Rucker, Rucker, and Gilley, P.C.- Attorney and Partner I began working for the firm as a clerk in 1995 and ultimately became a partner in 2002. The firm dates back to the 1860's and has handled all types of legal matters, but specialized over the last several decades in the areas of insurance, personal injury, workers' compensation, and medical malpractice defense. The current size of the firm is three lawyers and three support staff. The size and nature of practice areas result in considerable courtroom experience including jury trials, bench trials, motion hearings, appeals and mediations.

The Mediation Group- Mediator I became certified as a Rule 31 Mediator in 2007 and joined The Mediation Group the same year. The Mediation Group is a state wide mediation service provider and is one of the largest, if not the largest, such organization in the state. The Group handles mediations and arbitrations of all types, including personal injury, contract disputes, will contests, land disputes, fee disagreements, and governmental issues with a very high rate of success.

Middle Tennessee State University- Adjunct Professor teaching Insurance Law and Commercial Law I began teaching in the Spring of 2007. I teach Insurance Law each Spring, which is an upper-level elective. I teach Commercial Law each Fall which is a required upper-level course for Accounting Majors to prepare them for the legal portion of the CPA Exam.

Murfreesboro City Council- Councilperson I was first elected in 2000 and have been reelected in 2004, 2008, and 2012. The Council oversees the budget, services, and policy making of a city where the population has grown at an exponential rate over the last twelve years.

Murfreesboro Planning Commission (separate stipend) I have represented the City Council on the Planning Commission for over twelve years. During this time, numerous legal issues have arisen including litigation over annexation, zoning, and the city's sign ordinance. I have gained firsthand experience with complex municipal litigation.

Murfreesboro Water and Sewer Board (separate stipend) For approximately ten years, I was the City Council representative on the Water and Sewer Board. Given the unprecedented growth of the city during this time, I helped oversee multi-million dollar projects. Some of the legal issues presented to this board included land acquisition, financing of projects, and construction contract disputes.

Murfreesboro Electric Department Board (separate stipend) I became the City Council Representative on the Electric Department Board in 2012. As such, the experience I gained on the Water and Sewer Board will continue to expand as similar duties are required of me on this municipal utility board.

Since beginning practice in the Fall of 1997, I have handled approximately 1,500 legal matters. These cases include the representation of individuals, small businesses, corporations, and government entities. My experience includes civil matters such as plaintiff and defendant tort representation, insurance law, contractual matters, collection and subrogation matters, workers' compensation, medical malpractice, criminal cases, divorces, adoption, child support matters, name changes, and estate planning. Over the years, my practice has become more specialized in areas that focus heavily upon courtroom experience including jury and bench trials as well as complex motion hearings.

Our firm is a small one, yet a significant portion of our work comes from large clients such as State Farm, Nissan, National Healthcare Corporation, State Volunteer Mutual Insurance Company and Yates Services. These clients could utilize larger firms or even other small firms throughout the state. They, however, have entrusted our firm to represent them in the following counties as well as federal court: Rutherford, Putnam, Cumberland, Lincoln, Trousdale, Franklin, Coffee, Smith, Davidson, Lawrence, Warren, Moore, Bedford, White, Cannon, Fentress, Williamson, Wilson, Overton, Sumner, Montgomery, Macon, DeKalb, Marion, Hickman, and Shelby. I regularly appear in Circuit, Chancery, and General Sessions Courts.

This speaks volumes as to the confidence our clients place in us. Moreover, it illustrates that I am very familiar with trial and motion practices in multiple jurisdictions and venues.

My first jury trial occurred in my first full year of practice. I was lead counsel in a case involving a liability dispute in an automobile accident. I was successful in proving to the jury that a substantial portion of the fault should be attributed to the opposing party.

Since that time, I have been lead counsel in at least twelve to fifteen jury trials in numerous counties. Success for the defendant in a tort case is often measured in terms of low verdicts. In one case, with admitted liability, the plaintiff presented over \$30,000.00 in validated medical bills to the jury. She was awarded a total verdict of \$35,000.00.

In another case, again with liability admitted, the jury hung after two days. At the conclusion of the trial, I polled members of the jury and found that eleven jurors wanted to award nothing to the plaintiff and one juror wanted to award only the medical bills.

In yet another matter, my client's insurance carrier had advanced certain medical expenses on behalf of the plaintiff. By successfully arguing comparative fault issues and pointing out medical proof discrepancies, the jury came back with a verdict that would have allowed the insurance carrier to seek reimbursement of those medical expenses from the plaintiff, if it had chosen to do so.

Additionally, I have been very successful in attaining verdicts lower than Offers of Judgment, as instructed by my clients.

During my career, I have tried at least twenty-five workers' compensation bench trials in addition to other bench trials pertaining to a variety of other matters such as contractual disputes and domestic issues. I have also tried numerous matters in General Sessions Courts.

I have appeared before the Tennessee Supreme Court Workers' Compensation Appellate Panel on multiple occasions. As referenced below, my success in *Blake v. Nissan North America, Inc.* resulted in a change in the workers' compensation law by virtue of both the affirmation of the decision and by statutory change, in which I was involved.

I have served as a hearing officer in termination cases for the Rutherford County Board of Education. I currently serve as a hearing officer for the Tennessee Board of Professional Responsibility and have conducted a considerable number of mediations and arbitrations (see below) with an extremely high success rate.

9. Also separately describe any matters of special note in trial courts, appellate courts, and administrative bodies.

Blake v. Nissan North America, Inc., M2009-02173-WC-R3-WC, 2009. Appeared before the Tennessee Supreme Court Workers' Compensation Panel where I successfully argued that an economic based reduction in hours, employer wide, was not an exception to the 1.5 Workers' Compensation multiplier cap. During the appeals process, I assisted with the drafting of and passage of a statutory change codifying the same.

These changes helped reform Tennessee Workers' Compensation Laws. If the trial verdict stood, it would have placed employers in a very difficult predicament. When faced with economic downturns, an employer would have had to lay off employees who had never had a workers' compensation claim in order to continue to provide forty-hour work weeks for those employees who had sustained a workers' compensation injury in the preceding 400 weeks. This permits a reduction in hours while allowing an employer to keep **all** employees working and earning a paycheck.

Mediations and Arbitrations

Since becoming certified as a Rule 31 Mediator in 2007, I have conducted 35 mediations and arbitrations. I have a 90-95% success rate. These cases have involved personal injury, premises liability, domestic matters, will contests, contract disputes and attorney fee disputes.

While not every case that goes through mediation or arbitration may not produce legal

significance or involve substantial financial consequences, each case is significant to the participants. In one of the first mediations I ever conducted, the plaintiff shared something that I have never forgotten. He said that he had been through mediation, in the same case, unsuccessfully, with another mediator. Furthermore, he said that the difference between the two mediations being successful was my attitude and demeanor. This gentleman said that while both the prior mediator and I essentially said the same things, he appreciated my sincerity. I was very humbled by his comments. I always remember these words with each mediation I conduct.

During a domestic mediation involving custody and child support, which I conducted, the father was unrepresented. At first, he did not seem to want to resolve anything. I soon realized that no one had ever been willing to listen to him regarding his feelings; rather, they only talked to him about numbers and procedures. I took him aside and let him share with me how hurt he was and let him cry for almost an hour. Afterwards, we were able to reach a resolution.

While mediating a premises liability case involving a minor child, I was reminded that sometimes personal injury cases are not just about money. This case was worth a six figure settlement and the insurance carrier for the defense agreed. However, the parents of the child did not want to talk specifically about settlement. I discovered that the defendant, an amusement facility where the child's birthday party was being held, had demanded, at the scene of the accident, that payment for services be rendered while the parents were trying to get into the ambulance with their child. In addition to compensation, they simply wanted an apology. The case then settled.

The significance of these cases is to illustrate that mediators, as well as judges, should examine all of the circumstances and show compassion, along with being knowledgeable in the law.

Of the three branches of government, the judicial branch is the least recognized. Legislators enact laws and the Executive sets policy. However, it is the judges who interpret those laws and policies.

Those interpretations have tremendous impact on our lives. Until interpretations are made, laws and policies are words on paper; afterwards though, they take on life and meaning. I have a sincere and earnest desire to help make laws and policies a reality.

I was raised by working class parents. I was mentored by excellent lawyers (one a former judge). I have been a successful mediator and arbitrator for several years. For twelve years, I have served my fellow citizens in local government. These experiences have shaped me into the kind of individual who, as judge, would provide empathy and sympathy, practical justice not impractical theory, and unbiased resolutions not just finality to problems.

Since I have not been as active in terms of *pro bono* work as I would like to be, I contribute financially to legal aid. As president of our local bar, I promoted our local *pro bono* clinics as well as hosting a monthly radio call-in show which provided free legal advice. When my students at MTSU have legal issues and cannot afford an attorney, I provide assistance. One *pro bono* adoption client still calls every year on her child's birthday to thank me.

Additionally, pertaining to my commitment to equal justice under the law, during my tenure on the City Council and Planning Commission, I have participated in many public hearings. The testimony during these public hearings comes from corporate representatives with counsel and citizens with limited formal education. In my eyes, both groups are equal. On multiple occasions, I have met with residents in their homes, bringing the corporate representatives along so that compromise can be reached.

Our 16th Judicial District is comprised of four Circuit Court judges and one chancellor. This District covers Rutherford and Cannon Counties. These judges hear both civil and criminal cases.

The District bench includes well-rounded judges from diverse backgrounds. I, though, would bring a new perspective, due to background and experience, that would strengthen our judiciary.

I have deep family roots in both counties. I have extensive experience in insurance law and workers' compensation, as well as in general civil and criminal law. I am teaching law classes at the collegiate level.

During my time as an elected official, our county has experienced phenomenal growth. I have been blessed with the opportunity to help transform and mold our community as it deals with this expansive growth.

I would relate to those who come in to court from all aspects of life, make educated rulings and provide, when asked, insight to fellow judges in areas of the law in which I have experience.

I maintain active involvement in my community. I am active in Special Olympics, having served on the local board; active at North Boulevard Church of Christ; and, active at the school my children attend, Reeves-Rogers Discovery School. I served on the Main Street Board of Directors as well as the board for the Tennessee Rehabilitation Center—receiving recognition from the Governor for my service. For almost thirteen years, I have served on the Murfreesboro City Council. As an elected official, I feel it a duty and an honor to participate in community service. It has been said that the strength of a society is judged by how it treats its weakest members.

If appointed, I will continue to stay involved in community service. Oftentimes, the general public thinks of judges only when court appearances are required. When it comes to community service, judges do not differ from any other person. Compassionate justice is not limited to the courtroom.

In addition to my current involvement, I intend to help and participate in our school system to the best of my abilities. If children learn to understand our laws, they will become more productive members of society. I have young children and firsthand insight on this issue. Effective civics classes and related programs such as the Scales Project, will, I believe, prove that raising children who understand and respect our laws means fewer participants in our criminal justice system.

I am a first generation college graduate raised by a factory worker and a bank teller. One grandfather was a minister; the other worked in law enforcement. This upbringing has instilled in me the value of hard work and honesty and the ability to relate to people from all walks of life.

I have striven, my entire life, to achieve leadership roles in public service. In all but the first two years of my career as an attorney, I have served in elected public office. I maintain a leadership role in my political party.

At MTSU, while obtaining my bachelor's degree in English and attending graduate school in Criminal Justice, I was elected Student Government President, an honor that only one student can claim each year. I was appointed to the Board of Regents, only the second such appointment in MTSU's history.

I have been elected four times to the Murfreesboro City Council. In that role, our Mayor calls me "the great resolver" because of what he refers to as my talent for being able to help disputing sides reach compromise.

For three years, I have served as Treasurer for our local Republican Party. I was recently named Republican of the Year for my dedication to principles and resolving disputes on our executive committee.

In summary, I am a leader and a litigator with broad experience who believes that every problem has a solution and I have the ability to find it. However, I am also fully capable of making fair and just rulings when compromise is not reached.

No one is above the law, especially not those instilled with public trust to uphold, interpret, and enforce the law. If selected to serve as judge, I will take this oath very seriously and honor my promise regardless of my personal feelings.

In a jury trial, I represented a client who had gotten drunk and got behind the wheel of a car. This resulted in an accident with severe injuries to his passenger. I did not agree with, nor did I condone, this behavior. However, under the law, his passenger was at fault for knowingly riding with him. I lined up ten shot glasses before the jury and filled these glasses to represent what the plaintiff observed my client drink before climbing into his car. The jury placed substantial fault upon the plaintiff.

I was appointed by the court to represent an inmate in a parental rights termination matter. The man's past was checkered. He was a poor example of a father. Nonetheless, he had a right to representation to the best of my ability, which is what I provided.

Judges must have the utmost respect for the law, even when it is unpopular and is contrary to their personal beliefs. Personal beliefs and common sense, though, are assets which an exemplary judge should use when ruling. Few things in life are black and white and judges have the responsibility of navigating those shades of gray.
