Upon starting law school, I clerked during the summer of my first year at Leitner, Williams, Dooley & Napolitan, PLLC in Nashville along with Trail & Trail, in Murfreesboro, TN. I clerked for Blackburn & McCune, PLLC and Leitner, Williams, Dooley and Napolitan, PLLC during the summer of my second year of law school.

Beginning in Murfreesboro in 2004, I have engaged in a general law practice with a primary focus on civil law. Collections work 30%; Family Law 20%; Probate/Estate 10%; Contract 15%; Corporate/transactional 15%; Personal injury 5%; Criminal Law 5%.

Throughout my entire legal career, my practice has primarily focused on the litigation of my clients' cases. From 2002 until July 2004, I worked as an Associate with Leitner, Williams, Dooley & Napolitan, PLLC in Nashville. During that time, I represented insureds in a number of different areas of law, including workers' compensation, premises liability and personal injury. My responsibilities consisted of deposing parties and witnesses, preparing and arguing, case evaluation, and trials.

Upon beginning practice in Murfreesboro, I expanded my practice to handle a wider variety of cases which included civil and criminal matters. I assumed primary responsibility for all of my cases at that time. During the last eight years of practice, I have handled personal injury claims for injured clients. I have also represented numerous individuals and companies in and around Rutherford County on cases regarding the Uniform Residential Landlord and Tenant Act. I have also represented individuals with family law matters, including divorce, child support, child custody, dependency and neglect, adoption and matters involving the Department of Children's Services. I have represented clients in construction and other real property matters. The above-referenced areas of law have required both extensive oral and written discovery. Further, it has been necessary to prepare, file and argue motions in court on a routine basis.

I have represented clients relating to contract law issues. This has required the construction and interpretation of a variety of contracts. Finally, I have represented clients with regards to the formation and dissolution of corporate and business entities.

7. Also separately describe any matters of special note in trial courts, appellate courts, and administrative bodies.

I represented several defendants in the Chancery Court for Rutherford County regarding an easement and use of an abandoned road. The matter was tried over two days and following the close of plaintiffs' proof; the judge dismissed their case involuntarily based on defendants' motion. The plaintiffs appealed the matter to the Tennessee Court of Appeals. The Court subsequently remanded the case to the trial court for damages. As my clients did not have an opportunity to defend the case, I filed a Petition for Rehearing based on the Violation of Due Process. Upon filing the Petition, the Court withdrew its opinion and filed another opinion that remanded the case for a new trial. *Vaught v. Jakes*, 2009 WL 1470490 (Tenn. Ct. App. May 26, 2009).

On some the occasions I served as a substitute Judge, I handled the calling of the docket and handled matters basically involving collections and default judgments. On other occasions when I have served as a substitute Judge, I conducted trials and heard testimony of parties and witnesses in various kinds of civil matters. I do not recall all of the parties or circumstances in those cases. Finally, I have served as a substitute Judge for a preliminary hearing in a criminal case in the General Sessions Court. I do not recall the facts of the case or the docket number.

<u>ESSAYS/PERSONAL STATEMENTS</u>

33. What are your reasons for seeking this position? (150 words or less)

My father was a primary care physician. I learned from a very early age that the impact you can have on people's lives during a time of turmoil can leave a lasting impression. I learned that people do not care about how much you know until they know how much you care. With this philosophy, I began my law practice. I have had the opportunity to comfort clients in times of sorrow as well as rejoice in times of triumph. People avail themselves to the judicial system to resolve their grievances. I believe it is important for people to know that their judge will give them a fair day in court and listen to their story. I have tried to build my practice on those principles and would continue to do so as a judge.

34. State any achievements or activities in which you have been involved which demonstrate your commitment to equal justice under the law; include here a discussion of your pro bono service throughout your time as a licensed attorney. (150 words or less)

It is often difficult to explain to clients that "equal justice" does not always refer to whether you simply win. People need to understand that both parties are entitled to the same justice regardless of their background or their current station in life. Throughout my career, I have assisted a number of individuals who have had significant financial hardships. Further, I have been appointed as counsel for clients involving Department of Children's Services and juvenile delinquent matters.

35. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. *(150 words or less)*

I am applying for the Circuit Court vacancy in Part III of the 16th Judicial District (Rutherford and Cannon Counties). The District has four judges, who hear civil cases in both Circuit and Chancery, as well as criminal cases in Circuit Court. I understand that the position, recently vacated by the Honorable Don R. Ash, has primarily handled criminal cases, while also hearing civil matters. I would bring to the Court a strong work ethic, a genuine love for people, a deep passion for the legal profession and an abiding sense of justice.

36. Describe your participation in community services or organizations, and what community involvement you intend to have if you are appointed judge? *(250 words or less)*

My wife and I have been very involved in community service organizations in an attempt to better our community. I have been involved in numerous fundraisers to help support the youth of Rutherford County. Specifically, I have co-sponsored the annual fundraiser for Project Help, an Early Intervention Resource Agency, affiliated with both MTSU and Rutherford County. While remaining active in our community, I have maintained a full-time law practice, which typically includes obligations outside the eight to five work day. I believe that the position I seek would allow me to take on an even greater greater role in the community.

37. Describe life experiences, personal involvements, or talents that you have that you feel will be of assistance to the Commission in evaluating and understanding your candidacy for this judicial position. (250 words or less)

I have always believed that it is important to treat people with respect regardless of whether you agree or disagree with their position. Over the past ten (10) years, I have had the opportunity to deal with hundreds, if not thousands, of debtors on my collection practice. I have found that treating people with respect and dignity often results in an unexpected civility. As a result, I have been later retained by former defendants to represent them in future matters.

I believe it is important for a judge have an appropriate judicial temperament. Individuals, who may avail themselves to the judicial system one or two times in their lives, should expect to be treated with respect and receive a fair day in court. I believe I have such a temperament and demeanor, which I would bring to the bench.

38. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. Under our form of government, the judicial branch is required to uphold the law providing the law is Constitutional. The legislative branch is required to approve on the substance of the law. This is a very important distinction that should be honored by Judges. I have advised clients of the substance of the law and their likelihood of success in court based on the law. I have always believed it to be important to explain to clients that judges are required to follow the law even if they have a personal disagreement with the policy or substance behind the law.
