In 1992. I was employed as an associate attorney at Arnett, Draper & Hagood in Knoxville, Tennessee. I practiced civil litigation and trial work there until 1999. I moved to Baker, McReynolds. O'Kane, Townsend & Sheu and did the same until 2001. In 2001, I moved to Leitner, Williams, Dooley & Napolitan, PLLC as of counsel, working and training associates in civil litigation. I became a partner in 2004. Each time I moved before, I generally did so in order to give myself the opportunity to work on more complex litigation. I have also written a number of articles and have a regular column in *DICTA*, the Knoxville Bar Association Journal (generally 4 times per year).

I practice civil litigation, torts and contracts. I also practice employment law, products hability and personal injury. The following is an estimate of percentages of each area:

While employed at Arnett, Draper & Hagood, I worked closely with Foster D. Arnett, Sr. in defending local hospitals in medical malpractice actions as well us working extensively in the area of peer review. I helped Mr. Arnett with research and drafting various versions of peer review laws that were included in legislative amendments to the peer review statutes, importantly, the state recognition and coordination of the Health Care Quality Improvement Act of 1986 and its due process provisions. I also worked in the areas of insurance defense and personal injury. I wrote the appellee brief and helped in the case of *Cardin v. Campbell, 920* , *SW.2d* 222 (Tenn. Ct. App. 1995), perm. app. denied(Tenn. April 29, 1996)regarding the doctrine of judicial estoppel in Tennessee. I spent a great deal of time during the early years defending personal injury and medical/hospital malpractice actions.

By 1999, I had the opportunity to work with Baler, McReynolds n some different areas, including more contractual issues and declaratory judgment actions. I also continued to work in personal injury and products liability litigation. Many of the cases were more complicated. The attraction was also the fact that I was generally the lead attorney working on those cases and had the opportunity, not only for more client contact, but the opportunity to have the final say in how the litigation as conducted. It was a learning experience that continued with Leitner, Williams, Dooley & Napolitan, PLLC (hereinafter, "LWDN"). In late 2000, I agreed to move to LWDN. The office was primarily engaged in worker's compensation defense. The managing partner wanted me to help increase liability lawsuits and to mentor younger associates in training them to be able to perform jury trials. I found it a challenge. I also spent the first 8 years handling cases that came in "7 boxes at a time." Needless to say, I spent a lot of time in the library, in depositions and in the courtroom.

There have been a number of cases that I have had the opportunity to work on at the appellate level. Two of them stand out as particularly interesting. (Actually, there are some others, but 1 am sure "brevity is the soul of wif" here.). *Kilgore v. Carson Pirie Holdings, Inc., 205 Fed. Appx. 367. 2006 WL 3253490 (6th Cir 2006)/department store injury on an escalator)* was interesting due to the fact that I was able to explore and help firm up the *Daubert* expert "gate-kceping" doctrine somewhat. Essentially, the Court upbeld the lower court's exclusion of an expert on several key *Daubert* grounds. Moreover, although summary judgment was reversed at the 6th Circuit, the Court agreed with my analysis that Tennessee, if directly confronted with the question, *would not*, use a heightened common carrier analysis to a stationary escalator but it would use an ordinary negligence standard instead. That ruling, although not binding on Tennessee courts, is the only ruling on that question and hopefully would provide some help if Tennessee courts ever directly address the issue.

Lawson, et al v Edgewater Hotels, Inc., 167 S.W.3d 816 (Teen Ct. App. 2004), perm. app. denied (Tenn., May 2, 2005), a case I argued in front of the Eastern Section was notable for number of reasons, but for the sake brevity, is important to me personally because it was cited by the Tennessee Supreme Court as an example of how to obtain summary judgment (actually partial) in Hannan, et al. v. Alltel Publishing Co., 270 S.W.3d 1. fn.5 (Tenn. 2008).

I have had the opportunity to have a number of jury trials in the past, and argue numerous motions and summary judgment motions. A great deal of my practice has involved the study of the law and writing. I do not have lot of experience with administrative bodies in the employment law area. I have participated in a number of EEOC investigation and have written a number of position statements, al resulting in no follow up charges by either the EEOC or the THRC.

I believe that law is king, but I also believe judges are not kings and queens. Their duty is to service the law and honor it. They should guard zealously the processes by which duly constitutional laws are made. I want to do that very thing.

I have taken on a number of pro bono cases through the years. Most of the cases involve helping clients stay out of litigation if possible. Some of it involved dealing with used car dealers that tried to pass off "as is" language to under-educated buyers. While I am a staunch supporter of the right to contract, a contract implies that all parties understand certain basic facts and one party is not being defrauded. I generally have helped some persons with criminal matters in the early days. I admit I have been extremely busy in the last few years and a lot of pro bono activities have dropped off. I try to make up for it by charitable contributions, but I admit I should do more.

academic acumen suited to the task. In terms of impact to the Court, I would approach all cases with a fresh eye, and I would strive to always apply the law as opposed to my own notions.

I intend to continue participating in Hamilton Burnett Inns of Court.

I grew up in North Knoxville in a poor home. I had wonderful parents that have passed in recent years. I left home at 18 because I had two younger brothers. I worked through undergraduate and paid for my own law school. I started college at 24 and graduated law school at 32. I lived in leaky apartments and even in my car for a while. I have been so emotionally low and bereft at times I could barely feel anything. I have been on top of the world, especially the day my future wife told me she loved me. In other words, I am a regular person that gets up, works and tries not to give up. In the end, the only thing special about a Judge is the person under the robe. That is true of everything. I promise best efforts, which is what I have always tried to do.
