I began as an associate with Hunter, Smith & Davis immediately after taking the bar examination in 1982 and have been a lawyer with Hunter, Smith & Davis continuously since then. I became a partner with the firm in 1986 and served as Managing Partner of the Firm in 1995 and 1996.

7. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I am a civil trial attorney primarily defending physicians, hospitals and other health care providers who are sued for medical negligence. In addition to trial work, I respond to daily inquiries on a real-time basis to assist with decision making and the legal implications which arise involving patients, staff, visitors, and physicians. I also handle other civil litigation covering a wide range of business disputes. Approximately eighty percent (80%) of my time is spent on medical malpractice matters, fifteen percent (15%) of my time is spent dealing with other civil litigation, and five percent (5%) of my time is spent responding to inquiries from the hospital.

Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters. Over the past thirty (30) years, I have been privileged with the opportunity to practice before trial, appellate and regulatory authorities throughout East Tennessee and Southwest Virginia. During this time, I served as lead attorney in over one hundred (100) civil jury trials. I began my legal career handling personal injury cases, usually retained by an insurance company to defend its insureds, in automobile or premises liability disputes. Through these experiences, I developed a niche representing insurance companies in actions brought by individuals and companies whose property was damaged or destroyed by fire. However, in approximately 1994, the focus of my practice shifted to the defense of medical malpractice suits. While this is my primary practice area, I have also handled employment discrimination actions (on behalf of employers) and various business dispute cases ranging from misrepresentation and violation of the

Tennessee Consumer Protection Act relative to defective hardware and software, and litigation between *Forbes* 500 companies related to contractual disagreements. My trial experience has been extensive in both state and federal courts in Tennessee and Virginia. I have argued cases before the Tennessee Supreme Court, the Tennessee Court of Appeals and the United States Court of Appeals for the Sixth Circuit. I have appeared before several health related boards with the Department of Health, usually defending charges made by the department against health care professionals. I have handled all aspects of Alternative Dispute Resolution, including the arbitration of cases to a conclusion pursuant to the rules of the National Association of Arbitration. In addition, I have handled pro bono criminal matters involving misdemeanors or juvenile offenses.

9. Also separately describe any matters of special note in trial courts, appellate courts, and administrative bodies.

I served as local counsel in a significant patent case representing a glass manufacturer who alleged a patent infringement. At the request of the lead counsel, a patent specialty firm in Arlington, Virginia, I handled the damages aspect of the trial, handling the direct examination of our damages expert and cross-examining the defendant's damages expert. After the federal judge granted a directed verdict on the issue of liability, the only issue for the jury was damages. The jury returned a verdict that totaled \$43.7 million dollars in favor of our client. The sad rest of the story is that the United States Court of Appeals for the District of Columbia reversed the trial judge. The case was appealed four times.

I have tried several jury trials that were multiple weeks in duration, including a products liability case that involved a spinal injury resulting from diving into an above ground swimming pool, fire cases, medical malpractice cases, and a technology misrepresentation case.

A particularly rewarding plaintiff's case was for an eighteen (18) year old young man, son of a coal miner, who was being recruited by colleges for football prior to sustaining a severe leg injury in a trucking accident. A structured settlement that will provide lifetime financial resources for him was obtained.

I serve as a member of the Board of Law Examiners appointed by the Tennessee Supreme Court. The Board conducts Show Cause hearings in July and December each year which are related to

determining Character and Fitness and we sit in judgment of the applicants who appear before us. While these Show Cause hearings comprise the majority of my quasi-judicial experience. I have also volunteered a number of times as a substitute judge for the former General Sessions Court judge in Sullivan County who had chronic health issues, as did other local attorneys. The cases were usually collections cases, landlord-tenant disputes, other small claims disputes, and the handling of arraignments.

11. Describe generally any experience you have of serving in a fiduciary capacity such as guardian ad litem, conservator, or trustee other than as a lawyer representing clients.

I was appointed as guardian ad litem by the former juvenile court judge on a few occasions to protect the interests of juveniles who were the subject of a custody dispute. I have not served as a conservator or trustee.

12. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

Serving on the Board of Law Examiners has been a rewarding learning experience that demonstrates my commitment to serve the interests of justice and to work towards improving the legal profession in Tennessee. I began with the BLE as an assistant examiner with the responsibility of writing and grading one of the essay questions on the bar exam. I have served as a board member since the late 1990s.

This application is my only one for judgeship for a state judicial appointment. I was one of three lawyers nominated by then Senator Frist to President Bush for the federal district judgeship and I was interviewed by then United States Attorney General Gonzalez at the White House in 2003. Judge Ronnie Greer was appointed by President Bush, but I was honored to be considered for the position.

I am currently one of several defendants, including the other members of the Board of Law Examiners and members of the Tennessee Supreme Court in a federal court action brought by Robert Marlowe, who was denied a law license in Tennessee. The action was filed on June 26, 2012 and is pending in the United States District Court for the Middle District of Tennessee. The docket number is Civil Action No. 3:12-cv-00646. I was just served with the Complaint on October 5, 2012.

- 35. What are your reasons for seeking this position? (150 words or less)
 - 1. With excellent training and mentoring by members of my firm, I have achieved a successful legal practice and while I have had the opportunity to train and mentor younger lawyers, I welcome this opportunity for another professionally challenging experience.
 - 2. I believe that my "time" to make a difference is now. My mother died recently at a relatively young age, and her death has made me more cognizant that time to make a difference is short. My husband and I have raised three children whose educations are complete, thus financially we are ready for me to make a change.
 - 3. I believe I would be the kind of appellate judge that litigants want. My strong work ethic and my ability to relate with others, along with my commitment to the legal profession, are talents that will be useful in the role of an appellate judge.

36. State any achievements or activities in which you have been involved which demonstrate your commitment to equal justice under the law; include here a discussion of your probono service throughout your time as a licensed attorney. (150 words or less)

I have been active with numerous projects of the Tennessee Bar Association whose goal is to ensure equal justice under the law. I served on the TBA Task Force on Diversity to encourage increasing minorities in law school and the profession. Every year for the past 30 years I have provided legal service without fee to individuals who could not afford a lawyer. The types of cases have ranged from helping individuals who have minor criminal charges, to helping individuals who needed legal assistance with housing, immigration, protection from abusive spouses, and to seeking compensation for individuals with injuries. Hunter, Smith & Davis has implemented a plan to reward associates for their pro bono service and we provide them with opportunities to help individuals who cannot afford to hire a lawyer. Finally, I have provided legal advice to numerous not-for-profit organizations on a multitude of issues without charge for my services.

37. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am applying for the Eastern Section Court of Appeals that was vacated by the retirement of Judge Herschel Franks. The court hears only civil cases. I believe my selection will add a seasoned trial attorney to the court, with a strong knowledge base and a willingness to quickly learn the areas that have not been part of my practice for the past 30 years. I believe my selection will add another judge who will be impartial and apply the rules of law without regard to the identity of the litigants. Further, I believe my selection will add to the court an individual who has demonstrated a strong work ethic and a passion for adhering to the rules that govern our profession's conduct.

38. Describe your participation in community services or organizations, and what community involvement you intend to have if you are appointed judge? (250 words or less)

I was active in my children's school organizations, including the PTOs for 18 consecutive years. When our children were in college, we were active at the University of Tennessee and the University of the South. We were active in dance and swimming associations in which our children were involved. Additionally, I served in a leadership role at Girls, Inc. and was a charter member of the Committee of 100, a fundraising effort for Girls, Inc. I participated in the second class of Leadership Kingsport in 1987, and then served in a leadership role for SHOUT, the youth leadership program in 2007. I have also served in leadership roles with United Way of

Greater Kingsport.

My husband and I have been members of the same church since we moved to Kingsport 30 years ago. We have served in various leadership roles at church, serving as teachers and committee members and we have been supportive of the Interfaith Hospital program. I provided legal services, without fee, to the church in several situations.

If I am selected as the judge, then I believe I will have more time to give back to my community. My specific interests are working with underserved women and children.

39. Describe life experiences, personal involvements, or talents that you have that you feel will be of assistance to the Commission in evaluating and understanding your candidacy for this judicial position. (250 words or less)

Like many others of my generation, I was the first member of my family to graduate from college. My father passed away when I was a senior in high school. I benefited greatly from the location and opportunity provided by a community college in my hometown, Morristown. I did not have an appreciation for how successful I would and did become, both as a lawyer and as a member of the Bar. I feel a great sense of gratitude to my law firm for affording me good training and wonderful opportunities. Because I have been the recipient of many gifts, I have an obligation to return to my family, my school, my community, and my profession whatever I am capable. I am at that place in my professional career where I want to contribute more to my profession. I have had the privilege of hard work, and despite my modest start, I have achieved success in my legal career thus far.

While I take great pride in my career, my family has always been a priority. Being married to a husband with a charitable spirit has helped me stay grounded in what is important in life. With three young adult children, I have been humbled by their successes and challenges. I have empathy for others who have significant life events, but I believe my personal and professional experiences will help me make decisions that are based on the law and the facts of the case.

40. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I commit to uphold the law even if I disagree with the substance of the law. The Tennessee Supreme Court decided a case in 2006, *Calaway* that changed the statute of repose for children in medical malpractice cases in a meaningful way. Before *Calaway*, children had until age nineteen to file a lawsuit for personal injuries sustained during their years of minority. The Tennessee Medical Malpractice has a three-year statute of repose. The court in *Calaway* decided that the three-year statute of repose would apply to children in medical malpractice cases. After *Calaway*, there were a couple of actions that were filed on behalf of minors but beyond the three-year statute of repose. Because I represented the defendants in those cases, I was required to

assert the defense that the action was barred by the statute of repose, even though the result seemed unjust. The trial judges were reluctant to follow *Calaway*, and in one instance allowed the plaintiff to voluntarily dismiss the case. The lawsuit was then re-filed in federal court. Once again, I was required to assert the defense made available by the TMMA and *Calaway*, even though I disagreed with the substance of the law. If selected, I will uphold the law regardless of my personal disagreement with the law.
