County Attorney for Sullivan County, Tennessee. This is a county-wide elected position with a four (4) year term of office. I was originally elected in 1994 and most recently elected in 2010. I have held this position since 1994 having been elected in 1994, 1998, 2002, 2006, and 2010.

After graduating from law school in 1980 I returned to Kingsport, my home town, and started a private practice of law. I practiced civil law and criminal law in state and federal court. My practice included trial work, appellate work and the general practice of law. I often served as a substitute judge in Kingsport General Sessions Court and Juvenile Court, and I also served for a approximately a year and a half as the municipal judge for the city of Church Hill. I also worked temporarily on two occasions as a prosecutor for the Sullivan County District Attorney's Office. In 1994 I was elected as the County Attorney for Sullivan County. During my initial term of

1994-1998, the office of County Attorney was a part-time position and I was allowed to maintain my private practice of law. Beginning with the 1998 election, the position of County Attorney became a full-time position and I had to close my private practice. I have been the County Attorney for Sullivan County since 1994. As County Attorney for Sullivan County I handle all the legal needs of Sullivan County and Sullivan County officials. I provide a very wide range of legal advice and legal services, and I also defend Sullivan County and Sullivan County officials in all litigation. I also provide legal services, advice and representation to the Sullivan County School System. Sullivan County has a population of approximately 156,000 people. Sullivan County has about 850 full and part-time employees and the Sullivan County School System has about 1800 full and part-time employees.

6. If you have not been employed continuously since completion of your legal education, describe what you did during periods of unemployment in excess of six months.

7. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I am the elected County Attorney for Sullivan County and handle all the legal needs of Sullivan County and Sullivan County officials: I also provide legal advice and representation to the Sullivan County School Department. [On occasion, although rare, when necessitated by various reasons, such as conflicts, outside counsel will be retained to provide representation to Sullivan County and its officials in litigation. Also, the Sullivan County School Department has a separate attorney paid on an hourly basis to provide additional legal advice to the school system.] My position is considered a full-time position and I am forbidden by the private act that establishes the office of County Attorney from engaging in the private practice of law. I provide legal advice and representation in every area of law ranging from the Americans with Disabilities Act to landfills, from the county health department to the Sheriff's Department, from county roads to jail medical malpractice, from mold in county high schools to strip clubs. The largest part of my work is in litigation; I handle all the litigation filed by or on behalf of the county and its officials including workers compensation, civil rights, lawsuits by jail inmates, lawsuits against law enforcement officers, employment law, Title VII, EEOC complaints, unemployment claims, zoning, property law, subrogation, condemnation, and general tort/negligence claims. I also devote a lot of my time to providing legal advice to county officials on a wide range of matters which confront the county on a daily basis including contracts, leases, purchasing, budgeting, bonds, insurance, beer licenses, drug testing, real property, county roads, employment law, law enforcement, jails, Constitutional rights, planning and zoning, elections, conflicts of interest, Robert's Rules of Order, and legal issues concerning the operations of county government. I advise the county health department, Sheriff, Trustee, Property Assessor, Register of Deeds, Court Clerks, County Clerks, Highway Dept., Purchasing Dept., Finance Dept. and School Department as well as county department heads and county committees and boards.

Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters. I began my legal career in the private practice of law. While in the private practice of law, I practiced both civil and criminal law, but I handled a lot of criminal work. I have handled a

death penalty case from start to finish (fortunately the defendant did not receive the death penalty). I have handled several murder cases and other high level crimes such as rape, robbery, and burglary. I handled divorce, child custody, plaintiff's personal injury, car wrecks, bankruptcy, employment, and the whole range of a general practice of law and plaintiff's litigation work. During my private practice I worked in General Sessions and Juvenile Court, in trial courts and appellate courts, and I worked in state courts as well as federal courts. I tried cases to verdict before judges and juries. I tried a personal injury case before the Tennessee Claims Commission to verdict and successfully defended the verdict on appeal. After I became the County Attorney for Sullivan County, I ceased doing criminal, divorce, custody, and plaintiff's personal injury work; however, I began to do a lot of defense litigation work representing Sullivan County. I have now been the County Attorney for Sullivan County for 18 years. I handle all their litigation work as well as provide legal advice and representation to the county and county officials. I appear regularly in General Sessions, Circuit and Chancery Court; I handle appeals to the Court of Appeals and the Tennessee Supreme Court. I also appear in Federal Court and in the Sixth Circuit Court of Appeals. I handle any and all legal work and representation needed by Sullivan County, its officials and employees. I also provide legal advice and representation to the Sullivan County School Department (although the School Department does have another attorney under contract to provide some legal work). [See also my answer to question 7 above.]

9. Also separately describe any matters of special note in trial courts, appellate courts, and administrative bodies.

I have handled many serious criminal cases including death penalty cases through trial and appeal. I have handled many serious civil cases including wrongful death, medical malpractice, personal injury and workers compensation cases. I handled litigation from start thru the Appellate Courts concerning adult nudity (strip clubs) in Sullivan County. I tried a personal injury case before the Tennessee Claims Commission, received a fairly sizeable verdict for the Plaintiff, and successfully defended it on appeal. Although full trials, and particularly jury trials, are not as common as they used to be, I have handled many cases through trial including jury cases.

During my private practice of law, because I spent much time in General Sessions and Juvenile Court, I was often asked to sit as an acting judge during judges' absence. I also served as the City Judge for the city of Church Hill for about a year and a half which required me to be on the bench once or twice a week for a few hours each time. I was one of the first mediators approved by the Federal District Court in Greeneville; however, due to my holding a full-time elected position, I have not served as a mediator.

11. Describe generally any experience you have of serving in a fiduciary capacity such as guardian ad litem, conservator, or trustee other than as a lawyer representing clients.

Courts often need a guardian ad litem to represent minors, other incompetents or sometimes those that just need help. Because I regularly appeared in all the courts while in private practice, I was often appointed to serve as a guardian ad litem. This would most often involve minors or incompetents in juvenile court, in domestic relations, and in judicial commitments. I was appointed conservator of an elderly man once when the family had a history of litigation and the court needed a conservator to take over the elderly man's finances and to assist the court. I sorted thru the finances and litigation and successfully turned the estate over to a local bank. I often was asked by one Circuit Court Judge to represent individuals in commitment proceedings. I also served as a guardian ad litem for the deceased bodies in a forgotten graveyard which contained the bodies of casualties in the Civil War.

12. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

During the first few years of my career, I shared office space with a couple other lawyers; however, since those first few years, I have always been by myself. The importance of this is that I have had to rely upon my own abilities in each and every legal issue I have confronted over the years; I have not had the luxury of having a law firm of lawyers available to assist me. I am experienced and capable of addressing the full range of legal issues that will confront a member of the Court of Appeals. If the matter is new to me, I have 32 years of experience in researching new legal matters. During the first half of my legal career, I represented mostly plaintiffs and criminal defendants and operated a general practice of law; during the second half of my legal career, I have been on the defense side of litigation and have provided legal advice to government. I have a wide range of legal experience.

<u>ESSAYS/PERSONAL STATEMENTS</u>

35. What are your reasons for seeking this position? (150 words or less)

I have been practicing law for 32 years; I believe I can best serve myself and the people of Tennessee from this point forward as a judge. I believe I am qualified and can perform the job of

an appellate judge well. An attorney can only pursue justice and work towards its achievement; a judge can actually render justice, at least as the human ability allows. I believe I will be a good judge maintaining the integrity of the judicial system and improving it when possible. I am an analytical thinker and I am good at breaking down, distinguishing the different parts of legal issues and thereby understanding the law and its history, which is a talent I believe would be very valuable as an appellate court judge. I have broad life experiences which will enable me to relate to and understand people of all classes and backgrounds, their problems and life encounters. I feel few attorneys have the wide range of experience in the practice of law that I have. I have practiced law on my own for 32 years and have developed the ability to provide legal opinions relying solely upon my own abilities and efforts. I have lengthy experience as Plaintiff's counsel and as Defense counsel; I have lengthy experience representing individuals and I have lengthy experience representing government. I have lengthy experience representing the solo client and I have lengthy experience representing a large employer. I believe with such experiences, I can provide the people of Fennessee with valuable, competent and fair review of their legal problems and questions. I have always felt that providing the best and fairest justice possible according to our laws is the ultimately goal of our justice system and I want to - and I believe I can – keep us on track towards achieving that goal.

36. State any achievements or activities in which you have been involved which demonstrate your commitment to equal justice under the law; include here a discussion of your pro bono service throughout your time as a licensed attorney. (150 words or less)

While in the private practice of law, I did a large amount of court-appointed criminal work and juvenile work. Most of my work in these fields occurred before the Office of the Public Defender was created. I often say that before the Public Defender, I was the Public Defender. I and just a handful of other attorneys handled all the court-appointed work before the Office of Public Defender was created. During that time, I feel I preformed a tremendous amount of work for indigent clients at a severely reduced rate of pay. The rate of pay was, as I recall, \$20 per hour for out-of court-work and \$30 per hour for-in-court work with caps of \$500 and \$1000 per case which included from initial appearance thru jury trial; some juvenile court work was occasionally for zero pay and at most \$10 per hour often with a cap of \$50. I also had to handle the appeals for these court appointed cases, and the pay for appellate work was similar. Also, during my private practice I provided free legal advice to numerous non-profit organizations I was involved with, including for example, a local rescue squad, an environmental group working to protect a local lake, the local community chest, and my church. When I became the County Attorney for Sullivan County I was forbidden by the private act that created my office from providing legal services to anyone else. Also, my available time decreased when I became County Attorney and as my family grew. Although the amount of free legal advice I have provided has decreased over time, I have continued to provide free legal advice and assistance to my church, friends and non-profits when I can.

38. Describe your participation in community services or organizations, and what community involvement you intend to have if you are appointed judge? (250 words or less)

Prior to becoming County Attorney, I had a lengthy history of community involvement. After being elected as County Attorney I scaled back my community volunteer work in order to dedicate most of my time to my newly elected position as County Attorney, my private practice of law (which I maintained for four years after initially being elected County Attorney), and my young family. Although my first term of office as County Attorney was considered part-time, I worked full-time in order to handle the work; during that 1st term, I also had my private practice to worry about, although it suffered greatly. My position as County Attorney became full-time in 1998. I slowed down my community volunteer work and dedicated more of my time to my elected position and my family. Currently, my oldest is in her 4th and final year of medical school; my son is in his first year of law school, and my youngest is a senior in high school; keeping up with and supporting my children and their endeavors renders me currently unable to do much community volunteer work at the moment; although I am always willing to help when and where I can. Raising my children and helping them succeed and achieve in life takes a large portion of my time (not that I regret it at all).

However, I do have a lengthy history of community involvement. I served as Vice-President and President of the Kingsport Boys and Girls Club and served on its Board of Directors for 10 years. During my work with the Boys and Girls Club, I was inducted into the Boys and Girls Club of Greater Kingsport Hall of Fame, I received the "Man and Boy Award" on two different occasions and also received a state award for the successful opening of a satellite branch of the club in a rural area. I served as President of the Sullivan South Area Community Chest on two different occasions and served on its Board of Directors for 14 years. During that time I served for several years as the Chairman of the "Land Use Committee" which was successful in buying and developing approximately 15 acres of land as an athletic park in my neighborhood. I was a member of the Board of Directors of the Suzuki Talent Education of Appalachia, the Kingsport Jaycees, the Greater Kingsport YMCA, and the Downtown Kingsport Association. While involved with the local Jaycees, I chaired many projects including Special Olympics and a 10K. road race, and served as treasurer for the local city beauty pageant. I also received many awards while involved with the Jaycees including "Outstanding Young Men of American" in 1983 and 1984. I served on several occasions as both a coach and judge in the local high school Mock Trial Competitions sponsored by the Tennessee Bar Association. I also coached local youth sports in several sports off and on for over 20 years. I also served two three-year terms as an Elder of my church and taught Sunday School for approximately 15 years. In 1995, I was nominated for Volunteer Kingsport's "Volunteer of the Year" award, and in 1990 I was nominated for the J. C. Penny's "Golden Rule Award".

My youngest will graduate high school this Spring and be off to college. As a judge on the Tennessee Court of Appeals, I will make myself available to the public and serve my fellow man and society as best I can. I will perform the requirements of my job and also go beyond my job

requirements in public service.

39. Describe life experiences, personal involvements, or talents that you have that you feel will be of assistance to the Commission in evaluating and understanding your candidacy for this judicial position. (250 words or less)

I wanted to be an attorney from an early age. Merely being accepted into law school was a huge accomplishment and a high achievement for me. Being in law school, studying and talking about law and justice and the history of both was fascinating to me; my curiosity was with the idea of justice and the pursuit thereof; the concept itself was a goal. I have always tried to pursue my practice of law as a very precious thing, one to be protected with the pursuit of truth, honesty and integrity. I believe I have a reputation as an honest and trustworthy attorney, and having worked as a solo attorney for my whole career, I have learned to think on my own. I am an analytical thinker, which I believe would be an asset as a judge, and I have a career of providing legal services irrespective of negative feedback or public perception. I have a broad range of legal experience and volunteer work. I believe working as a judge gives me the best opportunity to pursue these goals.


40. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. As judge I will interpret and apply the law, not insert my own personal agenda. My career is full of examples of upholding the law in the face of conflicts. As a criminal law attorney representing obviously guilty clients, I had to protect their right to a fair trial, their right to remain silent and their presumption of innocence. This can be quite hard when the crimes are violent and repulsive and the victims and public seek justice against these individuals. Also, as County Attorney my work is continuously open to public scrutiny, and I am quite often called upon to advise on very volatile issues such as posting the Ten Commandments in the courthouse, prayer in government meetings, dealing with adult entertainment and alcohol, keeping public records available to the public, keeping meetings open and the public aware, protecting the freedom of the press, pointing out potential wrongdoing and wrong courses of action by public officials, and protecting the rights of citizens against government. I am often called upon to give legal advice when there are differing positions promoted by different groups competing for different outcomes. I believe I have always followed the law, even when it was not popular; I believe I have a reputation in my community for being honest and for following the law based upon my best opinion as to what the law is and not being unduly swayed by public reaction or potential for reaction.
