5% - Defense of individuals charged in criminal proceedings in the general sessions court and criminal courts;

10% - Representation of estates and conservatorship in probate court;

5% - Drafting of documents such as, will, trusts, contracts, deeds, pre-nuptial agreements and real estate closings.

Since 2001, I have been able to practice law and represent clients in numerous different courts. 1 have preformed services for clients in the General Sessions Court for Scott, Campbell, Morgan, Blount, Fentress, and Anderson Counties for criminal matters which necessitated some preliminary hearings and civil matters including estates, divorce, debt collection and debt

defense, detainer actions and suits to enforce judgments. I have handled cases in the Circuit Court for Knox, Cocke, Anderson, Campbell, Cumberland, Rhea, Scott, and Morgan Counties. These cases have included domestic relations, car accidents with personal injuries, other personal injuries, damages to real property, breach of contract, debt collection and defense of debt collection, and workers' compensation. I have appeared in the Chancery Courts for Scott, Campbell, Fentress, Claiborne, Anderson, Cumberland, Putman, Morgan, and McMinn Counties handling workers' compensation matters, contract disputes, domestic relations, boundary lines, easements, road ways, clouds on title, and debt collection. Many times I had the opportunity to conduct trails in the Circuit and Chancery Courts mentioned. I have also practiced in the Federal Court system in the Eastern District for the State of Tennessee and the Eastern District for the State of Pennsylvania. The cases involved discrimination, insurance dispute over a fire loss, and breach of contract coupled with debt collection.

I have also had the opportunity to appear in the appellate courts for the State of Tennessee. I have appeared in the Court of Appeals for the Eastern District of Tennessee, Supreme Court for the State of Tennessee Workers' Compensation Division, and the Supreme Court for the State of Tennessee.

Handling numerous workers' compensation matters I have appeared many times at the Department of Labor for the State of Tennessee for Benefit Review Conferences representing the injured employee seeking benefits under the Laws of the State of Tennessee. I have become familiar and comfortable with the department of labor structure and procedures. I feel I have gained a vast knowledge of the laws concerning workers' compensation while utilizing the benefit review process.

I have learned that preparation is the key to success. I have applied myself to represent my clients to the utmost within the bounds of the law. This has included researching the law until I was comfortable with quoting it properly to the Courts and having the authority to evidence the position, preparing clients to properly present the most credible evidence to Courts, fully investigating claims through deposition, interrogatories, requests for admission, requests for production of documents, and interpreting records. Practicing in so many areas has allowed me to develop knowledge about the subject matter which has been entrusted to the jurisdiction of the chancery courts.

I have dedicated myself to the career path I have chosen. Typically I am the first to arrive and the last to leave. Often just to make sure there is something I am not overlooking that may benefit my clients. With each of my clients I was focused on them and would perform the major work that was necessary to prepare the case for trial.

I have always been a proponent of helping others. Representation of injured employees has

become a leading interest in my life. The most significant I can recall is a relation of two cases. Trosper v. Armstrong Wood Products, 273 S.W. 3d 598 (Tenn. 2008) and Cloyd v. Hartco Flooring Co. 274 S.W. 3d 638 (Tenn. 2008), both dealt with pre-existing conditions which were aggravated and advanced by a work related incident. From day one I was lead attorney on the Cloyd matter. The Trosper case was handled by Charles B. Sexton. Upon the Trail on the Merits the Chancellor found that both individuals had incurred a work related injury and awarded benefits. The defendants appealed both cases. I researched, prepared briefs, and presented oral arguments in the Workers' Compensation Panel and ultimately before the Supreme Court for the State of Tennessee. The Trosper case was overturned by the Panel. The Supreme Court overturned the Panel and interpreted the workers' compensation statutes to include advancement and aggravation of a preexisting condition when the advancement and aggravation is causally related to the work preformed for the benefit of the employer. These two cases are significant developments in Tennessee Workers' Compensation Law.

I currently serve as trustee on three trusts. One trust is a scholarship trust for the purpose of post high school education, the other two are real estate trusts which manage real property for the benefit of many.

I have served as a guardian ad litem on occasion for the juvenile court and chancery court. I undertook the challenge to properly investigate the best interest of the children I was appointed to protect, even to the point of challenging the parents and the Department of Children's Services in one particular matter in order to find the most appropriate placement for the juvenile I was appointed to protect.

I have been appointed by the Circuit Court for Scott County, Tennessee, as a receiver to protect the assets of a defendant in a wrongful death action from destruction, concealment, and transfer by individuals related to the defendant. With this appointment I was charged with compiling an inventory, monitoring the assets, and preparing the assets for public sale. Once the Plaintiff has received a judgment in their favor, I will be charged with conducting the sale and collecting the funds for distribution to the Plaintiffs and the Court for all costs.

I have always sought to protect the interest of the party I was empowered to protect in my fiduciary role.

I have mentioned significant cases and representations of my legal experience. I have treated each client with the utmost respect and attempted to serve them as their attorney to the fullest extent under the law.

Since 2001, after passing the bar exam I have preformed my services in the assistance of others. In doing so I have developed a passion to see that everyone is treated equally under the Iaw. I have always respected the position of Judge or Chancellor since the beginning of my practice. I have had the great opportunity to try cases in the Courts of many Judges who felt equality under justice was important. I wish to continue the same foundations that have been laid before me as to allowing all individuals equality under the Laws of the State of Tennessee, just as the predecessor to this Chancellorship.

36. State any achievements or activities in which you have been involved which demonstrate your commitment to equal justice under the law; include here a discussion of your pro bono service throughout your time as a licensed attorney. (150 words or less)

Living in Scott County, Tennessee, affords licensed attorneys with ample opportunities to provide services to those in need. Some of my most prominent pro bono service has come at the protection of children and mentally challenged. On numerous account I have undertaken the

challenge of representing individuals I knew had no opportunity to pay fees yet needed representations in actions against the Tennessee Department of Children's Services. My strive was to protect rights of parents that were being deprived by the governmental entity. No one person or entity shall be entitled to superior position just because of status, economic standard, or to who they are connected.

37. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. *(150 words or less)*

I seek the Chancellorship for the Eighth Judicial District for the State of Tennessee, which includes Union, Claiborne, Campbell, Scott, and Fentress Counties. The district is extremely rural and economically challenged. The district currently has two well qualified Judges which travel the complete district hearing cases.

Being from the same rural area on a permanent nature, I understand the socio-economic standards that have developed. Having the ability to connect with the individuals within the district would allow me to be compassionate to their condition, apply the law, and help each explain to individuals why the law dictates the outcome. This has occurred from the previous Chancellor and I wish to continue his touch with the people of the district. The ability to appear as "one of them" (similar in identity to the parties) relates a degree of comfort for the parties involved in the litigation, where this litigation means everything.

38. Describe your participation in community services or organizations, and what community involvement you intend to have if you are appointed judge? *(250 words or less)*

I would continue all my community involvement which did not interfere with my ability to preside as the trier of fact and question my impartiality. I have applied my talents with Court Appointed Special Advocate (CASA) in fund raising, the Boys and Girls Club of Scott County as a youth basketball coach, as director of Big South Fork Youth League, as a baseball and Tee ball coach, assistant basketball coach for Oneida Middle School boys basketball, by helping the Oneida Lions Club with special projects (Schools in Scott County) by supporting, promoting, and participating a basketball game, active promotion in a "Stand in the Gap" march for uniting our community.

It would be my desire to continue active community involvement for the benefit of children. Reaching a child at an early age and being able to mentor and develop his or her life skills is crucial to a productive individual and benefit a productive society in the terms of crime, economics and social well being. I would continue assisting in any capacity possible which would benefit directly with the children of my county and the counties of the Eighth Judicial District.

As I currently serve as Youth Director at New Haven Baptist Church I would attempt to facilitate relationships with middle school and high school students. It is important to stay involved in

children's lives to assist them in their social development and their ability to adapt to conflict which arise in their lives.

39. Describe life experiences, personal involvements, or talents that you have that you feel will be of assistance to the Commission in evaluating and understanding your candidacy for this judicial position. *(250 words or less)*

As long as I can remember, the legal system has been part of my life. My great uncle was an attorney, my uncle was an attorney, my father is a former general sessions judge and is currently a practicing attorney. Through each of them I was challenged to see the entire picture concerning a legal matter before passing judgment. When a client presented his position I was instilled to be able to find the strengths of that position, as well as, open my eyes to see what the strengths of the opposing position may be. Studying both sides of an issue helped me understand which position was correct, understand the ruling from the Judge, and to counsel my client on how and why the ruling was correct.

I learned a lesson very early in the practice of law dealt with limiting personal involvement. I was retained in a dependant and neglect matter by the mother whose child was removed by a former step parent. The mother was of inability to pay, yet I continued representation through numerous hearings. I took many stands to protect her constitutional rights, just as many attorneys do, but upon each stand I would take each ruling more and more personal. Counseling from wiser attorneys, those previously mentioned, opened my eyes to the opposing side, removed my person interests from the matter, and helped me develop focus to utilize my client's strengths to achieve a positive result.

Lesson learned, and I know judges should have no personal involvement.

I will uphold the law even if I disagree with the substance of the law at issue.

It has to be hard to work in the Department of Children's Services and remove a child, but it is even harder when you file an emergency dependency and neglect petition for a grandparent against their own child for a grandchild, then know that upon the thirty day hearing that the parents cleaned up enough that it looks good on paper to return the child to them. Even when facts discontinue to support the position for dependency and neglect, sometimes it does not feel right to send a child back to the parents.

This has happened on more than one occasion. I have been on both sides of the issue as well. It is heartbreaking to know that the law does not support the removal any longer, when things in your gut just do not feel right. I have a job to do once hired. I cannot create facts or

misrepresent the conditions concerning the child. Sometimes, the law does not capture the grey area. The only solace I can find in the decision, is that I preformed my work to the best of my capabilities under the circumstances, and if in my mind it was not correct to return the child to my client I support the law and reason that I preformed as required by my oath.
