**ORDER**

Upon consideration of the application for permission to appeal of Wendy Alford Holdsworth and the record before us, the application is granted for the limited purpose of vacating the judgment of the Court of Appeals with respect to the issue of attorney's fees. In light of its remand to the trial court for a determination of the income of each party, child support, and the amount and duration of transitional alimony, the Court of Appeals also should have remanded the issue of attorney's fees. On remand, the trial court shall first determine the income of each party, child support, and the amount and duration of transitional alimony, and then make a determination as to attorney's fees.
