Upon consideration of the application for permission to appeal of the State of Tennessee and the record before us, the application is granted. In addition to the issues raised in the State's application for permission to appeal, the Court is interested in briefing and argument of the question whether the good faith exception adopted in *State v. Lemaricus Devall Davidson*, No. E2013-00394-SC-DDT-DD, 2016 WL 7339116 (Tenn. Dec. 19, 2016), should be expanded to include technical violations in the service of the search warrant when the search in question is otherwise constitutional. In addition, the parties should address the question whether the Exclusionary Rule Reform Act, Tenn. Code Ann. § 40-6-108, violates the Separation of Powers Clause in Article II of the Tennessee Constitution and is therefore unconstitutional.


