**ORDER**

Upon consideration of the application for permission to appeal of Christopher M. Black, and the record before us, the application is summarily granted for the purpose of vacating the judgment of the Court of Criminal Appeals and remanding the case to the trial court for entry of a corrected order denying the petition for post-conviction relief. The order entered by the trial court does not address the issues raised in the post-conviction petition nor does it accurately reflect what occurred at the evidentiary hearing in this matter. Within sixty days of the filing of this order, the trial court clerk shall transmit to the Court of Criminal Appeals as a supplemental record an amended order denying the petition for post-conviction relief. Upon the filing of the amended order, the Court of Criminal Appeals may order additional briefing, if appropriate, and thereafter shall reconsider the case.
