ORDER

Upon consideration of the application for permission to appeal of Corrin Kathleen Reynolds and the record before us, the application is granted.

In addition to the other issues raised in Ms. Reynolds' application for permission to appeal, the Court is particularly interested in briefing and argument on the following questions: (1) whether the Court should adopt a good-faith exception to the exclusionary rule, *see United States v. Leon*, 468 U.S. 897 (1984); and (2) if so, whether the good-faith exception would preclude application of the exclusionary rule in this case.

The Clerk is directed to place this matter on the docket for oral argument upon the completion of briefing.
