Statewide Appellate and Trial Court Statistics

This section is the statistical portion of the Annual Report of the Tennessee Judiciary for fiscal year 2001-02. Included in this report is information gathered from the offices of the Appellate Court Clerk in Nashville, Knoxville and Jackson and the state clerks of court of Tennessee. The collection of this information is mandated by the Tennessee General Assembly and is used primarily as a tool to measure the effectiveness of the court system in Tennessee. The report is divided into three major sections: appellate (Supreme, Court of Appeals and Court of Criminal Appeals) caseload data; state trial court (chancery, circuit and criminal) filings and dispositions data; and jury and non-jury damages and torts data. The state trial court information is being reported by judicial district. No

statistical data will reported for Shelby County Criminal Court for this fiscal year. That office is unable to report caseload information that conforms to Tenn. Code Ann. § 16-1-117 and Supreme Court Rule 11 due to problems with the case management system in use in the criminal court clerk's office. A new caseload management system should be implemented by October 2003, and they will be able to report previously unsubmitted data. All information disseminated in this report has been distributed to and verified by the judges and the clerks of court of their respective judicial districts. 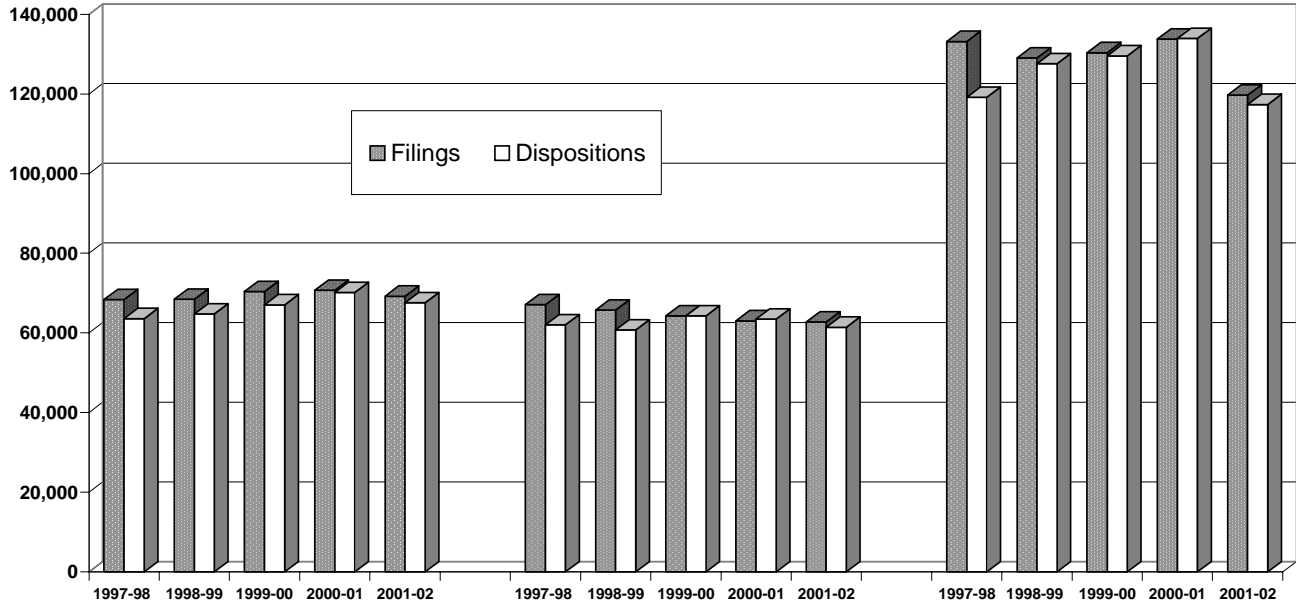

Damages and Torts Cases

Fiscal Year 2001-02

Effective July 1, 1989, Tennessee Code Annotated, §16-21-111, requires the clerk of each Circuit Court and the clerk and master of each Chancery Court to report the following information on a monthly basis: the number of cases filed claiming monetary damages for personal injury or death, and the number of such cases actually proceeding to trial. For those cases proceeding to trial, clerks must also report:

- the number of cases in which the plaintiff was awarded monetary damages for personal injury or death;
- the amount of judgment in a jury case;
- the amount of judgment in a case without a jury;
- any additur or remittitur awarded in the case by the trial judge.

The staff of the Administrative Office of the Courts (AOC) must compile this information and report the findings of the previous fiscal year to the chairpersons of the Senate and House Judiciary Committees and to the Attorney General.

Pursuant to this code section, the AOC, acting as staff for the Judicial Council, prepared this report. In fiscal year 1995-96, it was decided that this report would be incorporated into the *Annual Report of the Judiciary*, so that statistical information on the court system could be easily located.

The clerk of each Circuit Court and clerk and master of each Chancery Court send monthly reports on all case filings and dispositions to the AOC. Case filings are classified by case type categories, one of which is damages and torts. The damage and torts category consists of personal injury and wrongful death cases only. Property damage cases are reported under the

Miscellaneous General Civil category. Dispositions are classified according to the manner in which the case is disposed. For the purpose of this report, the disposition categories used were jury and non-jury trials. Also reported is whether or not monetary damages were awarded, and the amount awarded, if any, and the amount of any additurs and remittiturs to the original awards. This data is contained on the Tennessee Judicial Information System (TJIS) database.

Information gathered from the TJIS database provides the basis for the analyses included in this report. The following charts and graphs include cases that meet the following criteria:

- the case involved a claim for monetary damages for personal injury or death;
- the case was disposed of during the July 1, 2001 – June 30, 2002, time period;
- the case went to trial;
- the case was not settled or dismissed.

Prior to the publication of this report the AOC staff mailed preliminary data sheets to each Circuit Court clerk and to each clerk and master. Each was asked to review the sheets for accuracy and considering the reporting criteria described above, to submit corrections, if necessary. Copies of the data sheets also were sent to each judge in their respective districts.

Overall, for fiscal year 2001-02, data reported as to damages and torts cases showed slight decreases in the number of filings and dispositions reported over last fiscal year. There were 12,166 filings and 12,150 dispositions for fiscal year 2001-02. Damages and torts cases represented over 9 percent of civil filings and dispositions for the fiscal year. Of the 12,150 damages and

torts cases disposed of during the year, 717 (almost 6 percent) proceeded to trial. Jury trials accounted for 412 cases (57 percent) and non-jury trials for 305 cases (43 percent) of the cases that proceeded to trial. There was a significant decrease in the number of cases going to trial over those reported last year. The four metropolitan areas (Davidson, Hamilton, Knox and Shelby Counties) had 325 damages and torts cases (45 percent) going to trial. The four metropolitan counties accounted for 39 percent of all civil filings and dispositions for the year. The chart on page 152 has a comparison breakdown of damages and torts cases disposed of and cases going to trial from fiscal years 1990-91 through 2001-02.

Of the 717 cases going to trial in fiscal year 2001-02, 382 were awarded damages. The statewide total for damages awarded is 117,028,790, which is over \$22 million more than the previous year. The large increase in damages awarded can be attributed to the number of cases where significantly large damage awards were reported.

The four metropolitan areas reported \$99,247,120 in damages awarded, which is double the amount reported for the last fiscal year. The four metropolitan areas' total damages awarded represents 85 percent of all damages awarded. The chart on page 153 shows total monetary damages for fiscal years 1990-91 through 2001-02.

The average award for fiscal year 2001-02 was \$306,358. This represents an increase of \$97,074 from the previous year. The average award for three of the four metropolitan areas was up from last year. Hamilton County, however, showed a decrease. The chart on page 153 gives the average monetary award for fiscal years 1990-91 through 2001-02.

Knox County had the largest award for fiscal year 2001-02 with \$44,000,000. There were 23 awards of \$500,000 or more for a total of \$102,020,487. This represents 87 percent of all damages awarded. Fifteen of the 23 cases were for \$1 million or more for a total of \$97,212,010. A brief synopsis of the case with the largest award follows.

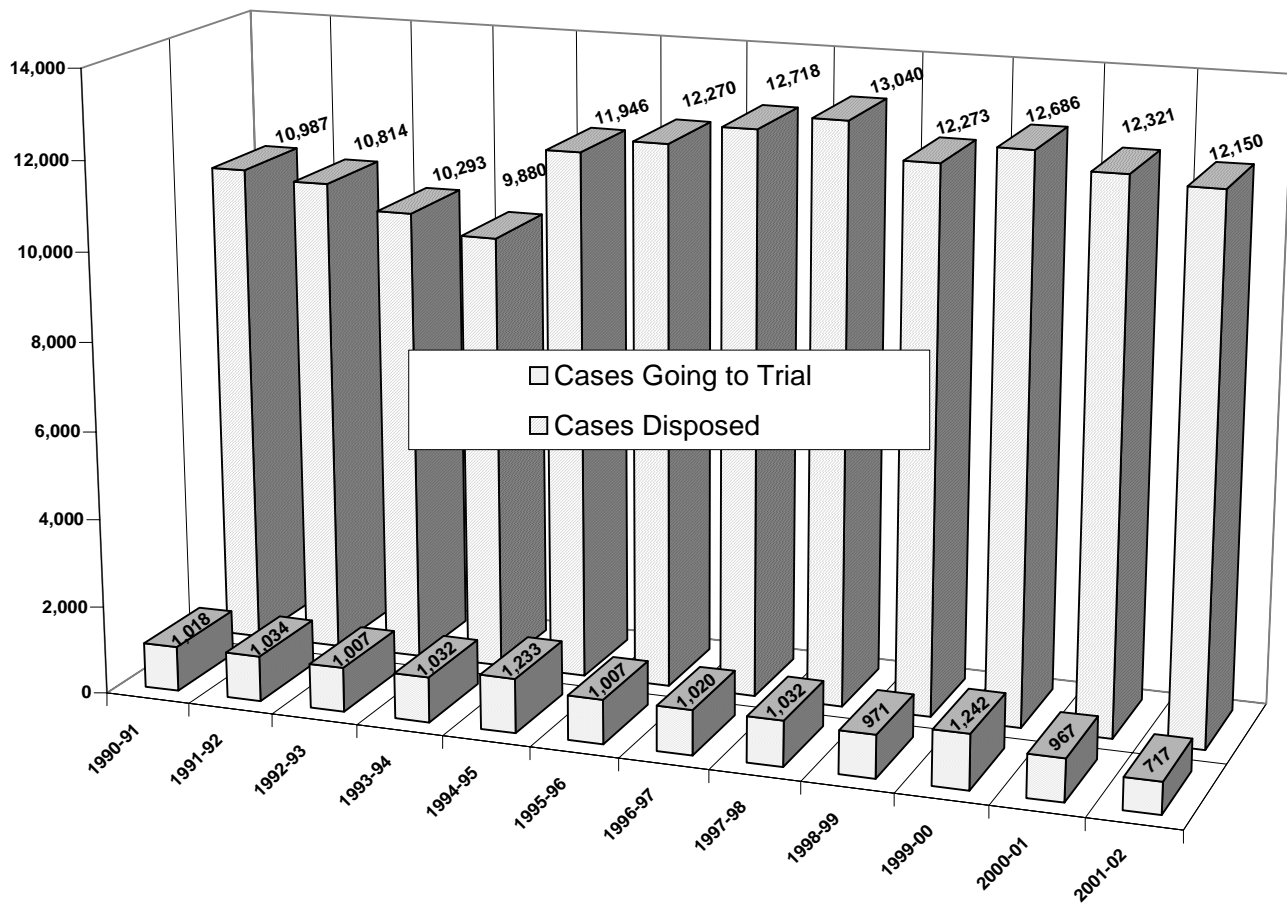
Largest Award

The largest award for fiscal year 2001-02, \$44,000,000, was a personal injury suit filed in Knox County Circuit Court on August 31, 2000. The following information was obtained from the Knox County Circuit Court Clerk's Office. The plaintiffs, Ashley Nicole Manes and Joseph Manes (legal guardian and individually), filed a complaint stating that on November 10, 1999, Ashley Manes was riding as a passenger on the right side of the middle bench seat in a 1999 Dodge Caravan which was proceeding in a northerly direction on Heiskell Road in Knox County, Tennessee. As the Manes vehicle approached the Washington Place Condominiums on Heiskell Road, Renee Johnson, who was traveling south on Heiskell Road, lost control of her 1987 Ford Escort, allowing the vehicle to cross the center line and collide with the Manes vehicle. As a result of the collision, plaintiff Ashley Manes, who was wearing her seat belt, was thrown in and about the interior portions of the vehicle, causing severe personal injuries. At the time of accident, defendant Phyllis Johnson was the owner of the vehicle her daughter Renee Johnson was operating, and such vehicle was being used within the scope of the family purpose doctrine. The plaintiffs allege the defendant Phyllis Johnson is vicariously liable for the injuries sustained by the plaintiffs as a result of Renee Johnson's negligence in causing the accident. The plaintiffs also allege that co-defendant, Daimler-Chrysler, designed, manufactured, assembled and sold a vehicle, including its occupant protection system, that was defective and not crashworthy. Plaintiff also alleges that defendant, Daimler-Chrysler, knew that said vehicle and its occupant protection system was inadequate to protect Ashley Manes from the risk of enhanced injuries as a result of being in a foreseeable crash. Plaintiff further alleges that defendant had actual knowledge that their vehicles would be involved in frontal crashes and failed to take adequate steps to eliminate or reduce the hazards of enhanced injuries. As a result of the accident, Ashley Manes suffered a skull fracture and a severe spinal cord injury, causing complete quadriplegia. Plaintiffs allege that Ashley Manes is permanently disabled as a result of the accident and is confined to a wheelchair, and has incurred and will continue to incur medical and related life care expenses in connection with her injuries. Plaintiff Joseph Manes, as father of Ashley Nicole Manes, brought suit for reimbursement of medical expenses incurred for the care of his daughter and for future expenses which will continue to incur, and as legal guardian, he sues for the injuries and damages sustained by her. A jury trial was held September 10 - 20, 2001. After due deliberation, the jury found that Renee Johnson was legally at fault and that Daimler-Chrysler was not at fault with respect to the injuries suffered by Ashley Nicole Manes. The jury assessed total damages in the amount of forty-four million dollars (\$44,000,000.00) for plaintiffs, Ashley Nicole Manes and Joseph Manes to be recovered from defendant Phyllis Johnson, individually and as representative of the estate of Renee Johnson. (Manes v. Daimler Chrysler Corporation, docket number 253700).

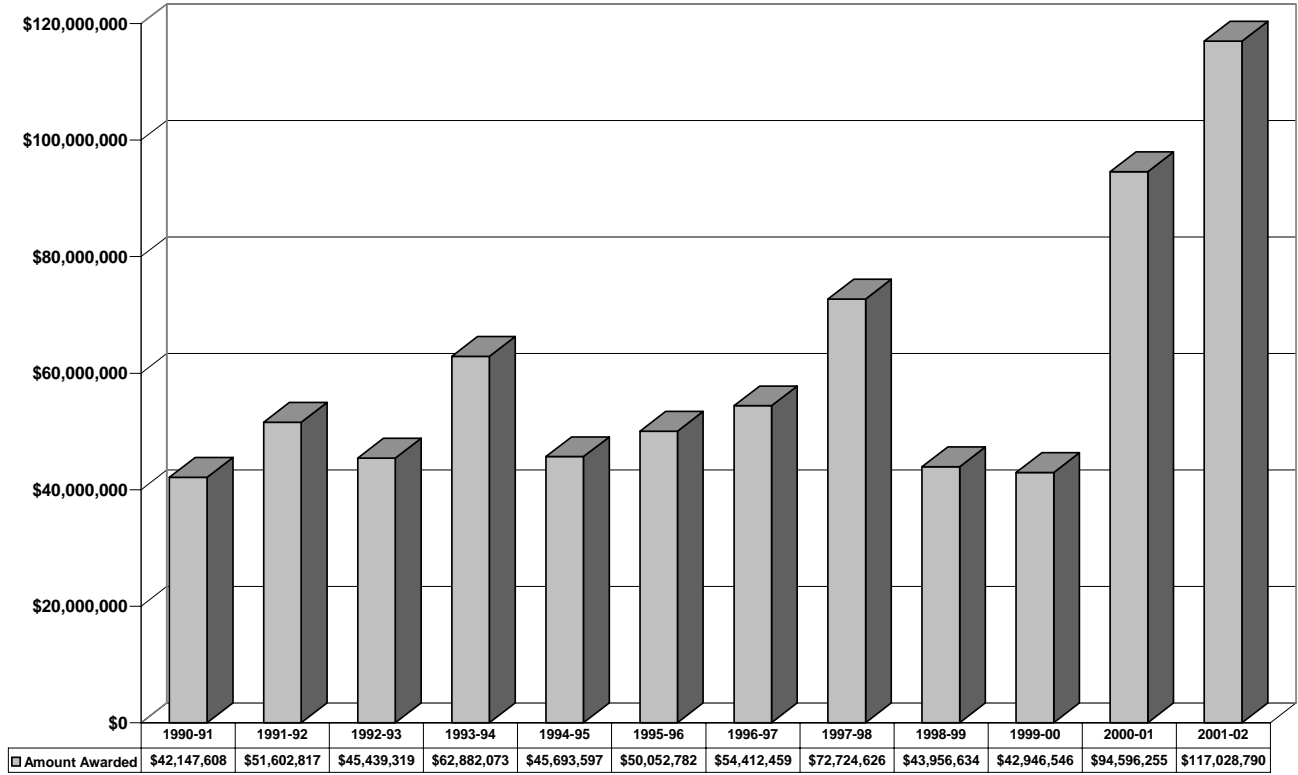

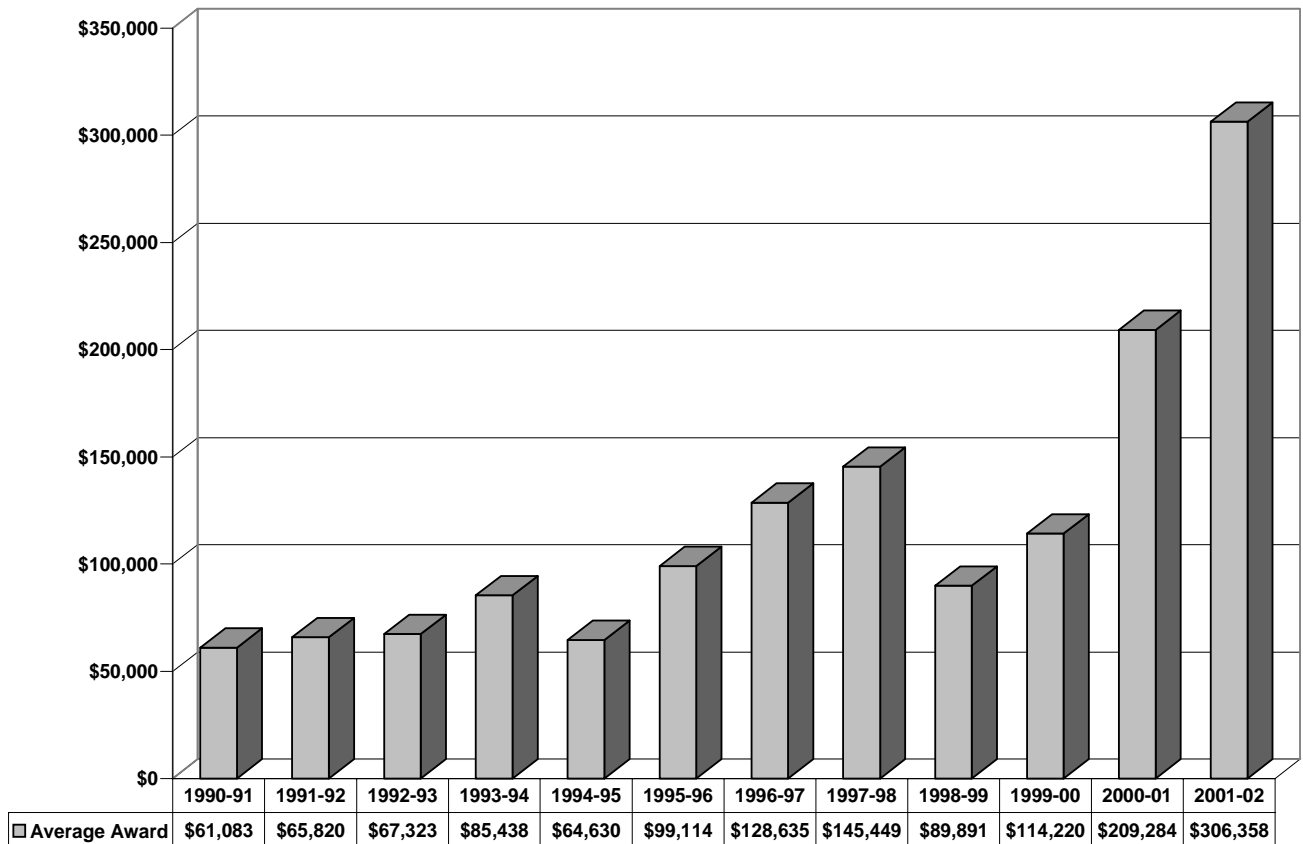
Damages and Torts Cases Disposed Statewide Fiscal Years 1990-91 Through 2001-02
