Statewide Appellate and Trial Court Statistics

This publication is the statistical portion of the *Annual Report of the Tennessee Judiciary* for fiscal year 2004-05. Included in this report is information gathered from the offices of the Appellate Court Clerk in Nashville, Knoxville and Jackson and the state clerks of court in Tennessee. The collection of this information is mandated by the Tennessee General Assembly and is used primarily as a tool to measure the effectiveness of the court system in Tennessee. The report is divided into three major sections: appellate (Supreme Court, Court of Appeals and Court of Criminal

Appeals) caseload data; state trial court (chancery, circuit and criminal) filings and dispositions data; and jury and non-jury damages and torts data. The state trial court information is being reported by judicial district. All information disseminated in this report has been distributed to and verified by the judges and clerks of court of their respective judicial districts. 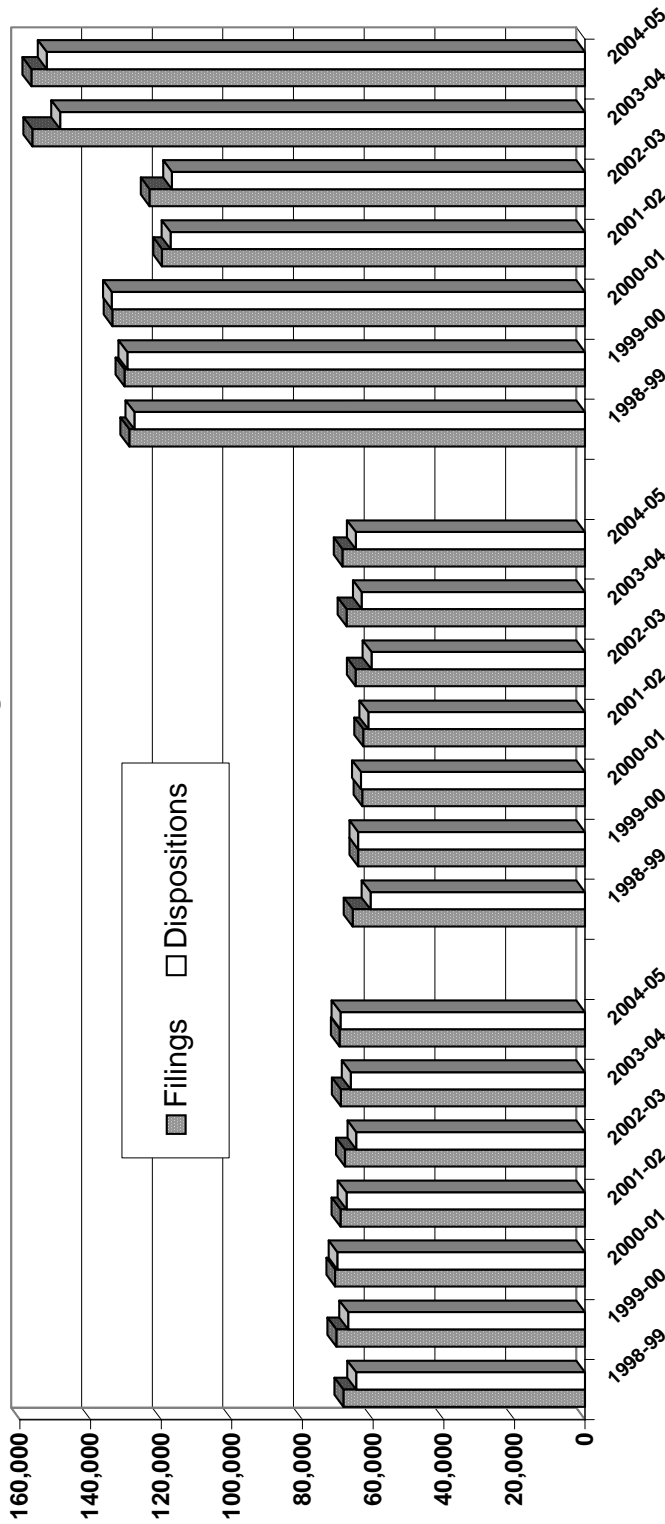

Damages and Torts Cases

Fiscal Year 2004-05

Effective July 1, 1989, Tennessee Code Annotated §16-21-111 requires the clerk of each Circuit and Chancery Court to report to the Tennessee Judicial Council the following information on a monthly basis: the number of cases filed claiming monetary damages for personal injury or death, and the number of such cases actually proceeding to trial. For those cases proceeding to trial, clerks must also report:

- the number of cases in which the plaintiff was awarded monetary damages for personal injury or death;
- the amount of judgment in a jury case;
- the amount of judgment in a case without a jury; and
- any additur or remittitur awarded in the case by the trial judge.

The staff of the Administrative Office of the Courts (AOC) must compile this information and report the findings of the previous fiscal year to the chairpersons of the Senate and House Judiciary Committees and to the Attorney General.

Pursuant to this code section, the AOC, acting as staff for the Judicial Council, prepared this report. Beginning in fiscal year 1995-96, this report was incorporated into the *Annual Report of the Judiciary* so that statistical information on the court system could be easily located.

The clerk of each Circuit and Chancery Court must send monthly reports on all case filings and dispositions to the AOC. Case filings are classified by case type categories, one of which is damages and torts. The damages and torts category consists of personal injury and wrongful death cases only. Property damage cases are reported under the Miscellaneous General Civil category. Dispositions are

classified according to the manner in which the case is disposed. For the purpose of this report, the disposition categories used were jury and non-jury trials. Also reported are whether or not monetary damages were awarded, the amount awarded, if any, and the amount of any additurs and remittiturs to the original awards. This data is contained on the Tennessee Judicial Information System (TJIS) database.

Information gathered from the TJIS database provides the basis for the analyses included in this report. The following charts and graphs include cases that meet the following criteria:

- the case involved a claim for monetary damages for personal injury or death;
- the case was disposed of during the July 1, 2004 – June 30, 2005, time period;
- the case went to trial; and
- the case was not settled or dismissed.

Prior to the publication of this report the AOC staff mailed preliminary data sheets to each Circuit and Chancery Court clerk. Each was asked to review the information for accuracy - specifically taking into consideration the criteria described above - and to submit corrections if necessary. Copies of the data sheets also were sent to each judge in their respective districts.

Beginning with fiscal year 2004-05, the AOC assigned a reporting category for medical malpractice cases, allowing these cases to be separated from the damages and torts reporting category. For reporting purposes for the *Annual Report of the Judiciary*, these cases are included in the damages and torts reporting category. For fiscal year 2004-05, there were 715 medical malpractice cases filed and 168 cases disposed under the medical malpractice

reporting category. Three of the 168 cases disposed proceeded to trial. There were no monetary damages reported for these three cases.

Overall, for fiscal year 2004-05, data reported as to damages and torts cases showed a small decrease in the number of filings and a very slight increase in the number of dispositions reported over last fiscal year. There were 12,743 filings and 12,530 dispositions for fiscal year 2004-05. Damages and torts cases represented 9.28 percent of civil filings and dispositions for the fiscal year. Of the 12,530 damages and torts cases disposed during the year, 622 (slightly less than 5 percent) proceeded to trial. Jury trials accounted for 324 (52 percent) and non-jury trials for 298 cases (48 percent) of the cases that proceeded to trial. There was a very small decrease in the number of cases going to trial over those reported last year. The four metropolitan areas (Davidson, Hamilton, Knox and Shelby Counties) had 266 damages and torts cases going to trial, representing 43 percent of damages and torts cases going to trial. The four metropolitan counties accounted for 37 percent of all civil filings and dispositions for the year. The chart on page 119 has a comparison breakdown of damages and torts cases disposed of and cases going to trial from fiscal years 1995-96 through 2004-05.

Of the 622 cases going to trial in fiscal year 2004-05, 252 were awarded damages. The statewide total for damages awarded is \$41,947,523, which is an increase of \$916,567 reported for the previous fiscal year.

The four metropolitan areas reported \$17,473,208 in damages awarded for this fiscal year, which is \$209,001 less than was reported for these areas last year. The four metropolitan areas' total damages awarded represent 42 percent of all damages awarded. The chart on page 120 shows total monetary damages for fiscal years 1995-96 through 2004-05.

The average award for fiscal year 2004-05 was \$166,458. This represents an increase of \$25,941 from the previous year. The chart on page 120 gives the average monetary award for fiscal years 1995-96 through 2004-05.

Cumberland County had the largest award for fiscal year 2004-05 at \$7,000,000. There were 12 awards of \$500,000 or more for a total of \$30,249,329. This represents 72 percent of all damages awarded. Nine of the 12 cases were for \$1 million or more for a total of \$28,249,329. A brief synopsis of the case with the largest award follows.

Largest Award

The largest award for fiscal year 2004-05, \$7,000,000, was a personal injury suit filed in Cumberland County Circuit Court on September 23, 2003. The following information was obtained from the Cumberland County Circuit Court Clerk's Office. The plaintiffs, Betty and Martin Potter, filed a complaint against Ford Motor Company and Morgan Ford, Inc. stating that on September 26, 2002, the plaintiff was operating her 1997 Ford Escort in a southerly direction on Highway 298 in Cumberland County. While rounding a curve, the vehicle slid off the road, impacted a state sign post, rotated approximately 180 degrees, and the rear end of the vehicle collided with a tree. The seat in which the plaintiff was sitting collapsed, allowing her to be ejected backwards into the back seat of her vehicle. As a result of the crash, the plaintiff suffered a broken spine and spinal cord injuries that caused her to be permanently paralyzed below the chest.

The plaintiff made several allegations against the defendant, including, but not limited to, the following:

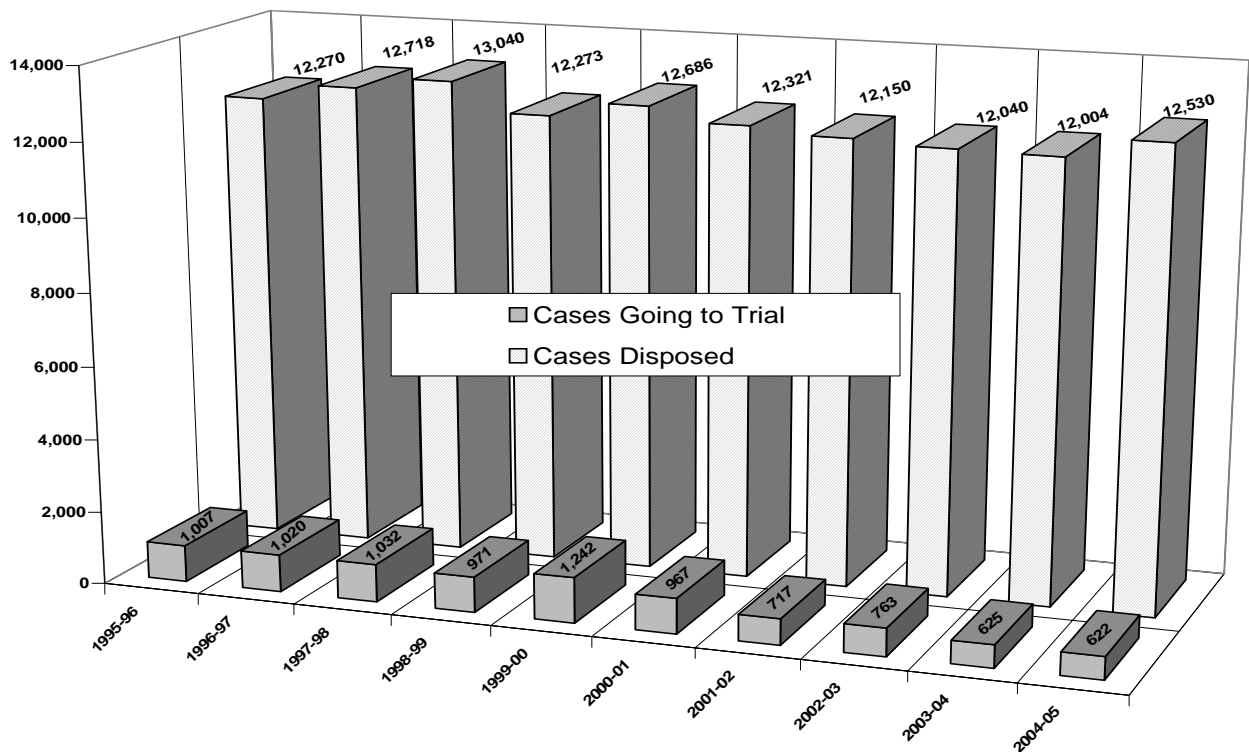
- the seat was designed and manufactured of inadequate strength to prevent its collapse in a foreseeable collision;
- the seat failed to restrain its occupant in a foreseeable rear-end collision; and
- no warning was given of the inadequacy of the seat to protect its occupant in the event of a foreseeable rear-end collision.

On February 11, 2005, the jury found the defendant 70% at fault and the plaintiff 30% at fault. The jury awarded total damages to the plaintiff, Betty Potter, in the amount of \$10,000,000. The plaintiff, Martin Potter, was awarded zero dollars. In response to the findings of the jury, the Court reduced the damages recoverable by the plaintiff to \$7,000,000 in light of her percentage of fault. (Betty Potter and Martin Potter v. Ford Motor Company and Morgan County Ford, Inc., docket number CV003993).

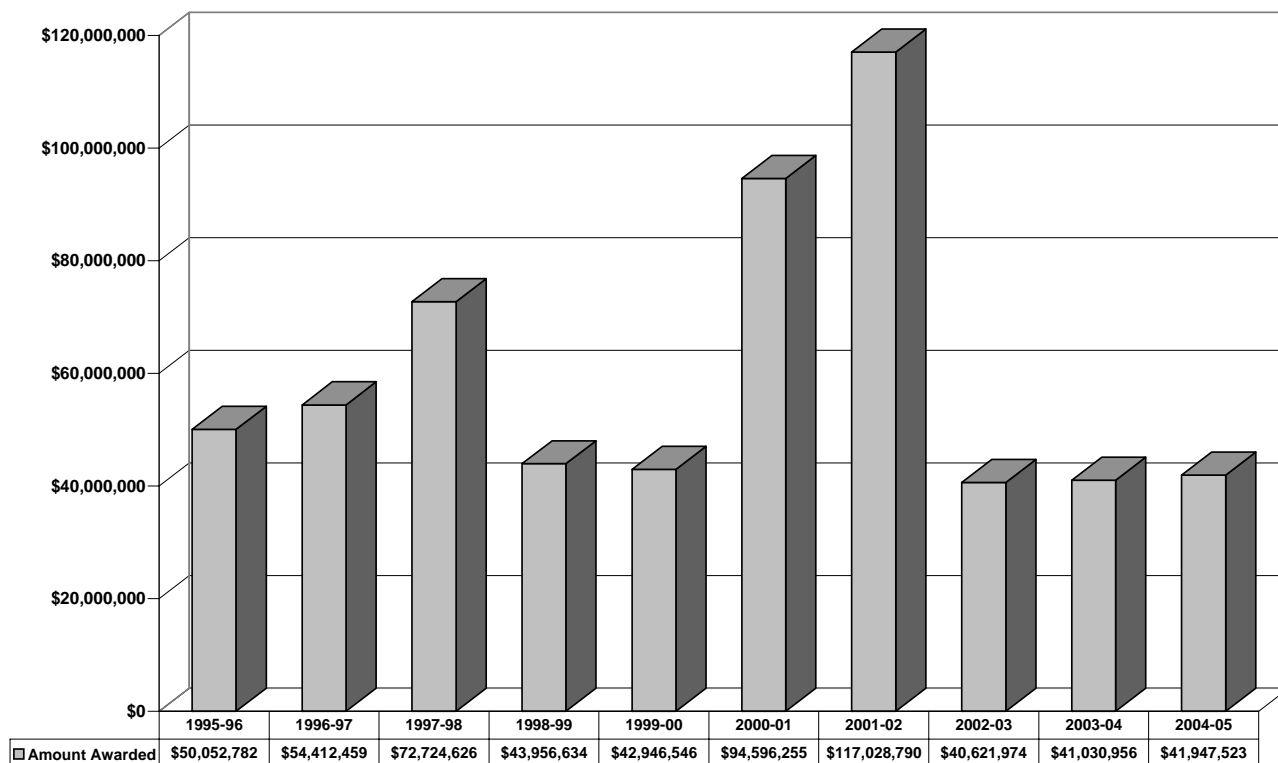

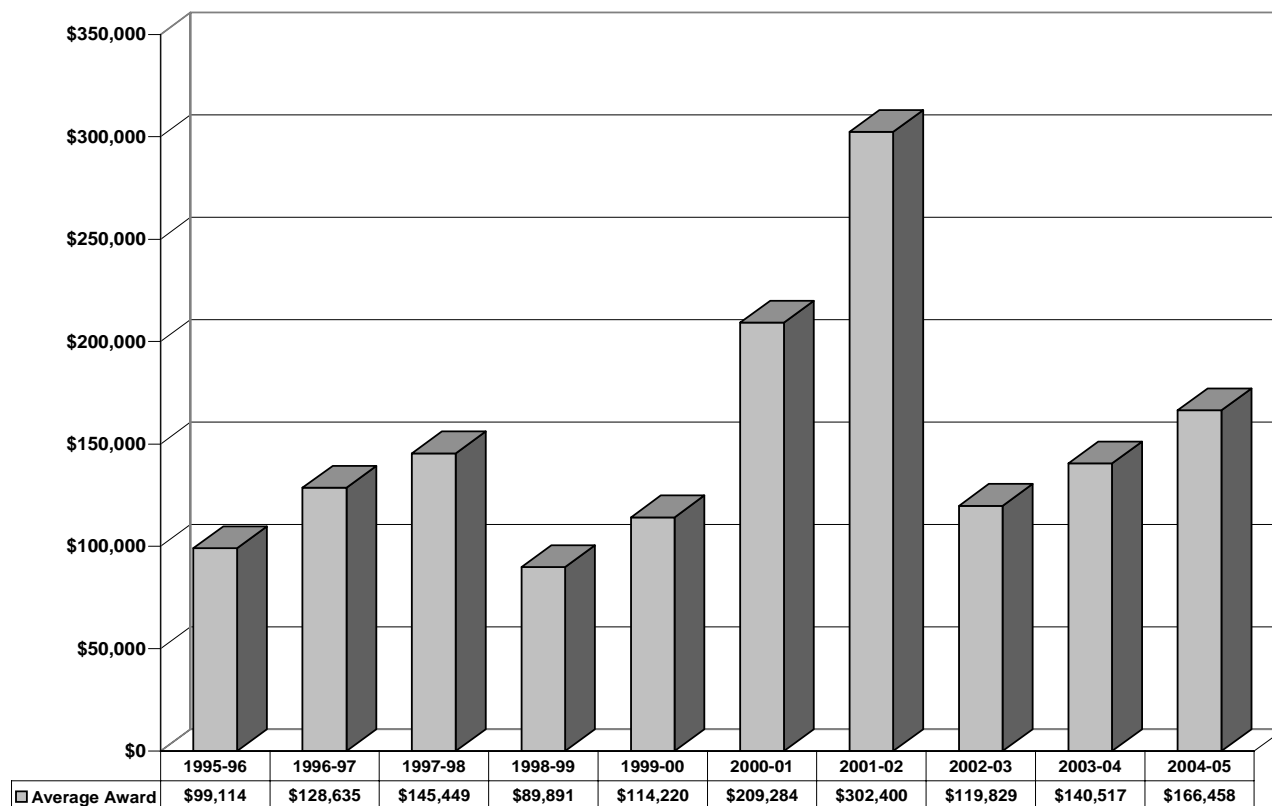
Damages and Torts Cases Disposed Statewide Fiscal Years 1995-96 Through 2004-05
