I am a solo practitioner.

Tennessee is the only state that I have ever been licensed in.

Since graduating law school, I have been exclusively practicing law as a solo practitioner. Prior to law school, I worked in the real estate and timeshare industry. Between graduation from college until working in the real estate industry, I worked as a manager at two different businesses and was a school teacher.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

Around fifty percent or more of my current law practice is in the area of family law, which includes divorces, post-divorce custody proceedings, juvenile court custody proceedings, adoptions, and termination of parental rights. Around twenty to twenty-five percent of my practice involves representing criminal defendants in General Sessions and Circuit Courts throughout East Tennessee. A very small percentage of my practice involves immigration law, specifically dealing with family immigration visas, adjustment of status, and naturalization. Around five to ten percent of my practice is in the area of Wills and Estates. The vast majority of the remaining area of my practice involves civil litigation, which would include section 1983 civil rights law suits, general tort lawsuits, and contract disputes.

For the first half of my career, a large majority of my work was involved in juvenile courts, including dependency and neglect, termination of parental rights, and unruly and delinquency. For about three to four years I handled many cases as a guardian ad litem.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

For the first several years of my practice, I was involved in juvenile courts representing indigent parents and defendants in various counties throughout East Tennessee. In addition, I have practiced throughout my career in front of Circuit and Chancery Courts with about half of my practice being in the nature of family law. The vast majority of the cases that I have tried in the trial courts of Tennessee were bench trials. In Criminal Court, both the General Sessions and Circuit Courts in Tennessee, I have represented hundreds of criminal defendants both as a private attorney and early in my career as appointed counsel for indigent defendants. In those cases, I would negotiate plea agreements for the defendants, conduct motion hearings, and try cases both before a jury and bench trials.

At the State Court Appellate level, the vast majority of my experience has been appeals in family law cases, specifically termination of parental rights and adoptions. I have also participated in appeals before the Federal Sixth Circuit Court involving § 1983 civil rights actions.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

In the late spring of 2007 I was appointed to represent an indigent mother in a termination of parental rights case that had been appealed to the Tennessee Court of Appeals. She had been represented by several other attorneys at the trial level and in previous dependency suits filed by DCS. After reading the trial transcripts and writing a brief, I was able to get the State to agree to a new trial.

When the case returned to the Juvenile Court, I was successful at getting the case dismissed. In addition I was able to have the underlying dependency petition dismissed. The State appealed that decision to the Circuit Court where we had the decision upheld.

For a period of over five years the State continued to try and terminate the mother's parental rights and filed at least two other cases. In the end I was able to get the State to enter an agreement that preserved my client's rights and protected the child.

I have volunteered helping on death penalty cases for appointed counsel to help ensure that the defendants received a defense.
