If you are ready to finalize your divorce, you must fill out this form. Only the spouse asking for the divorce must sign it, and that spouse **has to go** to the court hearing. **BUT**, it is a good idea for **both** spouses to go in case the court has questions. The Judge does not have to sign this Order if the Judge does not think your Divorce Agreement is fair.

The Court finds that the parties have signed and filed a divorce agreement that makes adequate and sufficient provision for the equitable settlement of property rights between them and fairly apportions their debt (an equitable division).

本法庭认定，当事人所签署和提交的离婚协议对于他们之间财产权利的处理进行了充分、公平的规定，并对其债务进行了公平分配（公平分割）。

That Agreement is now filed with and made part of this Order. The spouses swear they have no children together who are under 18, in high school or disabled. **Children together** means children they had together, born before the marriage, **AND** any and all children born or adopted during the marriage.

**Notice:** The Final Decree does not necessarily affect the ability of a creditor to proceed against a party or a party's property, even though the party is not responsible under the terms of the decree for an account, any debt associated with an account or any debt. It may be in a party's best interest to cancel, close or freeze any jointly held accounts. T.C.A. §36-4-134.
