I was responsible for the academic instruction and behavioral treatment and programming of special needs children, ages 6-8, at a residential school that was, at that time, part of the Tennessee Department of Mental Health and Mental Retardation.

Volunteer Regional Coordinator, Education Advocacy for Children with Handicaps (EACH), a non-profit organization. I was responsible for providing education advocacy services to parents of children with special needs in a ten-county area of southeast Tennessee on a volunteer basis.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I have extensive experience in all types of complex business and commercial litigation in state and federal courts and before state administrative tribunals. My practice areas vary from year to year depending on the mix of cases and needs of my clients. The following are estimates of my average case load: commercial and business litigation (40%); state and local tax litigation (30%); appellate litigation (20%); government contracts and bid protests (5% or less), administrative law and litigation (5-10%).

The variety of cases I have handled over the years include business litigation, state and local tax litigation, breach of contract cases, insurance, and real estate litigation, shareholder and corporate disputes, corporate governance disputes, partnership disputes, securities litigation, breach of fiduciary duty claims, fraud and misrepresentation claims, securities broker claims, environmental litigation, federal tort claims act litigation, condemnation, real and personal property tax valuations, employment-related litigation, including discrimination, restrictive covenants, non-competition agreements, and wrongful termination cases, civil rights litigation, and regulatory and administrative appeals from various state agencies.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

***Trial Court Experience***

I have experience with both jury trials and bench trials in civil matters before Tennessee state and federal district courts, representing individuals and businesses, plaintiffs and defendants. I

have been lead counsel as well as co-counsel at trial. More recently, I have served as appellate counsel with my firm's trial teams to assist with legal strategy, briefing for pre-trial and post-trial motions, and the preservation of issues for purposes of appeal. The majority of my trial experience is bench trials before the Chancery Courts, but I have also tried cases in Federal District Courts, State Circuit Courts, Probate Courts, and before the Tennessee State Board of Equalization and the Tennessee Claims Commission.

The types of cases I have been responsible for vary widely and this is an aspect of my practice that I have always enjoyed. Some examples of the types of cases I have handled at the trial court level include the following:

- insurance tax refund cases brought on behalf of multiple insurance companies regarding retaliatory insurance taxes;
- defense of consumer-related cases brought against a timeshare developer;
- challenges to state tax assessments on behalf of various clients, including internet service providers, national retailers, cosmetics and fragrance manufacturers, radioactive waste processor, fiber optics provider, record companies, equipment manufacturer, restaurant chains, and others;
- federal tort claims act claims on behalf of property owners for damages resulting from the May 2010 Nashville flood;
- defense of international engineering and environmental services company involving environmental claims before the state trial court, state environmental agency, and federal environmental agency involving remediation of underground storage tanks;
- real and personal property valuation disputes for various clients, including automotive manufacturers, non-profit country club, shopping malls, corporate headquarters;
- defense of employment-related claims on behalf of a joint venture providing services to the federal government;
- declaratory judgment action filed on behalf of a public utility to protect its certificated service area;
- defense of minority shareholder litigation brought against several closely-held corporations;
- defense of securities brokerage firms involving claims of fraud, conversion, and breach of fiduciary duties against former securities brokers.

***Appellate Court Experience***

I have experience handling appeals before the Tennessee Court of Appeals, the Tennessee Supreme Court, and the U.S. Circuit Courts of Appeal for the Sixth, Fifth and Eleventh Circuits. Some of the appeals I have handled include the following:

- business tort case between competitors that provide specialized medical monitoring services. I assisted the trial team and was lead appellate attorney before the Tennessee Court of Appeals. The case currently is pending before the Tennessee Supreme Court on an application for permission to appeal (pending).

- consolidated appeals involving retaliatory insurance tax refund claims on behalf of multiple groups of insurance carriers. I was lead trial attorney and lead appellate attorney responsible for briefing and arguing the cases before the Tennessee Court of Appeals and Tennessee Supreme Court.
- direct appeal from the Tennessee Regulatory Authority involving a regulatory compliance matter for a public wastewater utility. I was lead appellate attorney and argued the case before the Tennessee Court of Appeals.
- federal tort claims act case against the United States and the Army Corps of Engineers for property damage suffered by several commercial property owners during the May 2010 flood of Nashville. I was lead appellate attorney and argued the case before the Sixth Circuit Court of Appeals.
- performing artist dispute with former business manager, including claims for accounting malpractice, breach of fiduciary duty, breach of contract, misrepresentation. I was the lead appellate attorney on the briefs before the Tennessee Court of Appeals
- authored *amicus curiae* briefs for the Tennessee Bar Association, the Nashville Chamber of Commerce, the Innocence Project, the American Health Care Association, and others.

***Administrative Law Experience***

I have handled numerous real and personal property tax appeals before county boards of equalization and the State Board of Equalization. The issues I have handled involve both real and tangible personal property valuations, property classifications, and assessments. In cases where judicial review is sought from final administrative decisions, I serve as lead attorney before the Chancery Courts and Court of Appeals.

I have also appeared from time to time before the Tennessee Regulatory Authority, now known as the Tennessee Public Utility Commission, the Tennessee Department of Revenue, and the Tennessee Department of Environment and Conservation.

I have represented a variety of clients in connection with state contract bid protests, including financial service providers, telecommunications service providers, food service providers, and information service providers, involving multi-million dollar contracts for state services.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

I was the lead trial and appellate attorney in a consolidated group of insurance tax refund claims, which were originally filed with the Tennessee Claims Commission and were appealed to the Tennessee Court of Appeals and the Tennessee Supreme Court. These cases involved complex and novel issues.

I was the lead appellate attorney in a federal torts claims act case against the federal government and U.S. Army Corps of Engineers, involving property damage to several property owners during the May 2010 flood of Nashville. The case presented complex issues of governmental

immunity under the federal Flood Control Act and defenses or exceptions to liability under the Federal Tort Claims Act.

I was the lead counsel on a multi-forum environmental litigation matter involving an underground storage tank in Tennessee, with matters simultaneously pending before the Chancery Court, the Tennessee Department of Environment and Conservation and the U.S. Environmental Protection Agency. This representation was technically complex and required significant legal strategy and planning in the multiple proceedings, all of which were successfully resolved.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

As an associate attorney, I assisted one of my firm's litigation partners with the representation of a death row inmate on state post-conviction and federal habeas corpus relief on a pro bono basis by appointment through the former Capital Case Resource Center and the Tennessee Supreme Court. This was one of the most challenging cases of my legal career and proceeded through multiple levels of review and appeal before both state and federal courts as the law in this area was changing. Our representation continued for about seven years until our client died from natural causes while on death row.

I have also assisted with the representation of several state prisoners in federal civil rights actions by appointment through the United States District Court, Middle District of Tennessee. The issues involved conditions of confinement, including access to adequate medical care and access to legal materials and resources.

I have not previously applied for a state judicial position. In 1994, I applied for a United States Magistrate Judge position in the Middle District of Tennessee, but was not selected.

I attended law school from 1982 to 1985. I achieved the third highest grade point average in my law school class of 155, graduating with highest honors. Additional honors I received included:

***University of Tennessee at Chattanooga, Chattanooga, Tennessee (1977-1980)***

I attended UTC as a graduate student from 1977 to 1980 on a part-time basis while teaching full-time and completed 18 hours toward a Master of Science degree in Education. While I was a graduate student, I was selected to Kappa Delta Phi Honor Fraternity. I entered this program after I graduated from Indiana University and began working as a teacher/counselor at a residential school for special needs children in Chattanooga, Tennessee. I withdrew from this program before completing my Master's degree because I changed my professional goals and decided to pursue a legal career.

***Indiana University, Bloomington, Indiana, B.A. 1976, Major in Psychology***

I attended Indiana University, Bloomington as an undergraduate student from 1974 to 1976 to complete my undergraduate education and earn my bachelor's degree. Honors I received included the Founder's Day Academic Achievement Award and selection for the Senior Honors Seminar. I was a member of the Indiana University Student Foundation and worked on a part-time, work-study basis at the Indiana University Library and the Indiana University Yearbook. I also volunteered as a student assistant to the Indiana University Cross Country and Track teams.

***University of Tennessee at Chattanooga, Chattanooga, Tennessee (1972-1974)***

I attended UTC as an undergraduate student from 1972 to 1974. As an entering freshman, I was selected for the Interdisciplinary Honors Program, which is now known as the Brock Scholars Program. It was not my original plan to enroll at UTC, but I had a severe case of mononucleosis after my senior year of high school and was unable to enroll at my first choice, Indiana University. Because my family had relocated to Chattanooga, I attended UTC for two years before transferring to IU in 1974 to complete my undergraduate education.

*Conner v. Metropolitan Life Ins. Co., et al., U.S District Court for the Western District of Tennessee No. 2:15-cv-02883, Sixth Circuit Court of Appeals Nos. 16-5504 and 16-5590, U.S. Supreme Court No. 17-8824.*

I was named as one of numerous defendants in a lawsuit filed by a pro se plaintiff who was unsuccessful in a prior lawsuit that was also filed pro se against several federal agencies and my client, Metropolitan Life Insurance Company. The plaintiff sought life insurance benefits as a beneficiary under the Federal Employees Group Life Insurance Program, which is administered by Metropolitan Life. In the first lawsuit, the district court granted summary judgment in favor of the federal defendants and Metropolitan Life. The plaintiff appealed, and the Sixth Circuit affirmed the dismissal. The plaintiff unsuccessfully attempted to reopen the first lawsuit.

The plaintiff then filed a second lawsuit alleging conspiracy claims arising out of the first lawsuit under the Racketeering Influenced and Corrupt Organizations Act. Numerous defendants were named including the U.S. district judge from the first lawsuit, a U.S. Congressman, multiple federal government officials, the U.S. Attorney for the Western District of Tennessee, several U.S. assistant attorneys, Metropolitan Life, and one of my associates and me as counsel for Metropolitan Life. Summonses were never issued or served.

The plaintiff sought recusal of the district judge and the magistrate judge in the second lawsuit, which were denied. The magistrate judge then issued a Report and Recommendation for dismissal of the complaint as a frivolous lawsuit. The district court affirmed the dismissal, which the plaintiff appealed. The Sixth Circuit also affirmed the dismissal. The plaintiff filed a petition for certiorari before the U.S. Supreme Court, which was denied. The plaintiff filed a petition for rehearing before the U.S. Supreme Court, which currently is pending.

*Patricia Head Moskal, et al. v. Ivy Yolanda Jeffries, et al., Davidson County, Tennessee, Circuit Court Case No. 90C3044.* I was a co-plaintiff in this lawsuit arising out of an automobile collision in which my car was struck by the defendant's car, I was injured, and my car was totaled. I was awarded damages after a jury trial.

*In re Adoption, Davidson County, Tennessee, Circuit Court.* I was the co-petitioner in a state court proceeding granting my son's adoption. The records were placed under seal and are confidential in accordance with Tenn. Code Ann. § 36-1-126.

For a long time, I have aspired to one day enter public service and have the opportunity to serve as a judge and give back to our community. Nashville has been my home for thirty-three years where I continuously have practiced law in a wide variety of civil litigation matters. My practice has allowed me to develop my trial skills, expand my legal knowledge, hone my analytical abilities, and pursue my love of learning. My practice, coupled with my experience in leadership roles within the legal community, have prepared me well to undertake the new challenge of service as a Chancellor. I am passionate about the law and believe our judicial system is well-served when we have knowledgeable and experienced jurists on the bench who manage their dockets efficiently and effectively and decide cases fairly and impartially. I believe I can help promote these goals by bringing to the bench my experience, judgment, fair-mindedness, integrity, and work ethic.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (*150 words or less*)

I seek the position of Chancellor, Part I, of the Chancery Court for Davidson County, Tennessee, 20th Judicial District. In Davidson County, four Chancellors conduct bench and jury trials and hear motions in a wide variety of civil cases, including all types of business and commercial cases, contract disputes, applications for injunctive relief, declaratory judgment actions, state tax controversies, administrative appeals, and other civil cases.

I believe that the breadth of my professional experience, even temperament, and strong work ethic are personal qualities that will serve me well as a trial court judge and will have a positive impact on the Court. The majority of my cases over the years have been in Chancery Courts

across the state, and I am thoroughly familiar with the trial court process. I believe the overall diversity of my practice, including in-depth experience with complex commercial cases, will be of particular benefit to the court.

Yes, I will uphold the law regardless of my personal beliefs. An example from my experience as a licensed attorney was my representation of a death row inmate. It was necessary for me to set aside my personal and moral beliefs about the death penalty and the guilt or innocence of my client. My legal role as an advocate was to assist with my client's representation to the best of my abilities before multiple courts and vigorously pursue all available legal remedies. As a judge, I will be fully capable of deciding each case based on the law and the facts presented without regard to my personal beliefs.


