I have been self employed as a sole practitioner since becoming licensed and have maintained an office in Washington County, Tennessee. During my third year of law school I worked as a clerk at the firm of Kustoff & Strickland in Memphis, Tennessee. During college I worked from January to May of 1997 as an intern in the Tennessee General Assembly. Aside from summer jobs during high school and college, I have had no other occupations.

My practice is almost exclusively devoted to criminal defense and has been so for several years. Currently, I do not solicit or accept work other than criminal work with the exception of clients whom I represent in criminal matters.

As I stated in my answer to the previous question, my current practice is devoted almost entirely to criminal defense.

In the area of criminal law, I have handled virtually every type of matter that will come before the court. I have served as both lead counsel and as co-counsel in capital murder cases as well as trying numerous murder and other serious felony cases.

I have also handled many post conviction proceedings and appeals in front of the Court of Criminal Appeals.

On several occasions I have appeared in front of administrative law judges at the Tennessee Department of Safety in which I represented criminal defendants in forfeiture proceedings.

Earlier in my career my practice was a general practice of law. The matters that I handled included domestic relations, personal injuries, juvenile court matters (both delinquent matters and dependant and neglect), breach of contract and criminal defense. Because of my interest in

criminal defense, I began to limit my practice to criminal work. On rare occasions, I still assist my current clients with civil matters which relate to their criminal charges.

9. Also separately describe any matters of special note in trial courts, appellate courts, and administrative bodies.

State v. Marsha Shelton, Ms. Shelton was charged with three counts each of first degree murder and felony murder along with one count each of conspiracy to commit aggravated robbery, aggravated robbery, aggravated kidnapping, aggravated child abuse, aggravated arson, theft of property over \$1,000.00 and theft of property over \$500.00. The state filed notice to seek the death penalty. I was appointed lead counsel. The case involved a triple homicide (two adults and one child). After many months of work and negotiation I was able to secure a negotiated plea in which my client avoided the death penalty by pleading guilty and received a sentenced of life with parole.

<u>State v. Theadore Ratliff</u>, Mr. Ratliff was charged with first degree murder, especially aggravated robbery and especially aggravated burglary. At the time of the homicide my client was on parole for a prior murder conviction. Along with two co-defendants, Mr. Ratliff was accused of the robbery and murder of an elderly woman in her home. Through negotiations which lasted several months, I was able to secure a negotiated plea that allowed Mr. Ratliff to plead guilty and receive a sentence of life without the possibility of parole, avoiding a death sentence.

State v. Howard Hawk Willis, I was appointed co-counsel in Washington County case number 28343 in which Mr. Willis was charged with two counts each of first degree murder and abuse of a corpse and one count of attempted kidnapping. Mr. Willis was accused of killing a young couple and dismembering one of their bodies and disposing of those body parts in Boone Lake. The remainder of their bodies was found in storage containers in a local storage building. Mr. Willis had several attorneys (both lead and co-counsel) and eventually was ordered by the court to represent himself in the matter. I believe that I served as his counsel the longest, from May 31, 2005 to May 16, 2008.

**State v. Roger Dale Greenwell**, Mr. Greenwell was charged in Washington County with first degree murder. This case involved the beating death of an elderly man. After several months of hearings and negotiations, my client entered an Alford plea to second degree murder.

**State v. Terry McIntosh**, Mr. McIntosh was charged in Washington County with first degree murder. This case involved the gruesome death of a homeless victim near the Veterans Administration Hospital in Johnson City. After several court appearances and lengthy negotiations, I convinced the District Attorney that my client was not guilty. The case against Mr. McIntosh was dismissed.

<u>State v. Sherry Clawson</u>, Ms. Clawson was charged in Washington County with second degree murder. Ms. Clawson was charged with the stabbing death of her husband following a period of drinking and camping along the Nolichucky river. There was a history of domestic abuse. After

a jury trial, my client was found guilty of the lesser offense of voluntary manslaughter.

<u>State v. William Ned Snow</u>, Mr. Snow was charged in Johnson County with growing approximately 800 mature marijuana plants on a remote section of his property. After numerous court appearances and the filing of a motion to suppress, which is submitted as one of my writing samples, the State of Tennessee moved to dismiss the charges prior to the hearing on the motion to suppress.

I also represented Mr. Snow in a forfeiture proceeding before the Department of Safety. At the time of his arrest officers seized and sought forfeiture of money, several guns, vehicles and motorcycles that belonged to Mr. Snow. The value of the property seized from Mr. Snow was valued in excess of \$100,000.00. After a trial before an administrative law judge, the court ordered that all money and property be returned to Mr. Snow.

<u>State v. Jason Charles Austin</u>, Mr. Austin was charged in Washington County with first degree murder. This case involved the shooting death of the son of a former Johnson City police officer. After a jury trial which spanned several days, my client was found guilty of the lesser offense of second degree murder.

<u>State v. Brenda Bolton</u>, Ms. Bolton was charged in Washington County with first degree murder. The case involved the shooting death of an alleged gang member in my client's home in rural Washington County. After lengthy negotiations, Ms. Bolton entered a guilty plea to the lesser offense of voluntary manslaughter.

<u>State v. Steve Jones</u>, Mr. Jones was charged with the first degree murder of his estranged girlfriend, at the McDonald's in Elizabethton, Tennessee, following a visit with the couple's children. The matter was twice tried before a jury. The first verdict was set aside by the trial judge due to newly discovered evidence. Following both trials my client was convicted of first degree murder.

State v. Loy Dale Lineweaver, Mr. Lineweaver was charged with second degree murder in the shooting death of the victim. The case was tried before a jury and Mr. Lineweaver was convicted of the lesser offense of voluntary manslaughter.

My reason for seeking this appointment is to improve respect for and observance of the law in the community. I have learned through extensive trial experience the importance of a competent, experienced and courteous judge to the administration of justice and to the respect that the public must take away from the courtroom. The function of a judge is to administer justice in a way that creates and promotes respect not only in the courtroom participants but in the general populous. While it would be profitable for me to continue in my current law practice, I am dedicated to improving the judicial system in which I work. The position of judge would provide that opportunity.

I can not relate any activity in which I have been involved which demonstrates my commitment to equal justice under the law more than my willingness to accept extremely unpopular

defendants as court appointed clients. The most positive proof of a lawyers commitment to equal justice is his willingness to endure the criticism of the general public, to answer questions such as "how can you represent such a person", and to dedicate himself to the proposition that regardless of the ostensible cruelty of their actions, that everyone is entitled to a competent, capable and dedicated defense.

Recently, at the request of Judge Ben Hooper, I accepted an appointment in a triple homicide. The State sought the death penalty. Two adult victims were stabbed while a two year old child died as the result of a fire. After months of preparation, the case was resolved by a negotiated plea for a sentence of life.

I have on numerous occasions represented clients on a pro bono basis.

37. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. *(150 words or less)* 

I am applying to be appointed to the Criminal Court of the First Judicial District, which is currently comprised of Carter, Johnson, Unicoi and Washington County. The District has one other criminal court judge. This court has jurisdiction over felony and misdemeanor offenses, and post conviction proceedings. The court also hears misdemeanor appeals from General Sessions Courts de novo.

Because I have been involved with the litigation of almost every type of case the court will hear, I can seamlessly transition into the position as judge and administer the court's business. I will improve the efficiency of the court by scheduling cases in a way that reduces the time spent waiting, by victims, police officers, attorneys, and litigants prior to their case being called. I will also work to reduce the amount of time between an indictment and trial.

38. Describe your participation in community services or organizations, and what community involvement you intend to have if you are appointed judge? *(250 words or less)* 

Since my admission to the bar I have dedicated the majority of my time to my law practice, clients and family. However, I have also been active in my community. I am a member of Piney Flats Methodist Church and in the past have served as an assistant scout master and as president of the Ruritan Club. Also, I have volunteered my time to the moot court competition conducted by the Young Lawyers Division of the Tennessee Bar Association.

Additionally, I have had several opportunity's to speak to school groups, at both the high school and college level, concerning the interaction between legal issues and society and how the law impacts each of our lives. I have found these experiences very rewarding and productive.

If I am appointed judge I would continue to be active in the community and I would use the position to better acquaint the community with the role of the judicial system.

I am a seventh generation east Tennessean and was raised on the farm that has been in my family since before the civil war. I have lived in this geographic area my entire life, with the exception of time in law school and a semester in college, when I served as an intern at the Tennessee General Assembly. My understanding of the community and its people will help me to preside over the court with an understanding of the people who appear before me, their history and way of life.

I am no stranger to hard work. I have worked on a farm my entire life and I routinely work 50-60 hours per week in my law practice. I can handle the heavy dockets involved in the criminal court and will spend the time necessary to keep the docket current and prevent unnecessary delays in bringing matters to a fair and just resolution. Because of my extensive trial and practice experience, in the criminal courts of this state, I am prepared to step into the job and handle the court's business on day one.

Also, I recognize that aside from having legal knowledge and experience, a judge must have an even temperament. It is imperative that a judge treat all parties involved in a matter with respect and dignity. I believe that anyone who has practiced with me over the years would agree that I have the right temperament to be judge.

40. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

A trial judge has the obligation to follow the laws as promulgated by the General Assembly and I would always follow and uphold the law, even if I have a personal disagreement with the statute or rule in question. In a representative democracy, it is not the function of the courts to make or expand laws or constitutional rights, but rather to interpret and apply the laws as written by the legislature. In enforcing and interpreting a statute, I feel that a judge should look to text of the statute, rule and constitutional provision being examined and construe that provision based upon the text of the provision in question and interpret those words by their plain and ordinary meaning. It is not for a judge to make law from the bench.

I cannot recall a situation as an attorney that I have been required to uphold a law that I do not agree with.
