ORDER

On July 20, 2020, the Defendant, Neal Scott Daniels, filed an application for an extraordinary appeal pursuant to Rule 10 of the Tennessee Rules of Appellate Procedure challenging the trial court's rulings denying the Defendant's motion for expert assistance funding and motion for a continuance of trial. In his application, the Defendant argues that a continuance was necessary based on the rising incidence of COVID-19 cases in Knox County, that funding is needed to present "expert testimony regarding the cognitive effects of nervousness, fear, anxiety, or any other strong emotion caused by being required to sit for jury service during a pandemic," and that the trial court's rulings have denied the defense of the "ability to present relevant experts necessary to litigate unprecedented constitutional issues." The Defendant's application was denied by the Court of Criminal Appeals on July 20, 2020.

An extraordinary appeal may be sought from an interlocutory order pursuant to Rule 10 of the Rules of Appellate Procedure "on application and in the discretion of the appellate court alone . . . (1) if the lower court has so far departed from the accepted and usual course of judicial proceedings as to require immediate review, or (2) if necessary for complete determination of the action on appeal as otherwise provided in these rules." Tenn. R. App. P. 10(a). As the Court of Criminal Appeals observed, matters relating to continuances and the funding of experts are left to the discretion of the trial court. After due consideration, we conclude that the Defendant has not shown grounds for an extraordinary appeal under Rule 10. It is therefore ordered that the Defendant's application and his motion for a stay are denied.
