Since completing my legal education, I have been self employed as an attorney in Cocke County, Tennessee. Through the years, my practice has included experience in areas including, but not limited to, family law and related matters, criminal law, probates and estates, and personal injury, with an emphasis on family law. In addition, I have served as Cocke County Attorney since March 21, 2011. My duties as County Attorney have introduced me to a wide range of legal situations. In addition to being general counsel for the various branches of Cocke County government, I have helped guide the county through numerous suits filed against the county in

many different areas of the law.

Divorce and Family Law: 40%, County Attorney related duties: 40%, Probate and Estate matters: 15%, Criminal Law: 3%, Miscellaneous: 2%

Prior to my appointment as County Attorney, criminal law, in both Circuit and General Sessions Court, constituted a much larger portion of my work. In my duties as County Attorney, I represent the Cocke County Sheriff's Department. After consultation with the Board of Professional Responsibility, I determined that continued representation of criminal clients arrested by the Cocke County Sheriff's Department could be viewed as a conflict of interest so I no longer represent defendants arrested by the CCSD. Those individuals make up a large percentage of people arrested in this county so I have focused my practice in other areas since my appointment as Cocke County Attorney. Prior to that time, I represented criminally charged clients in Circuit and General Sessions Courts in crimes ranging from speeding tickets to large scale manufacturing of illegal drugs. I have represented clients in post conviction cases as well, and I have submitted briefs to the Court of Appeals on behalf of those clients.

I have argued before the Tennessee Court of Appeals in a juvenile matter as Guardian ad Litem for the child in question. I have served solely as both Petitioner's and Respondent's counsel in Order of Protection matters in both General Sessions and Circuit Court achieving success for my clients in both courts on multiple occasions.

I have solely represented clients in contested hearings and large numbers of mediations regarding family law and child support related matters in the Circuit, Chancery, and Juvenile Courts of Cocke, Sevier, and Jefferson Counties. Further, I routinely argue before the Chancellor in Cocke County Chancery Court concerning the various stages of probate matters. I have served as Guardian Ad Litem in Chancery conservatorships on numerous occasions.

As County Attorney, I have argued on behalf of the county in multiple unemployment appeals before a hearing officer within the Tennessee Department of Labor and Workforce Development Office of Appeals Tribunal. Further, I successfully argued on behalf of the county in a lawsuit concerning the county's lack of zoning laws recently filed in General Sessions Court.

ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

A Circuit Court Judgeship has been my goal since entering this profession. I would strive to be fair, and I would enjoy the work, though strenuous. The Fourth Judicial District deserves a qualified native who is vested in his or her community. Judge Ben W. Hooper, II is the only Cocke County resident serving as a Fourth Judicial District Circuit Court Judge. I, too, am a Cocke County resident and I enjoy working with fellow lawyers and the public. Like Judge Hooper, I will treat all litigants with the respect that human beings deserve. As County Attorney, I enjoy frequent interaction with various county department heads and other officials. I love our portion of East Tennessee and have no intention of leaving. That, in conjunction with the aforementioned working relationships with colleagues and other officials, has led to this application submission.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking appointment as Circuit Court Judge for the Fourth Judicial District. Said district includes Sevier, Cocke, Jefferson, and Grainger Counties. Circuit Court Judges hear trial level crimes ranging up to death penalty cases as well as many civil matters including, but not limited to, transactional disputes, personal injury, orders of protection, and family law matters. There are four Circuit Court judgeships in our district. Judge Hooper is the only Cocke County resident currently serving as Circuit Court Judge. Cocke County deserves to keep a qualified resident as Circuit Court Judge for matters of judicial efficiency and attorney convenience. I do not intend to leave or change the respectful way with which Judge Hooper has conducted court. Like Judge Hooper, my office would be located in Newport, Tennessee, and I would strive to serve the people of the Fourth District diligently until retirement.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Most lawyers have encountered situations where the law does not conform with their personal beliefs. However, statutory law, while imperfect, is enacted by legislators elected to be voices for the citizenry. It is not the duty or privilege of a trial court judge to disregard that process. As judge, I would seek to follow the law consistently. Otherwise, I would unnecessarily burden higher courts with litigation that would potentially return to my court with instructions to follow the law. This would be a waste of taxpayer money, and a waste of time for all parties involved. I will share my experiences concerning an aspect of family law with which I frequently deal. I personally do not agree that a parent's child support obligation should change with the addition of children to either party to the obligation. I have often explained to an angry client that state law requires me to factor the opposing party's other applicable children into the child support worksheet. My explanations generally end with advice to call the client's state representative because we must follow the law. Additionally, I never omit that portion of the worksheet calculation, and I have not argued its validity to a judge based on personal objections. If appointed to this trial court position, I would inform counsel that objections to the law's substance must be taken to a higher court. Moreover, personal disagreement with said laws would not factor into my decisions, because I respect the law and its processes.
