6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My present law practice is a general practice and it varies some from year to year. Our practice has consisted of approximately24% civil litigation, 6.1% criminal, 22% domestic relations, 24.2% wills and probate, 6.6% real estate, 2.8% contracts, and 14.3% governmental law up to date for 2017.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

A large percentage of my practice includes trial work. Most of my time during the week is spent in General Sessions, Circuit, or Chancery Court in various counties. Occasionally, I will represent clients in municipal courts in different counties. I have experience with both civil and criminal jury trials as well as numerous bench trials. I usually have about a case or two a year go up on appeal. In addition, I have eleven years' experience representing municipalities and their various boards. I represented real estate agents before the Tennessee Real Estate Commission involving real estate transactions and went before the Tennessee Department of Safety in regard to seized property where my client was the lien holder. I have also done some work in Federal Court relating to unfair debt collection procedures. I also do real estate closings and draft documents for clients fairly regularly.

I have experience in both criminal and civil trials and written both criminal and civil appellate briefs. Some of the issues I have written briefs on are termination of parental rights, domestic law, post-conviction relief, and issues relating to civil procedure. I have been successful on appeal a majority of time.

Several aspects of my legal career are advantageous for me in this position. I am the first female out of six generations of lawyers and judges. My family's legal heritage has helped me gain a wealth of information that has been beneficial to my career. In addition, while in law school, I worked as a research assistant for the law library and I often wrote appellate briefs for additional income. These research and writing skills I developed have benefitted me tremendously in the practice of law. In addition, it is the moral, ethical, and legal, obligation of attorneys to help those in need of legal services. It has been my personal policy to assist in pro bono work at least five hours every week. As a part of my services, I advise non-profit organizations, assist victims of domestic violence, and help others that are less fortunate with their basic legal needs.

I am the plaintiff in a case where I was the landlord against my tenants that damaged my property. It was Quinn Brandon Stewart v. Teri Anderson and Jeremy Cummings, Marshall County Circuit Court, Case #17-CV-31. After a bench trial, I was awarded a judgment for \$13,026.86 plus costs. Defendants have filed a motion for a new trial or to alter or amend the judgment. It is set to be heard on September 22, 2017.

In addition, I was occasionally named in lawsuits against the City of Lewisburg when I was on the Lewisburg City Council. Usually litigants against municipalities name everyone possible in the lawsuits. I do not recall the specifics, but I was never called as witness or found to be personally liable.

ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

One of my major motivating factors in going to law school was to help people on a daily basis. Lawyers have the ability to help others, but judges have the ability to help people on a grander scale based on the multitudeof people they encounter. Judges also have the innate ability and obligation to do the right thing. Lawyers are often required to do what is best for their clients even though it is not necessarily the right thing for everyone else involved. I have thoroughly enjoyed my experiences over the last twelve years as a municipal judge and it has given me the desire to work in a larger court setting and make more of a positive impact on my community. It is my sincere desire to help litigants to feel respected and fairly treated in their pursuit for justice.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking appointment as Circuit Judge of the Seventeenth Judicial District. The judicial district consists of the rural counties of Marshall, Bedford, Lincoln and Moore. It has two circuit judges and a chancellor with concurrent jurisdiction. Judges in this District hear both civil and criminal matters. Myjudicial experience combined with my knowledge base from both criminal and civil trial matters make me uniquely qualified for this position. My selection would positively impact the court by adding a fresh perspective and a wealth of information gleamed from years of private practice. If selected, I fully intend to use this knowledge to treat everyone fairly, equitably, and with respect, which will in turn improve the public's perception of the judiciary.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I will uphold the law regardless of my personal beliefs regarding the law. A judge's role is not to make laws. A judge's pivotal role is to interpret and apply the law, weigh the evidence, and make an impartial decision. Judges attempting to undermine and change laws are circumventing the principles of an independent judiciary.

For example, I personally believe that parents should do whatever is reasonably possible to provide their children with health insurance. Occasionally, a step parent has insurance available through their work at a more reasonable rate than the legal parent. However, the Child Support Guidelines do not allow legal parents to receive credit for contributions from a step parent in calculating child support. Therefore, the legal parent either pays more in insurance to the detriment of the child or has the child enrolled in TennCare. Either of these situations are not logical if the insurance was obtained by the step-parent at a lower rate reducing the family expenses. Despite my feelings on this matter, judges should continue to exclude insurance payments by step parents in child support payments as long as this is the law. It would be up to the legislature to make these changes.
