ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

I am applying for this vacancy after considering it for many of the recent vacancies in Shelby County. The introduction says the Council is trying to appoint the best and most qualified candidate. I believe that my experience makes me that candidate. I have spent my practice becoming a proficient trial practitioner and I feel that at this point of my career, I can use the knowledge I have acquired to make a difference serving the public as a Circuit Judge. I feel it is important for the next Judge to have ample experience in the courtroom as that is where he or she will work everyday. I have over 100 Jury trials as a First Chair Litigator. I have a very good relationship with other members of the Bar and I feel that my ability to work with litigants and lawyers for such a long career, will allow me to move into the role of Circuit Judge easily.

I want to be the Circuit Judge for Division 9 of the Shelby County Circuit Court for the Thirtieth Judicial District at Memphis. I am very familiar with the attorneys and other Judges in this area. I have a good working relationship with the vast majority of the Memphis Bar and I feel that the Bar's familiarity with me and my ability will create a smooth transition with little to no delay in moving pending cases.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Any Lawyer who has been in practice for any length of time has cases or statutes with which they do not agree. However, I do understand the weight of precedent and I absolutely can follow the law. In my practice, the best example of where I disagree with the law on a particular topic is the Made Whole Doctrine and where it intersects with TnCare. I once represented a little girl who was ejected from a vehicle and suffered a C1-C2 fracture. She was a ventilator dependent Quadriplegic. TNCare did not agree that the child was "not made whole" by the recovery and sought to get the entire proceeds of the settlement. The matter was argued before Judge Childers who made the finding that the Minor was not "Made Whole" from the recovery which under Tennessee law would nbar recovery by TNCare. TNCare appealed. The Court of Appeals agreed that the equitable principles of the Made Whole Doctrine should apply and we were able to secure some money for this child.

Subsequently, The Tennessee Legislature, in response to this ruling, changed the TNCare Statute and specifically stated that the Made Whole Doctrine did not apply to TNCare. While I disagree that this is good for Tennessee or fair to litigants, I do recognize that this is the law of the law and I, of course, follow the law.
