as a floater in the bookkeeping department of First National Bank in Shelbyville, Tennessee. While attending Middle Tennessee State University I worked as a resident assistant in Cummings Hall for three (3) years while returning home in the summer to work at the bank.

During my senior year at Middle Tennessee State University I began working in loss prevention

at Castner Knott department store. I continued that job when I began attending Nashville School of Law in 1991. I also worked part time for Judge Donald Harris, Circuit Court Judge of Williamson County, Tennessee as his jury attendant.

I was offered a position as a legal assistant to Jane Forbes, an attorney, in Franklin, Tennessee. I left Ms. Forbes' office and worked for a few months as a runner at Baker, Donelson, Bearman & Caldwell in Nashville, Tennessee.

I was contacted by Isham Bradley, an attorney I met while working for Ms. Forbes, and he offered me a position as his legal assistant. I worked for Mr. Bradley until I graduated from Nashville School of Law in 1995.

I shared office space as a sole practitioner with Mr. Bradley when I began my practice in October of 1995 until July of 1997.

In July of 1997, I made the best decision of my career and returned to my hometown of Shelbyville, Tennessee to practice law with Rondal T. Wilson, Sr., C. Kelly Wilson and Thomas E. Nance. I have continued to practice law with Kelly Wilson for the last twenty (20) years.

I currently practice in the following areas: Family Law – 60%

Criminal Defense – 20%

Social Security Disability – 5%

Probate and Wills – 10%

Personal Injury and Miscellaneous Civil Matters – 5%

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have practiced extensively in the Circuit and Chancery Courts of the 17th Judicial District in both civil and criminal cases. I have also practiced in various Chancery, Circuit and General Sessions Courts in counties throughout Middle Tennessee. I have appeared before the Tennessee Court of Appeals, Tennessee Court of Criminal Appeals, and the Tennessee Supreme Court. I have appeared in Federal Court, and appeared in the Sixth Circuit Court of Appeals.

A large portion of my present practice involves family law matters. My cases range from preparation of antenuptial agreements, complicated contested divorces involving division of assets and/or complex determinations of a residential schedule and child support for minor children to uncontested divorces. As the years have progressed, there has been an increase in cases involving the establishment of paternity and a residential schedule for the minor children.

The most rewarding area of my Family law practice is adoptions. By my estimation I have handled over one hundred contested and uncontested termination of parental rights cases leading to adoption. I have also defended clients when prospective adoptive parents have sought to terminate their rights.

A portion of my practice includes representing Plaintiffs in personal injury and other tort matters. In years past, I represented injured employees in worker's compensation cases until the changes in the laws that created the administrative process for worker's compensation.

I also prepare wills and administer estates for clients in Chancery/Probate Court in the 17th Judicial District. I have defended claims against estates as well as will contests.

My criminal cases have ranged from shoplifting to first degree murder through the years. At present, I primarily represent clients in general sessions courts for misdemeanor and felony offenses along with some felony cases in Circuit Court throughout the 17th Judicial District.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

Phil Phillips vs. Lori Ann Phillips I have handled numerous divorce and custody cases throughout my career, but there was one client I represented in her divorce and post-divorce issues for nearly seven (7) years in the Chancery Court of Bedford County, Tennessee. Phil Phillips vs. Lori Ann Phillips, docket number 27,775. Ms. Phillips and her minor children had suffered physical and emotional abuse which continued by the filing of unwarranted and litigious pleadings by Mr. Phillips for years. Ms. Phillips' confidence in me to continue to represent her never faltered and together with her children and the testimony of the child's counselor we were finally able to provide them a safer and more peaceful life by suspending the Father's parenting time.

In <u>Alicia D. Howell vs. Nissan North America, Inc., et al.</u> 346 S.W. 3d 467 (Tenn. Sup. Ct 2011) I represented an injured employee in a workers' compensation reconsideration of benefits case. The issue was whether the employee made a meaningful return to work. The Circuit Court of Moore County, the Honorable Lee Russell, awarded additional benefits ruling that she did not have a meaningful return to work. The Special Workers' Compensation Panel reversed. The Tennessee Supreme Court granted the appeal and ruled that the employee did not have a meaningful return to work, reversed the ruling of the Panel and reinstated the trial court's

judgment. This case was cited as authority in other reconsideration cases helping to clarify the definition of a meaningful return to work after a work-related injury.

Anita Faye Overcast and Gary Layne Gannon vs. Kenneth Greg Fowler, M2006-01889-CDA-R3-PT, I represented the Mother and Stepfather in a termination of parental rights case in which the trial court of Bedford County Chancery Court the Honorable J. B. Cox, terminated the parental rights of the Father based on the ground of abandonment due to willful failure to visit and support the minor child which would have allowed the stepfather to adopt the minor child. Between the ruling of the trial court and oral argument in the Court of Appeals, the Tennessee Supreme Court decided the milestone case, In Re: A.M.H, 215 S.W.3rd 793 decided on January 23, 2007 which provided that if a parent has filed any pleading actively pursuing visitation or custody of the minor child, then the parent's rights shall not be terminated for willful failure to visit. Our case was one of the first heard after the Tennessee Supreme Court ruling by the Court of Appeals. It was a tremendous learning experience for me to see the faces of the sitting Court of Appeals Justices and to hear their comments, particularly, Connie Clark, when they were bound by a new ruling of the Tennessee Supreme Court despite the facts in evidence that the Father had clearly abandoned the child pursuant to case law at the time of the hearing in the trial court.

Although this decision was devastating to my client and minor child, I was able to witness firsthand the difficult task of applying the case law, which is ever changing when it is not agreeable to the overall facts of the case.

World Association for Children and Parents National Council for Adoption and Jennifer Terhune vs. Torry Hansen and Nancy Hansen, Juvenile Court, No. 38-202. In the Spring of 2010, I represented the Mother, Torry Hansen, in the Juvenile Court of Bedford County when the maternal grandmother of the child arranged to fly her adopted son back to Moscow, Russia after he became violent and a threat to Ms. Hansen and others in the household. There were numerous issues concerning the adopted child that were not disclosed to Ms. Hansen prior to the adoption. This case drew international media attention most of which descended on our small town of Shelbyville, Tennessee. Rather than subject my client to numerous requests for interviews from Ann Curry, Oprah, Larry King, and other national and local news stations, I decided it was in her best interest to decline the interviews and focus on preparing her defense to the filing of a Petition for Dependency and Neglect. We were successful in the hearing, but the adoption agency appealed the case to Circuit Court, and Ms. Hansen substituted counsel several times after my representation.

I have served as a mediator in numerous family law cases. I am not a certified Rule 31 mediator,

but many of my colleagues have asked me to mediate their cases. I have enjoyed success in several of these mediations.

I practiced law for twenty-one (21) years and nine (9) months before receiving the first formal board complaint filed against me on July 21, 2017, File No.: 52829-4-ES. The complaint is currently pending and I am confident it will be dismissed. The complaint arises from my representation of a client in a divorce proceeding involving a twelve-year old child. The client was seeking to be designated as the Primary Residential Parent of the minor child based upon his Wife's use/abuse of prescription pain medications. The Court designated the Wife as the primary residential parent and my client received alternate residential time with the minor child in the amount of 145 days per year. He was dissatisfied with the result and filed a complaint with the Tennessee Board of Professional Responsibility.

The Seventeenth Judicial District consists of Bedford, Lincoln, Marshall and Moore counties. There are two Circuit Judges and one Chancellor in the District. Judge Forest Durard primarily hears criminal matters. Judge Lee Russell, who is retiring, hears the majority of the civil matters as well as felony criminal matters. The civil matters consist primarily of domestic cases, and personal injury, health care liability, breach of contract and commercial disputes. I can transition from a practicing attorney to the bench due to my extensive practice in the circuit court. While all new endeavors require an adjustment, I believe I will have the ability to be fair, objective and concise in rendering decisions.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes, I will uphold the law even if I disagree with the substance of the law. One example that comes to mind is in regard to payment of child support arrears by a father who has been denied the ability to form a relationship with the minor child due to the mother's failure to timely notify the father of his paternity or interference in the relationship. While there have been cases in recent years to assist fathers with this defense, there were many years of my practice that I had to deliver bad news to clients of the enormous amount of child support arrears they were facing after the mother sought to set support of a child near the age of majority. Additionally, I do not agree that payment of court ordered support directly to the receiving parent should be considered a gift if it was not sent to the receipting unit. I will uphold the law in spite of my disagreement as I have throughout my years of practice.
