
**ORDER GRANTING MOTION TO WITHDRAW AND FOR SUBSTITUTION OF COUNSEL**

This matter came before the court on 21 March 2025 upon the motion of Dana Crosland McLendon III to withdraw and to substitute Cayley Turrin as counsel for Dr. Katie Spirko. Present before the court were all counsel of record and Zach Adams. In opposition to this motion, the State had filed a *Motion to Clarify the Record*.
