I have handled (opened and closed) over 3000 files in my office over the last 17 years. Those cases were mainly in General Sessions, Circuit, Chancery, Federal, and administrative Courts in East Tennessee. I have been admitted *pro hac vice* to assist in cases in Virginia. I have been involved in at least 35 cases in the Court of Appeals and Court of Criminal Appeals. Of those cases, at least 9 resulted in reported opinions. I have been involved representing appellant, appellee, or amicus in 4 cases before the Tennessee Supreme Court. I have been involved in 2 cases in the 6th Circuit Court of Appeals. I have filed one application for permission to appeal to the United States Supreme Court that was not granted. I have tried over two dozen civil and criminal jury trials. I have handled appeals for discharged state employees through the administrative process and all the way to Chancery Court in Davidson County. I have represented three water utility districts as retained counsel for grants or litigation. I routinely write wills and deeds. I have represented clients in litigation in will contests, declaratory

judgments in probate and other issues, criminal cases, personal injury cases, worker's compensation cases, debt cases, civil rights cases, retaliatory discharge cases, violations of city ordinance cases, landlord/tenant cases, social security disability cases, Tenncare claims cases, wrongful death cases, boundary line dispute cases, ERISA cases, divorce cases, nuisance cases, dependent/neglect and termination of parental rights cases, adoptions, restrictive land covenant cases, wildlife and fish cases, alimony cases, child support cases, child custody cases, right of way cases, class action cases, credit life and life insurance cases, partition cases, and several more.

9. Also separately describe any matters of special note in trial courts, appellate courts, and administrative bodies.

I have a little niche carved out for myself in the area of probate litigation and specifically will contests. I have handled over a dozen will contests, or suits over wills, and have never lost one. A very few days ago the Tennessee Supreme Court reversed a jury verdict of mine and Attorney Denise Stapleton in *In re: The Estate of Raymond Smallman* (no SW cite yet available). The case was remanded for a new trial based on evidentiary issues. The case is noteworthy because it is one of the few cases ever tried in Tennessee where a marriage has been challenged after the death of one of the parties. The case will have precedential value once it is finally concluded.

I also, along with my brother, W. Lewis Jenkins, Jr., wrote an amicus brief to the Tennessee Supreme Court for several of the non-lawyer general sessions judges back in 1998. The style is *City of White House vs. Whitley*, 979 SW 2d 262 (Tenn. 1998). The Supreme Court followed part of our argument that non-lawyer judges could continue to incarcerate criminals if the defendants waived the fact that the non-lawyer judges were not "learned in the law" as required by the Constitution.

I was also involved, with others, in the Tennessee Supreme Court case *In re: Estate of McFarland*, 167 SW 3d 299 (Tenn. 2005), which is a precedent holographic will/anti-lapse statute case. We lost in the Supreme Court, but the legislature thereafter enacted a statute, T.C.A. 32-3-112, which makes our theory of the case the present law in our state.

I am presently involved in *McCoy vs. Bales*, E2012-02503-COA-R3-CV, which is a novel case in which a boundary line dispute was tried to a jury in Chancery Court (Hancock County). The jury adopted my surveyor's plat as the correct line, and the McCoy plaintiff has appealed.

I have successfully handled high profile criminal cases, as retained counsel, involving everything from embezzling hundreds of thousands of dollars to murder. I will not mention the styles of those cases herein as I understand this application is public.

This is a representative sample of some of my highlights and hopefully will give you an idea of the range of my experience.

I substituted as General Sessions Judge for the late Judge David L. Brand, Hawkins County General Sessions Court. I have also substituted as Juvenile Judge for John Anderson and Herbert Holcomb, Hawkins County Juvenile Court. I have done so probably on about a dozen or more occasions.

11. Describe generally any experience you have of serving in a fiduciary capacity such as guardian ad litem, conservator, or trustee other than as a lawyer representing clients.

I have served as guardian as litem for minors, incompetent adults, and missing and unknown heirs. I have been attorney ad litem for a ward of the court on one occasion. I have been appointed administrator of two estates at the request of the Bureau of TennCare. I have also been appointed by the Court as administrator of several estates to either administer them or accept service of process for a deceased tortfeasor.

I practice law in a small town where I grew up and married. I know a lot of people. My wife and I are related to a lot of people. This has given me an unbelievably large network of folks to bring or refer cases to me. I have never specialized in any area of the law, but my situation has allowed me to have exposure to many, many different types of cases from run of the mill probate, personal injury, worker's compensation, criminal defense, products liability, domestic, and administrative law – to complicated will, trust, injury, major crimes and even a few tax issues. My familiarity with these many areas of the law gives me a good basis to handle not only the everyday matters that come through Chancery Court, but also the most complicated.

I want to use my range of experience to benefit others. I want to help people who find themselves as litigants in our legal systems to be treated fairly, and to *feel* that they have been treated fairly.

I have never sought recognition for my pro bono work. Because of the nature of my practice, I advise the folks who can't pay, or can't pay much almost every day. I want badly to ensure that they have access to the legal system regardless of their ability to pay what the service may be worth. I also routinely do court appointed criminal work without seeking compensation.

I am applying to be Chancellor for the 3rd Judicial District. This district consists of Greene, Hamblen, Hancock, and Hawkins Counties. This position is the only judge over the Chancery Court for the 3rd Judicial District. I am in all the above named counties on a monthly, if not weekly, basis actively practicing law.

I have tried bench trials and jury trials in all 3rd Judicial District Counties. I know and have a good working relationship with all the clerks and court officers. My selection would provide an accepted and smooth transition from former Chancellor Frierson to the next Chancellor.

I understand all the competing interests that come before the Chancery Court. I know how to treat them all fairly. I have been through the legal "trenches" with all of them: husbands, wives, children, heirs, victims, perpetrators, business persons, employees, the injured – all of them. I know generally what they expect, what they think is fair, and what really is fair in most any case that might make it way in Chancery Court.

I am a member of the Rogersville/Hawkins County Chamber of Commerce, the Rogersville Heritage Association, the Hawkins County Farmer's Cooperative, the Masonic Lodge and Choptack Baptist Church. I intend to remain on the boards if I can do so without violating the Rules of Judicial Conduct. I am also involved with youth sports and school activities with my

I have been accustomed to hard work since I was a child. I grew up on a farm. I worked at a bank after college and while in law school. I presently own and manage a family farm. I am a father to four children. I am an avid historian and genealogist. All the above give me a well rounded and in-depth understanding of people from all walks of life. I believe I can use all those things together and manage the matters in Chancery Court for the 3rd Judicial District effectively. I can also do so in a manner that leaves the litigants and lawyers that come before me with the feeling that - though they may not completely prevail - they have had their day in court and were treated fairly by one who understands their situation.

40. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. All lawyers deal with the conflict between their own beliefs and a law or situation repugnant to those beliefs. A couple of examples for me are I once argued in the Court of Appeals that a mother was wrong for not wanting my client to take her child to a sports bar. In reality, I more or less agreed with her stance on drinking, but I argued the legal position of my client. Also, many times in criminal cases I have been faced with situations repugnant to me personally; however, it was necessary for me to discharge my duty to my client by ignoring the repugnant situation and arguing the facts and law of my client's case. Often times in voir dire in criminal cases I ask the jury not to judge my client on their personal beliefs but on the law that judge charges them. This is necessary for the system to work.
