will also ensure that all attorneys and litigants are treated with respect, and that all cases are decided fairly and impartially.

I have always aspired to become a judge, and I have the knowledge, experience and skills to serve the 10th Judicial District and the State of Tennessee.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. *(150 words or less)*

Circuit Court for the 10th Judicial District consisting of Bradley, Polk, McMinn and Monroe Counties. There are two (2) Circuit Court Judges in our district that hear only civil matters. One judge, Lawrence Puckett, is retiring and this is the judgeship vacancy that I am seeking to obtain.

The Circuit Court Judge adjudicates a wide range of civil matters including torts, contract disputes, domestic relations, business disputes, labor and employment, real estate, will contests and the like. I have handled all of these types of civil cases, and my litigation practice has well prepared me to serve as a judge. Judges must also have strong research and writing skills, and I have these skills.

A judge must have legal knowledge, analytical abilities, good judgment, communication skills, legal experience and high ethical standards. These are the qualities considered by Martindale-Hubbell in rating a lawyer's abilities. I am rated "AV Preeminent."

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. *(250 words or less)*

Yes, I will most definitely uphold the law, regardless of whether I personally agree or disagree with the common rule of law and/or the laws enacted by our General Assembly. This is absolutely essential in our judicial system.

On October 1, 2011, Tennessee's General Assembly enacted a statutory cap on noneconomic damages in all civil cases as part of the Tennessee Civil Justice Act of 2011 (hereinafter "the Act"). The Act altered Tennessee common law. I understand and respect the public policy reasoning that served as the basis of the Act. However, there is a debate as to whether, in rare circumstances, there should be limited exceptions to the cap to fairly and adequately compensate those most seriously injured.

In early 2012, shortly after this legislation was enacted, a young man was tragically killed in a motor vehicle accident due to the negligence of another driver. He was survived by a spouse and three (3) minor children. I represented this family in a civil action. In my view, due to the unique circumstances, the amount of noneconomic compensation that my clients were entitled to receive under common law far exceeded the statutory cap.

However, Tennessee law maintains that our General Assembly can change common law by statute, and that there is a strong presumption that Acts passed by the legislature are constitutional. As opposed to challenging the constitutionality of the noneconomic damages cap, my clients and I followed the law as written by our legislature and the civil matter was resolved.
