I am a general practitioner who practices in a wide variety of subject matters. The breakdown of my practice would be as follows: Criminal Defense 40%, Domestic/Family Law 20%, Personal Injury 15%, Probate & Estate 10%, General Civil Litigation 10%, Governmental Work on behalf of Coffee County 5%.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

Since becoming licensed in 2013 I have practiced at every level of court in Tennessee. This would include cases in General Sessions all the way to the Tennessee Supreme Court. All of my jury trial experience has been in the area of criminal law. I have handled misdemeanor cases as well as felony cases including multiple murder, attempted murder, and other A felony cases. I have also represented criminal defendants in front of the parole board.

Along with my criminal practice, I have tried numerous divorce/custody cases involving child custody and division of assets in both the General Sessions Courts and Circuit Courts in many counties across southern middle Tennessee. I have tried bench trials in personal injury cases as well as other civil litigation cases. Aside from my trial and litigation experience, through mediation and negotiation, I have settled numerous cases in the areas of divorce and custody, will contests, personal injury, business disputes and others.

I also regularly practice in Chancery Court and have handled numerous probates, will contests, and partition actions.

I have argued in front of the Tennessee Court of Appeals or Tennessee Court and Criminal Appeals approximately five times as well as the Tennessee Supreme Court on one occasion.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

State v. Terry Ashley – Successfully defended an attempted aggravated burglary in a jury trial resulting in conviction of a lesser-included misdemeanor offense and a not guilty on all felony charges. State v. Terry Ashley, Coffee County Circuit Court Case 41,945.

State v. Leon Holmes Jr.- Attorney Eric J. Burch and myself successfully defended Mr. Holmes during a 2-day jury trial in which he was acquitted of two counts of attempted first degree. State v. Leon Holmes Jr., Coffee County Circuit Court Case No. 42385.

In Re Cumberland Bail Bonding - I argued successfully to the Tennessee Court of Criminal Appeals in a case involving a unique question regarding the applicability of local rules to bonding companies. The Tennessee Supreme Court granted review. I was unsuccessful at the Tennessee Supreme Court however; the case clarified the relationship between the statutes regarding bail bonding law and the application and scope of local rules. <u>In Re Cumberland Bail Bonding</u>, 2019 WL 1076887 (Tenn. Court Crim. App. 2019); <u>In re Cumberland Bail Bonding</u>, 599 S.W.3d 17 (Tenn. 2020)

During law school, I had the opportunity to clerk for Circuit Court Judge Buddy Perry of the 12th Judicial District. During that time, I provided legal research, prepared briefs and legal memorandum, including appropriate suggestions and recommendations for Judge Perry, and conferred with Judge Perry concerning legal questions and construction of court documents. Most importantly, I was able to see what it took to be an effective Circuit Court Judge from a "behind the scenes" perspective. These practical observations and lessons including organization, attention to detail, and temperament have been invaluable in my law practice.

I am applying for this position because I want to use my education and experience to serve the people of Coffee County. I believe I have the temperament, knowledge of the law, experience and leadership skills needed to effectively and efficiently resolve the disputes that would come before me. The judicial system can be a very overwhelming experience for litigants. I would strive for my court to be a place where each litigant would be able to have their cases timely heard and decided based on the facts and the law only.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

The 14th Judicial District is a single county district with two circuit judges who also have chancery jurisdiction. Each judge hears every type of case for which they have jurisdiction whether that be through original jurisdiction or appeal from a lower court. I believe my active practice in essentially every aspect of the court would allow for continuity of the court. While it is impossible to be an expert on each subject, my diverse practice experience would lend itself to a shorter learning curve. My familiarity with each practice area would allow for me to keep the court efficiently hearing and disposing of cases. Further, with the huge challenge that our state and nation has faced with Covid-19, I believe that my leadership and organizational skills would help steer the court through the hopeful end of the pandemic as well as the large backlog of cases.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

In my view the number one role of a judge is to uphold and apply the law as written. The judicial branch of government is separate and apart for a reason and it is not within the role of a judge, especially a trial court judge, to attempt to legislate from the bench. The main scenario in which this comes to mind in my practice is with Tenn. Code Ann. 55-5-504. This statute makes driving on a revoked license either a class B misdemeanor or a class A misdemeanor. The criminal dockets are filled with individuals charged under this statute. Almost all of defendants' licenses were revoked for not paying fines or costs related to minor driving offenses. These people then lose their ability to go to work or school legally because in rural areas there is no mode of public transportation. By prosecuting and placing these folks on probation or in jail, it only makes the goal of getting their license back more unattainable and it becomes a cycle. However, although I disagree with substance of the law, I have advised many clients to plead guilty because just not agreeing with a law is not a valid defense. Due to the nature of the charge, it is a very easy case for the State to prove beyond a reasonable doubt. However, even though I disagree with the law, I would enforce the law as written and sentence individuals found guilty under the proper sentencing guidelines outlined in Tenn. Code Ann. 40-35-103.
