I am an attorney at the law firm Rogers, Duncan & North. I am a partner at the firm.

I was licensed to practice law in the State of Tennessee on October 21, 2003. My Board of Professional Responsibility number is 22963.

I have continuously practiced at my law office since my bar admission in 2003.		
From December 2007 through January 2018, I owned and operated North Properties. I operated this business individually. I owned 42 residential rental real estate properties in Manchester, Tennessee.		
I currently have North Farms at my residence in Hillsboro, Tennessee. I have Angus and Angus cross cattle and raise beef calves for resale. I purchased my first heifers in 2018.		

My law partners and I own the law office where I practice. I acquired interest in the building when I became a partner June 1, 2010. I have subsequently acquired more ownership interest in the building.

I also currently own a one-half interest in a residential property located in Manchester, Tennessee. My partner and I bought this property for renovation and resale. The property was purchased on March 19, 2019.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I have a general law office practice in Manchester, Tennessee. I estimate that twenty-five percent (25%) of my practice involves domestic relations. Approximately twenty-five percent (25%) involves estates. I handle both uncontested and contested estate matters. Approximately twenty-five percent (25%) is criminal defense. This includes clients who retain my services and clients who are appointed to me by the court. Approximately ten percent (10%) of my practice involves Plaintiff's personal injury cases. The remaining fifteen percent (15%) of my practice involves deed preparation, estate planning matters, and business related matters.

I have not included my services as a mediator in the above stated percentages. I have served as mediator in various types of cases. Also, I am the counsel for the Coffee County Children's Advocacy Center.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have tried civil and criminal matters in several judicial districts in Tennessee and practiced in the appellate courts. I have also represented clients in administrative matters.

I have tried civil cases ranging from small property dispute claims to wrongful death and medical malpractice litigation. These cases were tried in the General Session Courts, Circuit and Chancery Courts and in the United States District Court. I have tried civil cases to judges sitting as fact finders and to juries. My trial experience involves a wide range of cases.

I have tried criminal cases ranging from Class C misdemeanors to Class A felonies. My trial court practice includes jury trials and matters tried by the court. My clients are from all parts of the economic spectrum. Many of my most contested criminal jury trials involve indigent clients who were appointed to me by the court. The protection of a client's constitutional rights is extremely important to me, and I always use my best efforts to ensure that they have fair hearings and trials.

I have represented clients in both the civil and criminal Courts of Appeals. I enjoy writing appellate briefs and oral argument before the Court.

My practice has also included representing clients before administrative boards. Many times an attorney's representation of a client in a professional position will involve some disciplinary matters before an administrative board. I have represented clients before the Boards of Medicine and Nursing. I have represented clients before the POST Commission.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

One area of my practice that is increasing is litigation involving contested estate administration and estate planning documents prepared by alleged incompetent persons or secured by alleged undue influence.

These cases involved extensive trial preparation. Pretrial discovery is extensive. Medical testimony is a necessity in almost every case. Fact witness testimony is always a challenge, because it is emotional.

I have tried many of these cases in my district and other districts. Many of these cases are referred to me and my firm by other attorneys. I have also argued these cases in the appeals courts.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

One aspect of my legal career which has meant as much to me as anything has been the mentoring I have received from my law partners and other members of the bar. The legal practice requires more than knowing statutes and rules. I believe I was taught how to practice law by these people, and I am forever grateful. Clients can be effectively represented by advocates who are polite and respectful. This type of practice brings honor to the profession and often goes overlooked by attorneys.

I have had one complaint filed against me by a former criminal defendant client with the Board of Professional Responsibility. The client was charged in a three Count Indictment alleging that he sold methamphetamines and heroin on three different occasions. I was appointed to represent the person. He had fired his previous two attorneys. The District Attorney General chose to sever the counts, and the first case was getting close to trial. My client and I were discussing the last plea offer made, and we were going through his potential sentences if he was convicted. The client was not happy with me.

He filed a complaint against me, and the Board forwarded it to me. I filed my response. The client filed a written statement withdrawing the complaint soon after I filed my response. The matter was summarily dismissed.

Robert D. Qualls vs. Edward North, III, No. 1999-CV-1073, Coffee County General Sessions Court. I was sued by a gentleman. I was driving to work, and he pulled out in front of me turning across my lane of traffic. He was pulling a boat on a trailer. I was able to dodge his truck, but my vehicle struck his boat and trailer. The trial judge dismissed the lawsuit.

Suzanne A. North v. Edward H. North, No. 2008-CV-624, Coffee County Chancery Court. My former wife filed for divorce against me. The divorce was granted on the grounds of irreconcilable differences. A Marital Dissolution Agreement was incorporated into the Final Decree.

<u>Edward North vs. Victoria Taylor</u>, No. 2008-CV-530, Coffee County General Sessions. My former wife and I purchased a residence at a foreclosure sale. Ms. Taylor would not move out of the house, so I filed a detainer action to have her removed.

<u>Edward North v. Bethany North</u>, No. 2020-CV-229, Coffee County Chancery Court. I filed this action for divorce. The divorce was granted on the grounds of irreconcilable differences. There was a Marital Dissolution Agreement and Permanent Parenting Plan incorporated into the Final Decree of Divorce.

I have filed lawsuits for detainer warrants and rents owed in the name of North Properties.

I have wanted to be a trial court judge in my district since my admission to the Tennessee Bar in 2003. I have tried a variety of cases, both civil and criminal. I am experienced in the practice of law and courtroom procedure. I will apply the law to the case and will do so in a manner that is fair and equitable to all involved. I believe I am qualified to hold the position, and I will uphold the dignity of the Court.

I am seeking to fill the Circuit Judge position for the Fourteenth Judicial District. The Judicial District serves Coffee County, Tennessee. The Circuit Court Judges also sit as Chancellor for the Chancery Court. The Circuit Court has civil and criminal jurisdictions. The Chancery Court has civil and probate jurisdiction. My district has two Circuit Judge positions.

I believe my broad experiences practicing in all types of Circuit and Chancery Court cases make me the most qualified candidate to fill the position. I also believe my work ethic would serve the District well.

Yes.

I am counsel for the Coffee County Children's Advocacy Center. I was a founding Board Member, and I believe in its cause. I have resigned from the Board, but I have represented them in Court proceedings for some time. One area of the law that frustrates the purpose of all the advocacy centers is the statutes and case law which allows counsel for the criminal defendant to access recorded interviews of minor children at the centers by subpoena. As counsel for my advocacy center, I feel it is being used for a criminal defendant to get access to discovery which they might not otherwise be entitled. I comply with these subpoenas, but I hold them to the letter of the law.
