My experiences have provided me with the necessary background and the desire to pursue this appointment to the bench to be that individual that works to make our legal system a place where fairness and justice are always the desired goal. I seek this position to be a Judge who values and upholds and hopefully improves our legal system.

My experiences have provided me with opportunities to participate in all aspects of litigation from the filing of pleadings, completion of discovery, the filing and argument of pre-trial motions, negotiated settlements, full jury trials and post-trial litigation. These experiences give me a solid foundation to apply the law as a Judge.

Yes.

The importance of the separation of powers is and always has been a vital part of government at the national, state and local levels. I am certainly not immune to disagreeing with certain laws. However, in my work experiences I believe I have demonstrated on numerous occasions the discipline to put aside my personal feelings or beliefs and pursue an outcome that reflects the state of the law.

As a personal example, one illustration concerning this issue is the current state of marijuana in Tennessee. From a personal standpoint, I have reviewed medical evidence that supports marijuana may have legitimate medical uses. Our state legislature as well as many other states continue to address possible changes to laws that may permit the use of medical marijuana. With competent medical evidence, I would not be opposed to legislation that adopts medical marijuana in Tennessee. However, the current state of the law in Tennessee continues to make it illegal. As a Prosecutor, my job requires me presently to continue to treat any use, possession or sale of marijuana as a criminal offense. Accordingly, I routinely resolve cases with punishment that fits within the statutory provisions of the current laws regarding marijuana. Certainly, any decision to alter the status of marijuana, or any criminal statue, needs to come from the state legislature.
