6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My law practice focuses primarily (99%) on criminal defense. Though I will occasionally accept a family law client (divorce, post-divorce, etc.) most of my caseload is criminal defense. I accept cases in both General Sessions and Circuit Court and consider my practice to be a trial practice, as I regularly conduct jury trials.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

My initial experience was gained in the District Attorney General's Office for the 31st Judicial District. As a smaller district, we were structured with vertical prosecution, meaning that the cases I individually worked in General Sessions Court were generally my cases to work if they proceeded into Circuit Court. Additionally, I was assigned cases that were direct presentments to the Grand Jury. I gained trial experience quickly. Though I tried many cases alone, I also tried cases with more seasoned prosecutors, especially on more serious charges such as murder, sexual offenses, and offenses against children. Early in my career I would second chair such cases. As time progressed. I would handle those cases alone. As a prosecutor, I tried cases including, but not limited to, misdemeanor offenses such as DUI, simple assault, domestic assault, and misdemeanor drug crimes, as well as more serious crimes, such as felony animal abuse, murder, rape, kidnapping, aggravated assault, and felony drug cases. In working those cases, I handled all aspects of the cases. I prepared my own discovery for defense counsel, prepared witnesses for trial, prepared trial exhibits, and worked with law enforcement to ensure I was able to present the best and most complete case to the jury. I maintained an excellent working relationship with the local law enforcement agencies and prepared numerous search warrants at all hours of the day or night when needed. Often, when the circumstances giving rise to the need for a search warrant led to an indictment. I would be assigned to work the case in court because of my knowledge of the case. Naturally, most cases did not proceed to a jury trial. In those cases, I analyzed the evidence in the case, engaged in discussions with defense counsel, consulted with law enforcement, and made plea offers.

When I went into private practice I focused on criminal defense. I accepted court appointed cases in every county in which I practiced. My first jury trial as a private attorney was a court-appointed Felony Murder case in October 2012, which resulted in acquittal. As a private attorney I have tried cases including, but not limited to, felony murder, attempted murder, child abuse, child sexual crimes, drug offenses, rape, and various misdemeanor crimes including DUI. I handle all aspects of the criminal cases I accept. Though I have maintained a support staff for the majority of the time I've been in private practice, I personally work each of my cases. I review the discovery, develop case theory, develop and produce demonstrative aids or exhibits, draft all motions, and communicate directly with my clients. The only third party that handles any aspect of my criminal cases is an investigator or other expert if the case requires. I have tried all of my cases alone, with the exception of two cases where an intern or another attorney in my office sat in trial with me to gain experience. In cases where my clients have been convicted

after trial, I have conducted motions for new trial, motions for judgment of acquittal, sentencing hearings, and appeals to the Court of Criminal Appeals.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

The only case I have ever been involved in that proceeded all the way to the Tennessee Supreme Court was the case of *Stanton v. State*, 395 S.W. 676, where the Court reviewed my denial of pre-trial diversion to a defendant whom I prosecuted for animal cruelty. The Court held, in a detailed opinion, that I had properly applied the law to the facts and had not abused my discretion in denying the defendant pre-trial diversion.

In Rutherford County in 2019 I jury tried the case of *State v. Crystal Adams* wherein Mrs. Adams was charged with Aggravated Assault, Felony Reckless Endangerment, and Domestic Assault. The jury convicted my client of Felony Reckless Endangerment and I filed a written Motion for Judgment of Acquittal under Rule 29. In a written opinion, Judge Royce Taylor assumed the role of 13th juror and set aside the jury verdict against my client. That is the only one of my cases where a judge acted as 13th juror to set aside a jury verdict.

I am seeking this judgeship because I believe that my experience as both a prosecutor and defense attorney uniquely qualifies me to hear criminal cases. I have spent the past 15 years engaged in criminal law and have conducted numerous jury trials before several different judges. I have handled simple matters and complex matters. I understand the issues faced by both prosecutors and defense attorneys in handling their cases and I have a strong desire for our judicial system to work efficiently and with the utmost integrity. I want to contribute to my profession in a way that can have a positive impact on the people that work in the profession, as well as those who encounter the profession. I believe that my character, work ethic, legal knowledge, and experience will be beneficial for our profession, the Rutherford and Cannon County Bar, and the people of the 16th Judicial District.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

The judgeship I seek is in the 16th Judicial District (Rutherford and Cannon County) and it is a criminal judgeship. There are three judges hearing criminal cases at the Circuit level. Because of my extensive experience handling criminal matters and conducting jury trials, my selection would be accompanied by a smooth transition, allowing the criminal dockets to continue moving in an efficient manner. I would be able to immediately begin working on existing dockets and conducting jury trials, while managing future dockets and future Grand Juries. My selection would instill confidence in the bar because I have worked hard to earn a reputation as a competent and knowledgeable criminal attorney with a strong work ethic. I am very familiar with court scheduling, court procedures, the staff of both Circuit Court Clerk offices, as well as the Rutherford County and Cannon County Sheriff's Department, who handle prisoner transport and courthouse security.

Additionally, there are laws that I believe are not well reasoned, but I accept that the law is what it is and that my duty is to uphold it as written.
