I am currently engaged in a general trial practice, with 100% of my practice devoted to criminal defense cases, both felony and misdemeanor, in State court. As the Managing Partner at my firm, I have also overseen as many 5 other attorneys whose areas of practice have differed greatly from mine.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

My practice has always been focused at the State court level, and for the first 13 to 15 years, I handled a wide variety of cases in both civil and criminal courts, including, but not limited to, divorce and family law, tort, and contracts, as well as felony and misdemeanor criminal law cases. I have handled civil and criminal cases in most counties in the Middle Tennessee area, and have had both jury and non-jury trials throughout the area. I have also had numerous Administrative Law hearings, usually in civil forfeiture cases, during my career, and I have argued cases before the TN Court of Appeals, TN Court of Criminal Appeals, and the TN Supreme Court.

The last 15 or so years of my practice have been solely devoted to criminal defense, and I have continued to try cases, both jury and non-jury, during this time.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

In State of TN v. Areanna Lloyd, M2017-01919-CCA-R3-CD, I successfully argued a motion for the Circuit Court Judge to reconsider a previous ruling against a Petition for Suspended Sentence for a young lady who was sentenced as a mitigated offender and was passed over for parole after reaching her release eligibility date. Ms. Lloyd, who was a first-time offender, was told she would have to wait almost three years before being reconsidered for parole. My client was released at the conclusion of the hearing, and the Judge's decision was upheld oon appeal.

I completed the Tennessee Bar Association's Mentor Program, and I regularly provide advice

and assistance to younger attorneys in the 16th Judicial District. I also, through the TN Association of Criminal Defense Attorneys (of which I am currently a member of the Board of Directors), host a monthly Round Table meeting, with the goals of providing practical advice and building camaraderie within the local Bar.

Several years later, Mr. Patterson sold this property, and, during the negotiation process, he alleged the neighboring property was encroaching upon his property, so he chose to sue me rather than attempt to resolve the boundary issue in Chancery Court. A previous order dismissing the case was set aside on July 1, 2003, but there has been no activity in the case since that date.

During my years of practice, I have been fortunate to have appeared before dozens of judges throughout Middle Tennessee, and the best of them all possess the same basic qualities. They are courteous to the participants and respectful of the process, they are able to listen intently to the testimony and proof presented, and, above all else, they set aside their personal biases and beliefs to render an objective decision according to the law.

I believe I possess these traits, and, if fortunate enough to receive this appointment, I will strive daily to provide all who appear before me an opportunity to be heard in a fair and impartial forum.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am applying for Judge of the Circuit Court of the 16th Judicial district, Part II, covering Rutherford and Cannon counties. Currently, Part II handles approximately one third of the criminal cases in Circuit Court, as well as overseeing the Rutherford County Drug Court, although the types of cases handled by each Circuit Court Judge and the Chancellor is determined based upon seniority. I would not expect this to change if I were to be appointed, although my experience trying both civil and criminal cases in Circuit courts throughout Middle Tennessee would enable me to step in and immediately be prepared to handle either a civil or criminal docket, including presiding over hearings and trials.

I am a firm believer that it is not the role of a judge to legislate from the bench, and that applies regardless of one's personal beliefs about the validity of a particular statute or rule. As a criminal defense attorney, I have often found myself at odds with criminal statutes, usually for the punishment associated with certain criminal offenses, but I recognize the Legislature's responsibility to enact laws to protect the citizens it represents, and on the numerous occasions when I have sat as Special Judge in the General Sessions Courts in the 16th Judicial District, I have never hesitated to sentence individuals as required by statute.
