PRIOR CAREER, 1991 – 2011

I worked in various roles in the home furnishings industry for twenty (20) years. I was co-owner of a manufacturing company. Among my various responsibilities were supply chain logistics, sales and sales management. Though primary ownership changed a couple of times, the entire venture was with the same core group of people in McKenzie, Tennessee. We expanded our manufacturing from Tennessee to Mexico where I travelled extensively for several years. I travelled to and purchased raw materials in China, South Korea, Brazil, and Argentina. At its peak, employment topped 600 and production neared 5,000 pieces of upholstered living room furniture per week.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

As an Assistant Public Defender, 100% of my practice is Criminal Defense.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

My trial court practice is extensive. Since January 2017, I am active in nearly every session of the Weakley County Circuit Court representing nearly 200 felony defendants per year. Additionally, I fill-in for other attorneys in the office during Obion County Circuit Court as needed. During my early career, I practiced primarily in criminal, family, real estate and estate law in trial level courts. In criminal law, those tasks included conducting preliminary hearings, motion hearings, and criminal jury trials, each with the associated court filings. In family law, I prosecuted and defended divorces, post-divorce custody matters, adoptions, and conservatorships. In real estate law, I drafted deeds, mortgages, and land contracts, closed loans, and litigated boundary disputes. In estate law, I drafted wills and powers of attorney, and administered estates. Additionally, I assisted clients in obtaining Social Security benefits, retaining seized property, defending eviction proceedings, forming business entities and drafting contracts.

I did not argue before any of the appellate courts but drafted both civil and criminal motions and briefs to those courts.

I represented one municipality during my private practice, but otherwise did not practice before legislative or regulatory bodies.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

With the exception of Juvenile Court, I handle all of the public defender caseload for Weakley County, Tennessee. Though General Sessions is not a "trial court," much of the "trial work" is done there. In addition to the felony defendants stated above, I represent an additional 600 defendants per year through misdemeanor cases. Many of these cases are originally charged as felonies but settled as misdemeanors. Many of my trial court cases are won, lost, or settled as a result of the work done in General Sessions.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

Though stated above, generally, I want to elaborate on my time as a Staff Attorney for a Senior Judge.

Tennessee currently has 3 Senior Judges. They are retired trial level judges appointed by the Supreme Court to handle cases across the State when the local judge has a conflict and no judge in an adjoining district can sit by interchange. When such a situation arises, the Administrative Office of the Courts assigns the case to a Senior Judge who hears the case to final disposition when feasible.

The cases assigned to a Senior Judge are usually difficult and complex; cases that last for years, sometimes decades, cases where the District Attorney may be the plaintiff or cases in which the Sheriff may be the defendant, cases where an attorney wants his license restored after it has been revoked for years. These cases, in other words, are those that no judge wants to hear.

I coordinated with attorneys from around the country and prepared these difficult cases for trial with the direction of an experienced judge. I would describe the position as on-the-job training for a potential judge. I conducted scheduling conferences and drafted scheduling orders. I read, analyzed and drafted orders on complex and numerous motions. I literally sat at the bench next to the judge during hearings and trials. The experience was priceless.

I applied for the Chancellorship of the 24th Judicial District. The Trial Court Vacancy Commission selected me as one of the three candidates to interview with Governor Lee.

ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

I hope to become the 3rd generation of judges in my family. I was approached to seek this position in the 2022 election long before Judge McGinley announced his retirement. My wife, Sarah, and I are committed to work through this process and I plan to seek this position now and at the upcoming election.

Further, if I am appointed as Circuit Judge, it will be the result of decades of preparation. I spent 4 years in the military and 20 years in manufacturing before beginning law school at age 40. I realize how years of interactions with the people of this district impact me and my ability to relate to them. My 10 years in practice round off a lifetime spent in rural West Tennessee. I will be honored and humbled to serve as a judge for 24th Judicial District.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I seek the appointment to Circuit Judge, Part One, for the 24th Judicial District encompassing Benton, Carroll, Decatur, Hardin and Henry Counties. The district stretches over 100 miles along the Tennessee River in West Tennessee. The District has two Circuit Judges distinguished as Part One and Part Two with no geographic restrictions. However, for several years, the Part One Judge presides in Benton, Decatur, and Hardin Counties and the Part Two Judge presides in Carroll and Henry Counties. The 2019 fiscal year filings indicate over 92% of circuit court filings were criminal cases.

COVID-19 caused a tremendous backlog in this court. My criminal law experience as well as my practice outside the district will allow me to begin trying cases nearly immediately. I have no conflicts of interest with any potential defendants and expect a smooth transition to the bench.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes, I will uphold the law. As a criminal defense attorney, I explain to my clients very often that, "I don't like it, but it's the law." For example, I don't agree with the law that denies a DUI offender the right eventually to have his record expunged, if that offender would otherwise qualify. But I advise my clients of that consequence because it's the law. Conversely, I believe that the punishment for violent crimes, particularly those involving entering someone's home, are too lenient.

I find it disconcerting that many attorneys are zealous to defend 1st and 2nd Amendment rights cases yet disparage those willing to defend the equally important 4th, 5th, and 6th Amendment rights. I commit to uphold the law through the lens of fairness and impartiality notwithstanding my personal views.
