I was appointed as the Third Judicial District Child Support Magistrate in 2010 to serve for several months, during the medical leave of the prior magistrate.

I worked under contract for the firm of McHugh Fuller, a Mississippi law firm, concentrating in nursing home litigation and received extensive experience working in the courts of West Virginia, Mississippi and Tennessee.

I was an associate of Foster & Flohr, Attorneys at Law, a firm in Greeneville, Tennessee, from 2005-2007.

Immediately after graduating from law school, I worked at Petkoff and Associates, a law firm in Memphis, TN.

I have maintained my real estate license as a broker with Greeneville County Land and Auction.

I am also a Tennessee Rule 31 Licensed Mediator, and was licensed in 2012.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

The nature of my present law practice is primarily domestic relations cases which include divorce, adoption, termination, legitimization, and dependency and neglect matters. This makes up approximately sixty percent my practice. I also do other civil litigation including personal injury, nursing home litigation, and litigation related to real estate and probate matters. Those categories make up approximately twenty percent of my case load. Fifteen percent of my case load consists of class action litigation in the recent opioid cases and contract disputes and the remaining five percent is criminal law.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I started my practice at the above listed firm, in Memphis Tennessee, doing insurance defense in Shelby County Circuit and Chancery Courts. The concentration was primarily defending local governmental entities and aviation defense. Since relocating to East Tennessee, I regularly appear in the Juvenile, Sessions, Circuit and Chancery Courts around East Tennessee, concentrating in domestic relations. I have argued several appeals in the Eastern District Civil Court of Appeals for Tennessee. In 2009, for approximately four years, I worked under contract with the firm of McHugh Fuller, concentrating in nursing home litigation during which I received extensive civil experience in the courts of Tennessee, Mississippi and West Virginia. I am admitted to practice in the Federal District Court for the Eastern District of Tennessee. I am also co-counsel with attorneys from Tennessee and other states in the present opioid litigation and have filed complaints on behalf of counties in Tennessee in the Eastern, Middle and Western District Courts. I have also been admitted to practice before the United States Supreme Court. I have filed with co-counsel claims in the Tennessee Claims Commission relating to medical

malpractice and nursing home litigation.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

Hawkins County Humane Society v. Hannah Speaks, et al. (2017 Hawkins County Circuit Court). I represented the Hawkins County Humane Society against several individuals alleging false, harassing Facebook posts that placed the managers licensed at risk and almost caused the facility to close. The matter was tried before a jury and a successful plaintiff's verdict was obtained. Throughout this process, I defended the director and veterinary technician before the comptroller's office and the state licensure board.

In RE: K.F.R.T., 493 S.W. 3d 55 (Tenn. Ct. App. 2016). I represented children on behalf of the guardian ad litem in an appeal of a termination proceeding. There were four children involved in the case, and the trial court granted the termination as to one child and denied it to the other three. I appealed for the guardian ad litem, pro bono, after the guardian was informed that the Department of Children's Services would not seek an appeal of the ruling. The Court of Appeals reversed the trial court's ruling and granted the termination as to all four children.

In RE: Landon T.G., 2016 WL 890219, No. E2015-01281-COA-R3-PT (Tenn. Ct. App. March 9, 2016). I represented a mother requesting to set aside an adoption after three years because she was not given proper notice of the initial proceedings. This was a case of first impression which was at the Court of Appeals, at the same as the *Turner v. Turner* matter.

Napier v. Howard, 516 S.W. 3d 477 (Tenn. Ct. App. 2016). I represented the adjoining landowners in a declaratory judgment action, defining the difference between a camper trailer and a single wide mobile home. I was successful at trial in the Chancery Court of Jefferson County. The Court of Appeals upheld the Order.

I am privileged, along with other counsel, to be presently representing thirteen Tennessee counties in the nationwide opioid litigation. As part of my commitment to that litigation, I was nominated by the Greene County Mayor to be a part of the "Tennessee Faces" campaign, giving insight to the epidemic and opioid addiction. Being a part of the ongoing litigation, I have gained extensive experience in working with counsel throughout the United States in pursuing a nationwide solution to a problem that hugely impacted East Tennessee.

A complaint was filed with the Tennessee Board of Professional Responsibility by my exhusband, James R. Klumb, on May 21, 2013, Case Number M2014-01989-SC-BPR-BP. Prior to filing for divorce, I placed a monitoring system on what I believed to be a marital computer. I was not acting as an attorney and had placed the system on the computer to monitor my stepson, who had recently been caught with marijuana. My ex-husband sued me in federal court, as listed below in paragraph 22. I agreed to a conditional guilty plea on March 31, 2014, which the Court approved and I was publicly censured. The public notice set forth that I was publicly censured, but did not affect my ability to practice law.

A complaint was filed with the Tennessee Board of Professional Responsibility in 2009, File No. 31548-1-KS, right after I left the law firm of Foster & Flohr and started my own firm. When I was a member of the Foster & Flohr Law Firm, I had a contract with the City of Surgoinsville and the Surgoinsville Water Department as an employee of Foster & Flohr. When I left to start my own firm the board voted to retain me, however, neither the Foster & Flohr firm, nor I updated the written contract. Both Foster & Flohr and I received appropriate fees for the contracts for the time I worked. I received a private letter of reprimand for not updating my employment retainer.

A complaint was filed with the Tennessee Board of Professional Responsibility in 2009, File No. 32391-1-PS, by an appointed client. I was relieved of representation by Chancellor Frierson on January 13, 2009. The file was transferred to Mr. John Anderson as her new attorney. I in no

way impeded the representation of the client and the same was dismissed.

A complaint was filed with the Tennessee Board of Professional Responsibility in 2012, File No. 34860-1-PS by a client that settled his case at mediation but refused to pay the mediation fees when same concluded. He also refused to sign the Order finalizing his case, which delayed same. This matter was dismissed.

A complaint was filed with the Consumer Assistance Program, by an opposing party in 2019, Complaint Number 59592c-1. My social media account was hacked and had to be shut down after sending out friend requests to over two thousand individuals. The lady in question received a friend request prior to my representation of her ex-husband and involvement in the case. This mater was dismissed.

A complaint was filed with the Consumer Assistance Program, in 2018, Complaint Number 56910c-1, by a lady that I had a telephone consultation with, but never paid a fee or signed a contract. She complained because I refused to represent her. The same was dismissed.

I have always been interested in political issues and people working closely with the government. I was impressed by the concept of how a judge actually helps people resolve their differences, without violence, which occurs in other parts of the world. The judge and jury system, I believe, is one of the main foundations of our system of government and why it has survived for so long. I see a need in the Third Judicial District to improve the way families resolve conflict and overcome their problems. I believe the Third Judicial District is in need of an enhanced drug court, veteran's court, and a court clinic to improve the delivery of justice and more efficiently resolve conflict. I have concentrated my practice in these areas and researched the availability of grants. I believe I am the best candidate to implement change.

I am applying for Circuit Court Judge, Part II, for the Third Judicial District, which encompasses Greene, Hawkins, Hamblen and Hancock Counties. The counties are very different in their school systems, employment and social-economic cultures. There are three Circuit Court Civil Judges, one Circuit Court Criminal Judge and one Chancellor. Other than the criminal dockets in each county, the civil courts primarily hear domestic related cases. Given my practice concentration in civil litigation, and domestic law matters, I have the background that is needed to fill the position. A review of the appellate docket reflects that there are a substantial number of termination/adoption cases. Because of my experience I believe that I can work with the other judges in the district to modernize and focus the docket, as it relates to domestic matters. Having practiced across the state, I have the experience and ideas necessary to serve as Judge.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I will uphold the law, even if I disagree with the substance of the law, with the understanding that there are rare times when constitutional issues may occur. For example, I represented a woman who lost her children in an adoption proceeding three years prior to my filing a complaint alleging that she had not received proper notice of the proceedings. The status of the law was very specific as to notice, with no regard to the children's best interest or the length of time the Order had been entered. The trial court would not overturn the order and denied my petition. The Eastern District Court of Appeals reversed the trial judge and set aside the order of adoption. A similar case, at approximately the same time, was decided by the Tennessee Supreme Court saying notice must be followed, but under certain very specific circumstances, the Court could consider the length of time and the reliance on the original order of adoption. As one can see, a trial judge would be faced with having to completely disrupt a family that adopted the child based upon the existing law and yet be very concerned about the impact on the child/children involved. A good advocate was able to convince the Supreme Court in Turner v. Turner, to add some additional factors to be considered. All the parties were faced with upholding the law as written, while being concerned with the impact it would have on the children, parents and families.
