6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I am in private practice with a concentration in business and estate law. The small fraction of my practice in other areas are normally related to my client relationships in business and estate law.

Although I no longer concentrate on criminal law matters, it is my duty to stay engaged on the appointment schedule to serve indigent clients at the appointing judge(s) discretion.

My current practice focuses are as follows:

Business, Civil Law and Litigation: 45%

Estate Law, Planning, and Litigation: 45%

Family Law: 5%

Criminal Law: 5%

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

Early in my practice, I was focused more on criminal and family law. The growth of my practice allowed me to gradually shift from those areas to concentrate on business and estate law. Today, my primary focus is on business and estate related matters. Throughout this process, I have appeared in municipal, general sessions (criminal, civil, and probate), circuit and chancery courts from Bluff City to Huntingdon Tennessee.

I have appeared and argued appellate matters in both the Middle and Eastern districts of the Tennessee Court of Appeals and filed briefs on behalf of clients in the middle district of the Tennessee Criminal Court of Appeals.

My practice has led me to represent clients in administrative hearings including VA disciplinary hearings, professional boards and Department of Safety seizure hearings as well as representing police officials involved in use of deadly force situations.

I currently represent and have represented local, state, and national business clients in judicial, non-judicial and regulatory forums related to significant monetary transactional disputes, tax litigation, and employment matters.

During this period, I have learned varying local rules and observed courtroom demeanor both from the bench and the bar.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

In the criminal trial court, I represented a young man charged with Attempted First Degree Murder in which the evidence overwhelmingly supported the charged offense. A significant review of the case and thorough interview of witnesses revealed a lifelong struggle with severe mental illness. A circuit court bench trial resulted in a verdict of not guilty by reason of insanity.

In the appellate court, I successfully argued for an interlocutory appeal before the McMinn County Circuit Court and subsequently, the Court of Appeals for the Eastern District of Tennessee. This was a complex financial services case involving my client versus two (2) national corporations and a Tennessee citizen. This case involved conflict of law questions as well as asking the courts to apply the law of a foreign jurisdiction regarding financial transactions in our state.

I represented a corporate client in achieving their certificate to operate from a very resistant regulatory authority after the board had denied their application and prohibited my client from reapplying. My client was granted the certificate after several hearings and discussions with counsel for the board.

Administratively, I have represented police officers in multiple jurisdictions following use of force/deadly force situations. In each case, the officers were found to have acted appropriately and to my knowledge, still serve today.

Prior to, and throughout law school, I was employed full-time as a Detective Lieutenant with the Rutherford County Sheriff's Office. During my twenty-year tenure, I served as a patrol officer, narcotics detective, robbery/homicide detective, Detective Sergeant, SWAT team Lieutenant, Narcotics Lieutenant and Detective Lieutenant. During my tenure, I was nominated and selected to attend elite training from coast to coast. This included the Drug Enforcement Administration/Oklahoma Bureau of Narcotics Marijuana Investigators course, the first ever Advanced SWAT School hosted by the Los Angeles County Sheriff's Office, and the 226th Session of the F.B.I National Academy.

I was privileged to obtain countless certifications and routinely taught police personnel proper law enforcement procedures. On a regular basis, I presented classes and demonstrations to the attendees of our Citizens Police Academy as well.

On multiple occasions, I have been appointed as a special judge in the Rutherford County General Sessions Court, (Criminal Divisions). It is an honor to be asked and a privilege to serve in this capacity. As such, I have presided over countless cases from speeding citations to preliminary hearings charging various criminal offenses.

Perhaps to a lesser "legal experience" degree, I have served as a judge during state mock trial competitions. It is rewarding to see the interest and enthusiasm the students express for the practice of law.

I am seeking this position because I want to continue to serve my community. A judge is, above all, a public servant held to the highest of standards in applying the law ethically and impartially. I have dedicated my entire professional life to the law and the legal profession using the identical standards as my foundation. The diversity of my professional life and commitment to these standards uniquely qualify me to serve as a Circuit Court Judge. Moreover, this is the greatest contribution I can provide to the community that I was raised in and am very much a part of today.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking the judgeship for the Circuit Court in the 16th Judicial District. Our district is comprised of Rutherford and Cannon counties. Rutherford County is recognized as one of the fastest growing areas of our state in terms of population and commerce. Cannon County is a smaller community of rolling farm land and tradition of good folks.

The circuit combined presents civil cases varying from property disputes to major corporate issues. As with many jurisdictions, this circuit also hears a number of family and estate related matters. Similar also to many jurisdictions, this circuit hears criminal matters ranging from misdemeanor driving offenses to major felonies.

The circuit is comprised of four (4) circuit judges and a Chancellor. Having grown up, gone to school, and served the community for most of my life I understand the faith and confidence people have in our judiciary to be treated in a fair, impartial and courteous manner.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. The judiciary requires, (and our community expects), a judge that will uphold the law without consideration of his/her personal feelings regarding the legal matter before them.

During my law enforcement and legal career, I have demonstrated the fortitude to act in a manner consistent with what my oath and the law expects of me. As a judge, I will continue to apply the law without regard to any personal feelings I may have as to the substance of the law applicable to the matter before me.

Candidly, I cannot recall a specific example because my duty has been to be "one sided" for my client's benefit. However, one of the more challenging, (and beneficial), responsibilities for me was reversing my role as a twenty-year prosecutor of criminal offenses to one defending those charged with criminal offenses. Although this does not equate to upholding or enforcing a law that I may not personally agree with, it is an example of my commitment to afford all persons fair and impartial access to justice.
