I am a general practitioner who practices a wide variety of subject matters. The breakdown is as follows: Personal Injury 75%, Criminal Defense / Civil Rights 15 %, and Family Law 10%.

Since becoming licensed in 2011, I have practiced law consistently in State and Federal Courts in Tennessee. I have tried approximately eight (8) cases to a jury verdict as lead counsel and many more as second chair. I have tried three (3) jury trials to verdict since the Court's reopening for jury trials since the beginning of the pandemic.

Early on in my practice, I had numerous hearings and bench trials in Juvenile Court through to the Court of Appeals. I have tried numerous divorce cases in Circuit and Chancery Court. I have handled sentencing hearings and plea agreements in Criminal Court. Today, my practice is primarily personal injury work, however, I am familiar with inner workings of the criminal courts throughout Tennessee.

Aside from trials and hearings, I have resolved numerous cases through negotiation and/or mediation. I have an active cases load of about one hundred (100) cases at any given time throughout my practice.

I am applying for this position because I want to use my education and experience in the Court system to help the community of Hamilton County. I believe that I have the trial experience as a practicing trial lawyer to handle evidentiary and procedural issues from day one. I understand from my time as a Municipal Judge that the legal system can be overwhelming for individuals and it is important for a Judge to be patient and informative to make sure that people get a fair outcome through the legal process.

The 11<sup>th</sup> Judicial District is a single county district with three Criminal Court Judges. Each Judge is in charge of hearing both felony and misdemeanor criminal cases. Most of the time, the trials would be in front of a jury, although they could be bench trials.

In today's legal world, fewer and fewer lawyers have jury trial experience. I believe that my jury trial experience will have me ready day one for the job as Criminal Court Judge. I also have experience behind the bench with my position as Decherd City Judge for the past five years. I believe that I will bring a fair and balance approach to the bench and allow citizens of Hamilton County to have their day in Court.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

In my opinion, the Judicial Branch of Government is independent from the Legislative Branch. It is the job of the legislators to make the law as they see fit. It is then up to the judges to uphold the law as it is written, not as they see fit. If a Judge wants to be part of writing the law then he or she could certainly run for an office in the legislation. The main scenario that comes to mind in my experience as a licensed attorney is Tenn. Code. Ann. section 29-39-102 which caps the amount of non-economic damages can be awarded to an injured person. This statute can be used to go against what a jury of a person's peers determines a person is deserved due do negligence of a third party. In my practice of representing injured parties, I have seen instances where they should be awarded more than the caps on damages allow for, however, I understand what the law requires. If selected to be a Judge, I understand that my job is to follow the law as it is written regardless if I believe it is fair, just, reasonable or not. My job is to call ball and strikes within the strike zone that the Legislative Branch sets out for Tennesseans.
