I began my legal career as an associate attorney with the firm, Phillips Law, PLLC. My practice there was dedicated primarily to criminal defense, military law defense under the Uniform Code of Military Justice, and civil litigation. Specifically, I handled state level felony and misdemeanor defense cases and worked alongside lead counsel in Article 15 actions, Article 32 preliminary hearings, and court-martial cases. I also handled civil litigation cases ranging from landlord/tenant actions to domestic litigation.

I was offered an opportunity to work as an associate for a well-known criminal defense attorney, Edward DeWerff, in 2010. This transition provided me a greater opportunity to gain knowledge in the areas of criminal defense, specifically jury trial practice. While working alongside Mr. DeWerff, I assisted with major crimes defense, including homicides, drug trafficking and crime syndication. I also continued to practice in areas of civil litigation, primarily domestic relations and juvenile court work.

In 2011, I joined with a fellow practitioner, Tim Barnes, who had a well established and busy firm in Clarksville. When I began this role, I had previously been immersed in handling legal cases, but I now took on a managerial role also handling the day-to-day operations, including staffing, accounts receivables and payables, and the day-to-day aspects of a busy small firm. We handled varied cases that included larger and more complex matters.

In 2012, I joined with attorney Stephanie Ritchie-Mize in forming what is my current practice of Fry & Ritchie, an association of attorneys. She and I combined our varied talents and interests to form a firm that meets all the needs of our growing community and clientele.

I was born and raised in Williamson County, Tennessee. Although I have lived my entire life in Tennessee, I had no ties to Clarksville when I first began practicing. Many local firms have familial ties to the area. I did not have a recognizable family name, or a client base built by a prior generation. I had to acquire and utilize a skillset outside the scope of law school curriculum and the courtroom. I consider myself a lawyer and a businesswoman. In law school I never envisioned I would hang my own shingle and write up monthly budgets. I had never opened QuickBooks in my entire life. Nevertheless, I was determined to be a successful advocate for clients and a successful business owner.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I consider myself a general practice attorney focusing on litigation. The pandemic has changed the nature of my practice in a way that I never anticipated. Communication has become a greater focus and thinking outside the box has taken on a whole new meaning. I find that the versatility I now possess has broadened my expertise and allowed me to grow in ways that make me specifically adaptable to the ever-changing needs of the court.

My present practice is made up of criminal defense, domestic litigation, wills and estates, and a small amount of personal injury, juvenile court practice, and civil litigation. I apportion 35% criminal defense, 35% of my practice to domestic litigation, 20% wills and estates, and the remainder an assortment of civil litigation and juvenile court practice.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

The vast majority of my practice is litigation. Over my career I have practiced before the trial courts in Montgomery, Robertson, Williamson, Stewart, Houston, Hickman, Dickson, Cheatham, Maury, Humphreys, and various municipalities. I have performed jury trials and multi-day trials in several of these jurisdictions. Additionally, I have participated in more bench trials than I can count.

I have also appeared before the Court of Appeals, and presently have a case with a novel question of law on appeal to the Court of Criminal Appeals. Further, I was trial counsel for a case that made new law in the Tennessee Supreme Court, State v. Charlotte Frazier 558 S.W.3d 145 (Tenn. 2018). Although I did not appear before the Tennessee Supreme Court in the Frazier case, I litigated the underlying suppression issue in the trial court that formed the basis of the Supreme Court issue. I also represented this client in a seizure matter involving the Department of Safety that was related to the underlying case.

I was associate counsel for two court martial trials in the United States District Court located on Fort Campbell. As associate counsel I went through all trial preparation and performed cross-examination and direct examination on multiple witnesses in each trial. Additionally, in my own private practice I have represented clients in lesser actions involving the Uniform Code of Military Justice.

In the Middle District, I have worked with the United States Attorney's Office representing unindicted co-conspirators during the early stages of investigation on major crimes involving international drug syndicates.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

In August 2018, I litigated a first-degree murder case based on a homicide during the commission of a robbery in our Division IV trial court. The trial testimony lasted four days and the jury deliberation went from the fourth day after closing arguments until the afternoon on the fifth day. During the deliberation, the jury posed a question relating to clarification on the robbery count. The jury returned verdicts on the three-count indictment. While the jury found the Defendant guilty of second-degree murder, they did not find him guilty of robbery or any lesser included charge. Despite these findings the jury returned a verdict of guilty on the first-degree murder during the commission of a robbery. This resulted in inconsistent verdicts, an area of law that is complex and evolving. This case is currently on appeal to the Court of Criminal Appeals in the Middle District.

In 2015 I successfully defended a young woman in a Termination of Parental Rights case against the Department of Children's Services. My client was the victim of domestic abuse. Despite being physically and mentally abused at the hands of the children's father, she maintained a steady job to provide for her children. Throughout the case, she continued having a loving and close relationship with her children. The Department of Children's Services, however, pursued terminating her rights under a theory of failure to protect the minor children. During the course of my representation, I assisted her with acquiring counseling to get herself away from the abusive situation. Further, I encouraged her to better her situation by pursuing higher education and training. To this day I am thankful for the opportunity to have helped this mother and children.

While I find many practitioners shy away from this area of law, I find the opportunity to help young families to be very rewarding. As a businesswoman, advocate, and mother, I am proud to be able to offer my support to families in distress at a time when they need not only a legal advocate, but also sage practical advice which I have gained from my life experiences.

In 2011 I served as a member of the Fee Dispute Commission for the Montgomery County Bar Association. At the time I was appointed to the committee I was starting my own practice. The experience helped form my representation contracts and illustrated the fundamental importance of communication and examining expectations with clients. This knowledge assisted me in building the foundation for a successful small business practice.

I watched as my parents worked diligently and tirelessly to open their own dental practice. While building this practice they remained humble and offered support to the community by serving those less fortunate who would otherwise be unable to obtain needed care. This selflessness and generosity formed a framework that I have continued to build upon in my profession. I found my calling in the law working for my community.

Further, it will provide the skill to maintain the current schedule without delay or compromise. While the caseload for this division is immense, it is well-maintained, and I intend to continue this practice.


Yes, I would absolutely uphold law.

I currently represent a young man who was with a group of other young individuals when a horrific crime was committed. My client was fourteen (14) at the time of the crime and had no significant criminal history. He was not the leader of the event and took measures after the fact to assist law enforcement in the prosecution of the crime. Nevertheless, he was charged with the same offense as the other individuals, including the leader and main aggressor. All individuals participated in a transfer hearing from Juvenile Court. I did not represent my client at this time. The young individuals, all of whom were ages thirteen (13) and fourteen (14), were transferred to be tried as adults. The law does not allow for an appeal of the transfer hearing until the conclusion of the circuit criminal case, denying the ability for relief at a time that would be crucial for the juvenile. At this point the young individuals are approaching the age of majority without having a final conclusion to the criminal case.

I do not agree that a transfer hearing should not be appealable until the conclusion of the criminal court case, however, where the law and the precedent is well settled, I will uphold the law. The trial court judge cannot be influenced by passion or emotion. He or she has a duty to follow and uphold the law. I will uphold the law.
