My practice is 95% civil litigation, representing both plaintiffs and defendants in disputes involving general negligence, vehicle accidents, premises liability, wrongful death, product liability, contracts, construction, transportation, defamation, insurance coverage, consumer protection, and real property. The remaining 5% is advising insurance clients regarding coverage and claims, and miscellaneous civil practice.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

In 1996, I tried my first case in General Sessions Court in Chattanooga. Since then, I have tried more than 50 jury trials as lead or sole counsel in Tennessee Circuit Courts, the United States District Court for the Eastern District of Tennessee, and one jury trial in Knox County Chancery Court. I have tried many non-jury cases in Chancery and General Sessions Courts in Tennessee. I have also represented clients in administrative hearings and in binding arbitrations. I have briefed and argued cases before the Tennessee Court of Appeals, and the Tennessee Supreme Court (Workers Compensation Panel).

Appellate cases:

28. What are your reasons for seeking this position? (150 words or less)

I have been a trial lawyer for almost 25 years, and I strongly believe in the jury trial. While no system of justice created by humans can ever be perfect, when a group of diverse citizens are brought together, presented with facts, and instructed on the law, they form a powerful engine for the administration of justice, and they rarely make a wrong decision. As a judge, I would strive to impress on potential jurors how important their participation is, that they should be proud of their service, and that they are appreciated.

I believe that a trial judge should manage the docket and expeditiously move cases toward resolution. These days, that often means helping the parties narrow the issues and move toward a settlement. When a case is tried, however, the judge should "call balls and strikes" but otherwise allow the lawyers to try the case and intervene only when necessary.

My experience as a trial lawyer gives me insight into how a judge should treat parties, witnesses, jurors, and lawyers, and I am eager for the opportunity to positively impact both the justice system and the legal profession from a new perspective.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

The Circuit Court for the 6th Judicial District (Knox County) has three divisions. The Court has jurisdiction over civil matters, including general torts, vehicle accidents, premises liability, contracts, healthcare liability, products liability, wrongful death, and defamation.

In my 25 years as a civil litigator, I have tried many cases in this Court, and I have experience representing both plaintiffs and defendants in most of these types of cases. I understand the substantive, procedural, and evidentiary issues that frequently arise in this Court. If selected to serve, I would bring this experience, along with a passion for civility, professionalism, and impartial administration of justice.

I understand how the work of the trial court has changed, as parties have come to rely on mediation and other forms of ADR rather than take cases to trial. As a lawyer, I have been involved in every step of that process. Some cases still need to be tried, and I understand that process also. I believe this background makes me an ideal candidate for the job.

Finally, I know, like, and respect the current members of the Court. I would be honored to join them as a colleague.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. I strongly believe that the role of a trial judge is to apply and charge the law as it is, not as the judge believes it should be. A recent example is the dispute over medical expense damages, and whether the jury should hear evidence of the amounts paid by third parties or should only be presented with the amounts charged by the providers. There was good-faith disagreement on both sides of that issue, by both lawyers and judges. My personal view was that the damages are the amounts actually paid, not the charged amounts. The Tennessee Supreme Court, however, ruled otherwise. Although I did not agree with the decision philosophically, the issue is now settled. I respect the decision, and I understand the Court's reasoning.

Another example is the statutory cap on noneconomic damages. Although the majority of my practice has been on the defense side, I believe the determination of the amount of those damages is best left to the jury deciding the case, and the authority of the judge to grant a remittitur is a sufficient safeguard against anomalous verdicts that are not supported by the evidence. However, the caps were passed by the legislature, and our Supreme Court has upheld them, so the law is essentially settled. My personal opinion is immaterial. It is not the role of a trial judge to make law, or to change existing law. That is the role of the legislature and, at times, the appellate courts. A trial judge must respect this limitation.
