Occupation/Profession (other than the practice of law): My first job (part-time throughout high school) was at the local grocery store in my hometown of Cherryville, NC (Harris Teeter) from approximately 1995-1997. From approximately 1997-1999, I worked during the summer (full-time) at a children's day camp operating by the City of Cherryville, NC (my hometown).

During my time as both an undergraduate and graduate student at North Carolina State University (1997-2002), I worked part-time as an intramural sports official (the majority of which was flag football and basketball). In approximately 2000, I began refereeing middle school and high school basketball as well, first in the Raleigh, NC area while attending N.C. State and later in the Gastonia, NC area (2002-2004) while working full-time as a CPA.

Following graduation from N.C. State in 2002 with a Master's degree in accounting, I began my first professional full-time employment as a CPA with a local firm in Gastonia, NC, Butler & Stowe CPA's (2002-2004); I resigned from Butler & Stowe in July of 2004 to attend law school at the University of Tennessee in the fall of 2004. I continued to work as a middle school and high school basketball official from approximately 2004-2009 in the Knoxville, TN area both during and following graduation from law school at the University of Tennessee.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My current practice consists of both civil litigation and transactional work in a variety of practice areas including probate, estate planning, real estate, and small business, with an approximate percentage break down as follows:

35% - Probate and estate planning

25% - Real Estate

25% - Small Business

15% - "Other/Miscellaneous"*

*I refer to the "other/miscellaneous" category to account for "teamwork-type" cases where I have worked with my law partners and associate attorneys (using both my legal and accounting backgrounds). Some examples of these types of cases (many of which were in Chancery Courts across East Tennessee), which do not fit into a traditional area of practice (or are "traditional" areas of practice but not one of my regular practice areas), include:

- (1) "Salary" suits (Tenn. Code Ann. §8-20-101, et. seq.) representing Sheriffs and a Clerk & Master seeking additional funding for their respective offices and/or salary increases for their respective staffs;
- (2) Multiple adversary proceedings in U.S. Bankruptcy Court (one of my law partners regularly represents bankruptcy Trustees, and in one very large case in particular, many lawyers in our firm, including myself, were called upon to assist in the multiple adversary proceedings filed by the Trustee); and
- (3) Larger federal court cases necessitating more than one attorney (many of which I was asked to assist on based on my dual legal/accounting background, and most of which I would characterize as business litigation).
- (4) One of the benefits of working in a law firm setting with other attorneys is the ability to help out other attorneys in the firm, which I routinely do, in cases outside of what I consider my normal practice areas—some examples of which include:
 - Family law (I've worked with multiple partners on issues in their divorce cases);
 - Personal Injury (usually with probate, accounting, and/or tax issues that arise);
 - Employment law (accounting and/or tax issues); and/or
 - Administrative law and/or zoning (including property tax appeals).

I have certainly enjoyed the same benefit via assistance from fellow partners and associates on cases of my own. In my 13 year career, I have found the cases in which I am working with co-counsel, as a team, to be some of the most enjoyable experiences of my legal career thusfar.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

During my career at Frantz, McConnell, & Seymour, I have represented both Plaintiffs and Defendants in nearly every trial court in Knox County (from General Sessions to Circuit & Chancery and some work in federal court) and most surrounding counties on a wide variety of civil cases. One of my early (solo) trials was a divorce case involving a minor child in Knox County Chancery Court (no. 183971-1). My client in that case was happy with the result (my client's spouse was not awarded the full custody she sought), and to this day he still reminds me how thankful he was for my representation. To date, my only jury trial was a 2014 case in Knox County Chancery Court (docket no. 182286-2) where I successfully represented an insurance company by convincing a jury that the defendant (the former owner/manager of a title agency) had committed actual fraud by transferring real estate assets to avoid a prior judgment in my client's favor. I have also represented clients in a wide variety of civil bench trials in the past decade involving real estate litigation (boundary line disputes, easement disputes, and quiet title actions to name a few), estate/trust accounting litigation, probate litigation, breach of contract (collections, declaratory judgment actions, specific performance actions, etc.), and small business litigation (dissolution of businesses, collection actions, etc.).

I have also represented clients in the Tennessee Court of Appeals although my most recent experience there in 2019 did not end well. My partner, Arthur G. Seymour Jr., and I successfully represented our clients in a real estate dispute in Loudon County Chancery Court (docket no. 2016-81, consolidated with 2016-133 for trial); we tried the case in October of 2017 and Chancellor Williams ruled in our clients' favor on the access rights to the roadway/driveway at issue. Unfortunately, the Court of Appeals reversed the Chancellor's decision (docket no. E2018-01082-COA-R3-CV). In a prior trip to the Court of Appeals in 2018 (docket no. E2018-00611-COA-R3-CV), I successfully represented another client in a real estate dispute over easement rights (the trial court had granted my opponent's motion for summary judgment in Knox County Chancery Court no. 192055-3, but we were successful at the Court of Appeals level—they overturned that decision and remanded the case back to the trial court where it is still pending).

I have also represented clients in many real estate, business, and estate planning transactional matters where I routinely draft Wills, Trusts, and other estate planning documents, prepare operating agreements and contracts for small businesses, and regularly prepare deeds, leases, and other real estate documentation for many individual and small business clients.

8. Describe any matters of special note involving your practice in trial courts, appellate

courts, and administrative bodies.

Two interesting cases come to mind:

- 1. The Estate of Robert W. Rankin (Knox County Chancery Court, Probate Division, no. 74182-3). I was appointed as the Administrator Ad Litem for this probate estate in February of 2014 by Knox County Chancery Court Clerk & Master Howard Hogan. This probate estate had limited non-liquid assets (the main assets were partial ownership interests in 2 billboard structures), and the decedent had failed to file federal income tax returns for many years prior to his death, which left the estate in a very tough spot. I felt that I was a good fit as both an attorney and CPA, so I accepted the appointment. During my appointment, I was tasked with gathering what limited records were available (in a twist of irony, the decedent's ex-wife was a huge help in that process), preparing/filing unfiled income tax returns, and working to liquidate the billboard assets for the benefit of the creditors of the insolvent estate. After filing the required income tax returns to ensure no federal income tax liability, I was nearly forced to file a lawsuit to sell the entirety of the billboards (the Estate only owned a 25% interest in each of 2 structures) but was able to work out a global settlement amongst all creditors relative to the sale of the partial interests in the billboard structures and distribution of the net proceeds, which saved the Estate both time and money. In 2019, the Estate was finally closed, and the creditors received a partial distribution on their claims.
- 2. United States vs. Kenneth Devore, U.S. District Court case no. 2:17-CR-13. This is the only criminal case in which I have appeared during my legal career, but it was not as an advocate. After receiving a recommendation from a U.S. Attorney (whom I met via my service to the tennis community on the Greater Knoxville Tennis Association Board), I was retained by the prosecution to serve as an expert witness in this criminal case whereby the defendant was accused of taking advantage of a veteran of the U.S. military and defrauding him for financial gain (by inserting his name into the Veteran's Last Will & Testament). I served as the prosecution's expert witness on the process of executing a Will in the State of Tennessee. Following a six-day trial in 2018, the defendant was convicted of wire fraud, mail fraud, financial conflict of interest, theft of public money, and making false statements, and Judge Reeves later sentenced him to prison. I admittedly only played a small part in this case, but this was without a doubt one of the most satisfying experiences of my legal career.
- 9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

As part of my service on the Board of Directors of the Children's Center of Knoxville, Inc. ("CCK"), I had the opportunity to use my advocacy skills in an administrative law setting. In early 2016, Tennessee's Department of Human Services (DHS) began enforcing a regulation that threatened CCK's 3-star rating (the top rating for a childcare center); the regulation at issue, in its most basic form, required CCK's lead teachers to have earned a high school diploma or

equivalent approved by the Department of Education in order to achieve the 3-star rating. This posed a serious threat to CCK's 3-star rating because 2 of CCK's best and most experienced teachers did not have a high school diploma or GED. We began informal negotiations with DHS in early 2016 in an attempt to resolve the matter amicably given these 2 teachers had been working at CCK for over 30 years each, and during that time, CCK had always received a 3-star rating (apparently, the regulation was never enforced until 2016). Those informal negotiation efforts failed, and on March 24, 2016, on behalf of CCK I filed a Petition for Review of this administrative decision with the Tennessee Department of Human Services Child Care Licensing Board (no. 620965816 000). A few months after filing that Petition, we reached an amicable settlement with DHS whereby an "honorary" high school equivalency was awarded to 2 of CCK's teachers by Dr. Jane Qualls from the University of Tennessee (who drafted an excellent expert report attached as Exhibit "1" to CCK's Petition and who would have testified as CCK's expert witness if this matter proceeded to a full administrative hearing). I understand the intent behind the regulation was not to hurt experienced teachers who did not finish high school and am proud of the resolution reached with the Tennessee DHS on behalf of CCK.

28. What are your reasons for seeking this position? (150 words or less)

I seek this position because my unique background (law & accounting) and my 13 years of diverse practical experience will allow me to serve the public and Chancery Court well. It would be nearly impossible to find an applicant experienced in every type of case a Chancellor could be asked to decide in Tennessee, but my unique background and experience in Chancery Courts across East Tennessee will serve me well here. I feel all Judges owe it to the individuals before their Court to do their best to explain both the factual and legal basis behind their decisions, especially to pro se parties who may not understand the "why" behind a decision. I would do my best to make sure every individual in Chancery Court, even if they disagree with a ruling, understands the basis (both factual & legal) for my decisions.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I seek the appointment as Chancellor of Division 3 of Knox County Chancery Court which handles a wide variety of cases (family law, probate, conservatorship/guardianships, business litigation, contract cases, real estate, etc.), and I have experience in the majority of these areas (some more than others). Knox County has 3 Chancellors, and I have spoken recently with two (and the 3rd has agreed to talk with me soon) about efforts to work together, the general breakdown of caseloads, and what it takes to be successful. These conversations give me confidence that Knox County's Chancellors would mentor the newest member of the bench, so regardless of who is appointed, I recommend they immediately reach out to their fellow Chancellors. As far as impacting the Court, I would strive to ensure Chancery Court was an experience each individual understood, even if they disagree with the decisions and/or procedures.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. One example would be the three (3) salary lawsuits whereby I assisted my law partner in representing 2 local Sheriffs and a County Clerk & Master. I disagree with the substance of the statute providing for this remedy (and personally feel that the legislative branch of government, the county commission, should face the voters and be judged at the ballot box for inadequate funding of these offices). But despite my disagreement with the statute (Tenn. Code Ann. §8-20-101, et. seq.) I, along with my law partner, have represented our clients under the law to the best

of our abilities to achieve the results our clients needed to ensure their offices could continue to be operated at the highest level.

A second example would be my experience with the DHS regulation outlined in my prior response to Question no. 9. My personal view is that any parent would not prefer a random 18 year-old high school graduate to care for their infant child or toddler over one of CCK's teachers with 30+ years' experience but lacking a formal high school diploma. But if called upon to rule on this regulation (or a similar regulation or law) from the bench, I would follow the regulation or law as written, even if it conflicts with my personal views or if the result did not seem "fair".
