I was responsible for \$8 million dollars in reserves. I worked with local counsel on both liability claims and policy coverage disputes in most of the continental United States. 6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My current Judicial Magistrate position is focused on criminal law. I am responsible for reviewing arrest warrants for probable cause, advising defendants in custody of their Constitutional rights, explaining what charges they face and appointing legal counsel if I determine that they are unable to hire an attorney. I review and issue search warrants and conduct property seizure hearings. I am permitted to have a part time civil practice which currently includes probate work (20%), debt collections (40%), evictions (20%), representing creditors in bankruptcy cases (10%) and some real property matters (10%).

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

Over my 32 year legal career, I have spent most of my time in trial courts. The first part of my career took me into insurance defense litigation regarding asbestos and other workers' compensation injuries. Then I focused my attentions on real property law, specifically foreclosures and real estate closings. My firms have operated two title companies. I handled boundary line disputes, actions to quiet title and partition suits. I have filed probate matters and have been an executor myself a few times. I have litigated will contests and dealt with disputed estate claims. I have been appointed guardian ad litem in chancery to represent the mentally ill in termination of parental rights cases and even once represented an individual in a coma. I have represented parties in divorces including one that was highly contested. I understand both the joy and heartbreak of adoption. I have represented lenders and creditors in bankruptcy cases in the Eastern District of Tennessee since 1990 and a few cases in other districts. As a result, the concept of a receivership is very familiar to me. In my present position, I process reports of domestic violence on nearly an hourly basis. A myriad of victims seek criminal prosecution of and protective orders from their abusers. I also expect that as our population continues to age, we will be confronted with more elder abuse situations that will seek assistance from the chancery courts in the form of conservatorships.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

One of my best learning experiences came from my first out of county trial as a sole practitioner. The case was in Hawkins County Chancery Court and concerned a dispute as to the proper beneficiary of a bank account. My client received the balance of a bank account that was held with his mother as joint tenants with rights of survivorship. His daughter insisted that that money should be included in her grandmother's estate and divided according to the will which would mean the daughter would receive a third of the account funds. I lost the trial and took it up on appeal. I had to learn about making contracts with court reporters before the hearing starts. My other lessons included: How to write a statement of facts. How to read the rules and actually file the appeal. How to file another appeal when the Court of Appeals rules against you. How to prepare for oral argument before the Tennessee Supreme Court while still in my twenties. Why you should always write a trial brief to make sure that the Court knows which law must apply and why the facts require it. In the end, I won the appeal and remember all of my lessons. In re Estate of Nichols, 856 S.W.2d 397 (Tenn. 1993).

I also took another lost case up on appeal during that same time. A bankruptcy trial I had brought an unexpected decision that permitted the debtor to unilaterally modify her mortgage with my client, a finance company. Once again, the intermediate appellate court let things stand. The case was taken to the United States Court of Appeals, Sixth Circuit which reversed the bankruptcy court. In re Iris June Davis, 989 F.2d 208 (6th Cir. 1993).

28. What are your reasons for seeking this position? (150 words or less)

I am seeking this position to increase the public's access to justice in all of our courts. Chancery court is not just a court for wealthy business people. It is a court for human beings in times of crisis in their marriages, in their family relationships, in their employment, in their health, in their homes. It is a court where we seek, in the words of Justinian, "To live honestly, to harm nobody, to render to each man his due." I hope to live up to this sacred trust.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

The Sixth Judicial District geographically encompasses all of Knox County, Tennessee. According to the U.S. Census the population in Knox County last year was estimated at 470,313. The Knox County Chancery Court is made up of 3 Chancellors and a Probate Division overseen by the Clerk and Master. The Clerk and Master oversees administration of probate matters, subject to review and approval of the Chancellors. My selection to the court would add legal experience, life experience and diversity to the Chancery Court.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

The Center for Disease Control (CDC) issued a new regulation on September 4, 2020 that no evictions should be permitted until after December 31, 2020 where, among other things, the tenants state that eviction would force them to become homeless. I disagree that this should be the case because this applies to the landlord's privately owned property. It holds the landlord's real property hostage for the benefit of someone who may never be able to repay the rent owed. It forces the landlord to continue to pay the utilities on property where they may not be receiving

any money from the tenants at all. Yet, it is the law and I can only advise my clients not to take any adverse action despite their frustration with the current situation. They must wait and obey the law.
