6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I am a board-certified general civil trial attorney, and my current practice consists of domestic/family law (60%), personal injury/professional negligence law (20%), and general civil mediation (20%).

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

As a young lawyer, I did most everything (domestic/family law, criminal defense, personal injury, worker's compensation, product liability, wrongful death, civil rights, and professional negligence). I have tried Federal jury trials before Judge Neese (deceased), Judge Jarvis (deceased), Judge Wilson (deceased), Judge Taylor (deceased), Judge Hull (deceased), Judge Jordan, Judge Phillips, and Magistrate Judge Murrian. I have tried a few criminal jury trials but mostly civil jury trials in Knox County and all surrounding counties. When I became board certified in 1995, I had to certify a minimum of 50 jury trials tried to conclusion, and I have tried many more jury trials since then. In the early 1990's, I was selected by our Federal Judges in Knoxville to be trained and certified in the first class of Federal civil mediators, and I have conducted hundreds of mediations over the last 30 years. I stopped doing criminal defense work after about 10 years of practice and, in the late 1990's, my civil trial practice began to trend more toward domestic litigation involving complicated, high-value marital estates with inter-related forensic business valuation issues. I have tried hundreds of divorces/domestic cases in both the Circuit and Chancery Courts of Knox County as well as all surrounding counties, and I have had to limit my mediation practice because of its tendency to compete with the time necessary for my busy trial practice. Included in my curriculum vitae is a list of reported appellate decisions in which I have participated. I have argued appellate cases in all of our appellate courts and the United States Sixth Circuit Court of Appeals in Cincinnati. For the last 20 years, I have volunteered generally one day per month as a Special Master assisting both Knox County Chancery Court and Knox County Fourth Circuit Court trying domestic violence/Order of I would estimate that I have presided over at least 1,000 domestic Protection cases. violence/Order of Protection trials. Although infrequently, I have also appeared before the Knox County Commission as well as the Knoxville City Council representing the YMCA and various other client's interests.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

As I have already mentioned, for the last 20 years, I have volunteered generally one day per month as a Special Master assisting both Knox County Chancery Court and Knox County Fourth Circuit Court trying domestic violence/Order of Protection cases. I would estimate that I have presided over at least 1,000 domestic violence/Order of Protection trials. To the best of my knowledge, none of the Order of Protection cases over which I have presided have been appealed to the Tennessee Court of Appeals.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

In the early 1990's, U.S. Magistrate Judge Bob Murrian instituted a pilot program of civil mediation in the Federal Courts for the Eastern District of Tennessee. I was one of 12 candidates selected by our three Federal judges in Knoxville to be trained as a civil mediator in this pilot program which preceded by several years the adoption of Rule 31, Tennessee Supreme Court Rules, which governs mediation and alternative dispute resolution in the state court system. Thus, I was fortunate to have been selected for training and certification as a general civil mediator as early as anyone else in the State of Tennessee.

I have not previously submitted an application for any state or federal judicial position.

I thought that the attorneys involved in the mediation had disclosed that fact to their respective clients as had occurred in previous mediations which I conducted for that firm. Please note that a private informal admonition does not constitute a finding of misconduct or an ethical violation.

Yes, I was involved in a divorce proceeding which concluded on 1-10-96. The style of the case was <u>Harber v. Harber</u>, Knox County Chancery Court, Docket No. 121969-2, which was settled by agreement out of Court. Approximately 25 years ago, I was named as a defendant along with several state judges (Dale Workman, retired, and Harold Wimberly, deceased) and other attorneys in a pro se action filed in the U.S. District Court for the Eastern District of Tennessee by two convicted felons (Rocky and Leon Houston) in a frivolous suit alleging conspiratorial conduct against them. The suit was summarily dismissed, and it happened so long ago that I have no records. Approximately 15 years ago, I was named as a defendant together with other

attorneys in another frivolous pro se action filed in U.S. District Court for the Eastern District of Tennessee by a woman (Heather Wilder) alleging conspiratorial conduct related to her divorce case (Wilder v. Wilder, Knox County Fourth Circuit Court, Docket No. 108931) in which I was the mediator. That action was summarily dismissed, and it also happened so long ago I do not have any records.

Please refer to my curriculum vitae. As you will note, I have been a lifelong member of the YMCA and have served as volunteer general counsel to the YMCA of East Tennessee for approximately 25 years. I have also served as a volunteer on the Committee on Membership Standards for the YMCA of the USA for also approximately 25 years. My wife and I are lifelong members of the Methodist Church. However, I have never held any church office.

28. What are your reasons for seeking this position? (150 words or less)

I have accumulated a broad range of legal experience as a trial attorney over the last 42 years, and I have the greatest respect for our legal system and the quality of our State judiciary. If I am fortunate enough to be nominated and subsequently appointed as Chancellor, I will have the opportunity to share my accumulated legal experience and the practical wisdom derived from that experience in an objective, balanced, and fair-minded manner with the litigants and the attorneys who regularly practice in Knox County Chancery Court. Domestic/family law matters now constitute the majority of cases filed and tried in that court, and I am uniquely qualified because of my domestic trial background and experience to hear those cases. I have experienced almost every type of trial court situation that one can imagine. Although the office of Chancellor would result in a significant decrease of income, the opportunity to serve would offer more than sufficient compensation to me personally. We have all known lawyers whose demeanors changed for the worse when they became judges, and I will not be one of those. I have worked hard to develop a reputation for integrity, hard-work, objectivity, balance, and fair-mindedness, and I will never lose sight of nor will I forget the practical challenges of having been a trial attorney for 42 years. In my many years of volunteer work for the YMCA and my 20 years of volunteer experience as a Special Master, I have developed a true appreciation for public service and the need for committed public servants.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

The Sixth Judicial District of Tennessee constitutes Knox County only, and there are three divisions of Knox County Chancery Court. I am applying for the position of Chancellor in Knox

County Chancery Court, Part 3, which is currently held by Chancellor Michael W. Moyers who has announced his retirement effective 1-23-21. Chancery Court is a court of equity which exercises equitable, inherent, and statutory jurisdiction. Most commonly in Knox County Chancery Court, the types of cases filed and tried include divorce/domestic matters, contract disputes, probate matters, adoptions, actual or constructive fraud, specific performance of contracts, conservatorships, actions for an accounting, real estate disputes, receiverships, injunctive relief, title disputes, and disputes where there is no adequate remedy in any other court. In Knox County, the case load statistics support the conclusion that domestic issues such as divorce, child support, contempt, parenting plans, Orders of Protection, and custody disputes constitute the majority of the cases which proceed to an evidentiary hearing or trial. My trial experience uniquely qualifies me for this position.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. I was recently involved in a same-sex divorce and custody dispute involving a child born during the parties' marriage through the artificial insemination of the biological mother by an anonymous donor. I represented the biological mother in the custody dispute which required the application of T.C.A. Section 68-3-306, the Artificial Insemination Statute. On behalf of my client, I advocated the strict construction of that statute even though I personally thought that the statute should be construed in a gender-neutral manner consistent with the <u>Obergfell</u> decision of the U.S. Supreme Court holding that same-sex marriage is legal in all states.
