6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I operate a general civil practice, focused on business, residential and commercial real estate transactions and litigation, business formation and representation including employment disputes, trademark protection, employment contracts and personnel policies; general civil and commercial litigation, and probate and estate litigation. I represent a number of regular business clients, including homeowner and condominium associations. I advise and represent these clients in enforcing their rights, particularly with regards to collection of maintenance fee liens. I occasionally represent criminal defendants. I also prepare wills and other testamentary and fiduciary documents, including powers of attorney. While the following percentages are estimates and vary from year to year, on my most recent application for malpractice insurance coverage, I showed the following:

Corporate/General Business: 20%; Criminal: 1%; Estate Planning/Wills/Probate: 2%; Personal Injury: 5%; Closings: 5%; Commercial Foreclosures: 1%; Residential Foreclosures: 1% Landlord Tenant: 5%; other real estate commercial: 10%; other real estate residential: 5%; general civil litigation: 10%; HOA/Condo lien enforcement: 30%

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have represented clients in both jury and non-jury trials in the Circuit, Chancery, and General Sessions Courts of the State of Tennessee and United States District Courts, and in appeals to the Tennessee Court of Appeals, the Tennessee Court of Criminal Appeals, the Tennessee Supreme Court. and the United States Court of Appeals for the Sixth Circuit. As an assistant district attorney I tried 25 jury trials as sole or lead counsel, from voi dire to verdict. As staff counsel for the federal district court I reviewed, analyzed, and prepared both procedural and substantive orders for signature by the presiding federal district judge in thousands of pro se cases over a ten year period. In my subsequent private practice during 2001 to 2002 I represented 3 clients on federal appellate criminal appointments and pursued their appeals to the Sixth Circuit. In my private practice I have represented clients in various post conviction criminal matters, including successfully obtaining relief for one client under 28 U.S.C. § 2255.

In my private practice since 2002, I have run a one-man law firm, occasionally with a clerk, representing a broad variety of clients in both transactional and litigation work. My transactional practice encompasses both business and real estate contracts, leases, closings, and dispute resolution. My litigation practice reflects the scope of the practice, dealing primarily with commercial, business, and real estate related disputes. I have also handled several personal injury matters, including one serious wrongful death action that settled following mediation.

My representation of business clients includes risk management, regulatory compliance, and exhaustion and review of administrative remedies before state and federal agencies, including

representation before the State Board of Equalization, administrative proceedings before the Tennessee Department of Labor and Workforce Development, and the United States Department of Agriculture. My circuit court practice, in particular, includes personal injury, breach of contract, legal malpractice, General Sessions appeals, and general tort litigation.

Based on my education, my experience in the federal court system drafting orders for federal judges, and my representation of clients in private practice, I think I possess superior research and writing skills that would enable me to serve the public as a jurist with the mental discipline, intellectual curiosity, and acumen to meet the needs of the litigants and their counsel who appear in Circuit Court.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

I represented the appellants on appeal from the Shelby County Circuit Court to the Tennessee Court of Appeals in Brown v. Shtaya, No. W2012-00875-COA-R3-CV. This appeal resulted from a decision of the Circuit Court that serious misconstrued the conditions and requirements for effecting an appeal from General Sessions to Circuit Court. My detailed and comprehensive brief and related filings contributed significantly to the correction of a serious injustice that had threatened the right to a jury trial and access to the courts for thousands of citizens in Shelby County. The construction of the law also created significant issues for many attorneys whose handling of these appeals was called into question, putting them at risk for malpractice claims. Most significantly, the narrow construction of the proper appeal procedure threatened to call into doubt numerous judgments of the Circuit Court issued in appeals from Sessions Court in Shelby County, and by extension, across the state. The Court of Appeals, despite an earlier decision adverse to my client's position, reversed the Circuit Court and reinstated my client's appeal. The Tennessee Supreme Court, in Griffin v. Campbell Clinic, P.A., 439 S.W.3d 899 (Tenn. 2014), eventually affirmed the interpretation adopted by the Court of Appeals.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

I have represented clients in Shelby County Probate Court as an attorney, having joint control of funds with the personal representative, ensuring that all funds are properly accounted for and disbursed. In my real estate and business practices, I routinely hold funds in trust as escrow agent for parties to sales, leases, and other related transactions. Additionally, I have maintained an appointment as a notary public since 2001, during which time I have complied with all the requirements to be entrusted with the duties of that position. I also act as successor trustee on behalf of foreclosing lenders and condominium owner associations, conducting foreclosure sales and receiving and disbursing funds and transferring title to real estate.

For over ten years, I served as either a law clerk or staff attorney for federal district

judges. That experience taught me the inestimable importance of fairness, impartiality, and sober judgment in considering the claims of all parties. It also instilled in me a respect for the rule of law—that our civilization exists by reason of our faithful adherence to the truth that no individual person is above the law—that our Constitution is the crowning glory and achievement of that civilization, and that upholding it and promoting respect for it requires rigorous discipline and devotion to it and the laws enacted in accordance with it.

To ensure that I fulfill my obligation to maintain competence in the law, I generally strive to teach a few hours of CLE each year. I find that I learn extensively from proper preparation as a presenter (probably more than I impart to the attorneys attending). I have traditionally carried far more hours than are required for minimum CLE compliance. I am presently working on hours for 2017, as I carried over sufficient hours to cover my 2016's obligation. (I actually earned more hours last year than the 15 that could be carried over). I try to include in my CLE hours courses that are outside the strict area in which I practice. During 1995-96 I taught advanced criminal procedure as an adjunct professor at the University of Memphis School of Law, but the demands of my family at that time precluded my continuing that service.

In addition to my law practice, I also have volunteered repeatedly over the years for a variety of community service activities with a fiduciary role, including serving as: trustee of my Knights of Columbus Council, (a position that requires the review and certification to the Supreme Council of the financial status and obligations of the local council); Soccer Coordinator of the Diocese of Memphis' scholastic Soccer league; and as an officer and board member of the Memphis Chess Club, a non-profit corporation with 501(c)(3) status.

I have not previously applied for a judicial appointment in the State of Tennessee. While employed as staff attorney for the Western District of Tennessee I applied unsuccessfully for a position as United States Magistrate Judge.

Voting membership in the Knights of Columbus is limited to Catholic men, although participation in activities is open to virtually anyone who shows up at an activity. The organization is devoted to charitable and religious purposes. I see no conflict between membership in the Knights of Columbus and service in the judiciary of the State of Tennessee, particularly as numerous other judges, jurists, and public servants are also active Knights. The organization does not restrict membership on the basis of race, ethnicity, disability, or any other immutable characteristic, and indeed, devotes much of its resources to assisting those in need. In Tennessee, this is especially true of assistance to persons with mental disabilities, a major recipient of the organization's fund raising efforts.

## 28. What are your reasons for seeking this position? (150 words or less)

I have devoted my legal career to the preservation of the Constitution in the truthful and peaceable resolution of disputes. Increasingly our lay brothers and sisters fail to grasp that the very fabric of our society depends on a just and efficient judicial system. They seem to respond only to the most highly publicized cases, usually those in which they disagree with the results, and view judges as semi-omnipotent arbiters rather than jurists dedicated to the preservation of freedom. Unfortunately, some judges have contributed to a results-oriented philosophy. Every Judge must exhibit a zeal for service with an unshakeable commitment to the Constitution and the limited role of applying the laws the people make through their representatives. Every Judge must also understand the limits of office and how their frailty should temper their rulings and their exercise of judicial discretion. The desire to serve, not dominate, inspires me to apply.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (*150 words or less*)

I seek appointment to the Circuit Court, Division 7, Shelby County. Shelby County has 9 Circuit Divisions. A Circuit Court Judge's first duty? To arrive early and work diligently. The second? Keep the docket current and ensure that citizens' disputes are resolved fairly without undue delay. My knowledge and understanding of the rules and laws, of the pressures litigation imposes on litigants and counsel, and my concern for the citizen as focus of any court system would benefit our judicial community and the bar. My experience in the federal court system as

a court attorney, combined with my experience in transactional work provides a neutral perspective--the ability to view both sides of a dispute in an objective and impartial manner, and to act fairly in resolving disagreements. I also have a temperament that is, I think, generally experienced by others as kind, courteous, collegial, and mentally rigorous.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I do not represent clients in divorce cases, in part because of my religious and philosophical views on the indissolubility of marriage. Nevertheless, I have several family members, and any number of clients, who are either divorced or regularly deal with the consequences of divorce. While I refer direct divorce representation to colleagues, I have on occasion represented clients on issues arising from divorce proceedings. I strive to provide that representation in a competent manner while helping these clients deal with the seemingly inevitable stress caused by these situations. I also strive to remain abreast of cases and statutes affecting divorcing parties. Regardless of my views of the effect of divorce on society, our legislators and the vast majority of the public have opted for these remedies. The role of a judge is to follow the law and treat all litigants fairly. A Circuit Court judge, in particular, must be willing and competent to preside in divorce cases so that the divorcing parties and their children will be treated with respect.
