IMPORTANT NEWS

The ADRC is developing the agenda for the <u>Twelfth Annual ADRC</u> <u>Workshop</u> which will be held <u>Friday</u>, <u>November 7, 2014</u> at Lipscomb University in Nashville. Please make plans to attend! Please note that the Workshop will *always* satisfy the CME requirements for *BOTH* general civil and family listed mediators.



Fast Stats: There were 5,606 mediations reported for 2013. Of those, 3,542 (63.2%) had all issues resolved; 521 (9.3%) had issues that were partially resolved; and 1,542 (27.5%) had no issues resolved. There were 350 pro bono mediations plus 4 additional court ordered pro bono mediations conducted in 2013.

These mediation statistics were compiled from online mediation reports submitted by Rule 31 listed mediators. Per ADRC Policy 10, "Effective January 1, 2008 all mediators listed pursuant to Supreme Court Rule 31 will be required to submit reports as prescribed by the Commission, regarding any mediation beginning on or after January 1, 2008 except as to matters pending in state courts outside of Tennessee and the Federal Court System. Mediators will have 15 calendar days from the date of the last mediation session to submit the report to the AOC. This policy does not affect any other reporting obligation required of a Rule 31 listed mediator."

IN THE TENNESSEE ALTERNATIVE DISPUTE RESOLUTION COMMISSION

Advisory Opinion No.: 2014-0002

The Tennessee Alternative Dispute Resolution Commission has been asked to provide an opinion upon the following questions, posed by a Rule 31 mediator:

- 1. If a psychiatrist, practicing in Tennessee, is a Rule 31 approved mediator, could the psychiatrist schedule and conduct her or his mediations at the facilities where she or he maintains her or his medical practice?
- 2. May a Rule 31 mediator, who is a psychiatrist, provide post-mediation psychiatric treatment to a participant in the mediation?

For response to the first question, no provision of Rule 31 in its current form, would prohibit conducting a mediation within the physical space of a suite of medical offices. Mediations are conducted in law offices routinely.

For response to the second question, Rule 31 mediators are obliged to preserve and maintain the confidentiality of all information obtained during Rule 31 ADR Proceedings. They may not divulge information obtained by them during the course of Rule 31 ADR Proceedings without the consent of the parties, except as otherwise provided by law. *Rule 31*, \$10,(d).

As for domestic matters, and beyond the provisions of Rule 31, *TCA* §36-4-130, provides that when the parties to a divorce action mediate the dispute, the mediator shall not divulge information disclosed to the mediator by the parties or by others in the course of mediation. All records, reports, and other documents developed for the mediation are confidential and privileged.

These obligations continue after the conclusion of the mediation.

It is difficult to imagine how a psychiatrist could undertake to subsequently treat a patient, who was a party to a prior mediation. One would think that the best treatment would need to proceed with the open mind of the provider. However, this would seem to be a medical ethics question, and not one for consideration by this Commission.

ATJ Commission Establishes New Mediation Committee Under The 2014 Strategic Plan

The Tennessee Supreme Court Access to Justice Commission has established a new Committee on Mediation under the March 31, 2014 Strategic Plan. ATJ Commission Member Gail Vaughn Ashworth of Wiseman Ashworth Law Group, PLC is the Chair of the New Mediation Committee and has assembled a great team to implement the ATJ Strategic Plan Directive, which is to provide for additional pro bono mediation as follows:

"The Commission shall encourage the Alternative Dispute Resolution Commission and other groups to provide pro bono and reduced-rate mediation services to self-represented litigants, and to litigants who, although represented, have modest means or who are pro bono clients."

The Goal under this Directive is to launch three new pro bono mediation programs/opportunities and increase the number of individual mediators doing pro bono mediation by 10% and is to be completed by March 31, 2014.
