August, 1991 – January, 1994: Associate, Richard L. Dugger and Associates, Shelbyville, TN. I worked as an associate attorney for a sole practitioner. I engaged in a general practice of law. I handled a wide variety of civil cases in the Circuit, Chancery, Juvenile and General Sessions Courts of several counties in middle Tennessee. I also represented individuals charged with criminal offenses. I did this on both an appointed and a retained basis. I represented persons on all types of criminal offenses, including first degree murder, rape, robbery, burglary, drug offenses and various misdemeanor offenses. I also represented debtors in Bankruptcy Court.

January, 1994 – May, 1995: Associate, Grant, Konvalinka and Harrison, Chattanooga, TN. I worked as an associate attorney. My primary assignment was preparation of tax returns and financial statements for both businesses and individuals. I also assisted with representing clients

involved in IRS audits and tax litigation. I assisted with business model planning and estate planning. Lastly, I participated in some civil litigation.

August, 1995 – July, 1998: Assistant Public Defender, Seventeenth Judicial District Public Defender's Office.

I was assigned to the Circuit Court, Part I. If the Public Defender's Office was appointed to represent a defendant in the Circuit Court of Bedford, Lincoln, Marshall or Moore Counties, I was the attorney assigned to handle the case. Most of the cases were felony-level offenses running the gamut of the criminal code. My involvement in a case began at the arraignment and often continued through the first tier appeal to the Court of Criminal Appeals. I have also represented persons in post judgment proceedings, such as probation revocations and post conviction relief hearings.

July, 1998 – present: Assistant District Attorney General, District Attorney General's Office Seventeenth Judicial District.

l am assigned to Circuit Court, Part I, for Bedford and Marshall Counties. l am responsible for prosecuting all Class A and B felonies in Bedford County. l share responsibility with another assistant D.A. for the Circuit Court docket in Marshall County. I have conducted several hundred jury trials, and l have prosecuted several thousand felony cases. Additionally, I have responsibility for handling motion hearings, sentencing hearings, probation revocations hearings, motions for new trial and post conviction relief hearings.

At present, I am an Assistant District Attorney General for the Seventeenth Judicial District. I am assigned to Circuit Court, Part I, for Bedford and Marshall Counties. One hundred percent of my work is devoted to the prosecution of criminal cases in those two Courts.

Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters. For the first four years of my career I was in private practice. During that period I handled a wide variety of civil cases, mostly at the State trial court level. I have handled numerous divorces and child custody matters, personal injury lawsuits, contract disputes, debt collections, estate planning and probate matters. For a period of time, I was primarily handling tax matters for both businesses and individuals, which sometimes involved representing clients in disputed matters with the IRS. I have also represented persons applying for disability with the Social Security Administration. Additionally, I have represented debtors in Bankruptcy Court.

During my years in private practice, I also did criminal defense work. This was primarily in General Sessions and Circuit Court. However, I also handled matters in the Court of Criminal Appeals. I represented persons charged with offenses ranging from simple traffic violations to serious felonies, including first degree murder. During this period, I was frequently appointed by the Circuit Court Judge, so a large portion of my criminal defense practice was in Circuit Court. This period of time in my career was invaluable in developing my skills as a trial level litigator.

Beginning in August, 1995, I began my employment with the Public Defender's Office for the Seventeenth Judicial District. I was assigned exclusively to the Circuit Court. If the Circuit Court Judge was on the bench anywhere in the district, I was there also. During the three years I was in the Public Defender's Office, I tried more jury trials than any other attorney in the district for that period of time. Most of the cases I handled were felony offenses. I also occasionally prepared and filed briefs in the Court of Criminal Appeals. It was during this time in my career that I believe I significantly advanced my skills as a trial court litigator and my knowledge of matters related to Circuit Court, Part I.

In July, 1998, I became an assistant district attorney general. J believe it was my abilities as an assistant public defender that directly led to my being hired by the District Attorney General's Office. For most of the last fourteen years, I have been assigned to Bedford County Circuit Court. However, for the last year and a half, I have also been assigned to Marshall County Circuit Court. I have prosecuted many thousands of felony offenses. I have tried hundreds of jury trials.

Including my time in the District Attorney General's Office and the Public Defender's Office, I have nearly eighteen years of experience in Circuit Court, Part I. As both a prosecutor and a defense attorney I have seen the wide range of issues that confront a Circuit Court Judge. I believe I possess a comprehensive basis of knowledge for how to deal with those kinds of issues. For example, I believe I possess an excellent working knowledge of the rules of evidence, the rules of criminal procedure and the pattern jury instructions.

Regarding my work habits, I take very seriously my obligation to represent the State of

Tennessee. Only through hard work have I managed to achieve any level of success. Being assigned to Circuit Court requires an extra effort to be effective. Consequently, it is not uncommon to see me unlocking the courthouse in the morning as one of the first to arrive or to see me locking the door at night as one of the last to leave.

9. Also separately describe any matters of special note in trial courts, appellate courts, and administrative bodies.

A death penalty case is the most serious and complex criminal case a Circuit Court Judge will ever have to preside over. It places enormous intellectual and physical demands on all the participants, including the Judge.

In 1997, when I was in the Public Defender's Office, I was appointed to represent a defendant charged with quadruple homicide in Bedford County. The State was seeking the death penalty. I participated as co-counsel in the representation of that defendant in General Sessions Court and Circuit Court until July, 1998, at which time I was hired by the District Attorney General's Office. At that point, for obvious reasons, I no longer had any involvement in the case.

In 2010 and 2011, I was part of a team of prosecutors handling another death penalty case, this time in Lincoln County. The defendant had murdered five people including some children. The defendant eventually pleaded guilty and received five consecutive life sentences without the possibility of parole. Before that resolution, we interviewed nearly one hundred witnesses, and we went through a multitude of complex pretrial motion hearings, involving testimony, argument and briefing.

Consequently, I have experience with death penalty cases as both a prosecutor and a defense attorney, which would be invaluable as a Judge. I believe I am the only attorney in the district that can claim that distinction.

I have been an instructor for in-service training for local law enforcement agencies. I have also taught a week long course to State Bomb and Arson investigators on how to testify in court effectively. Lastly, I have been an instructor at a course hosted by the Bureau of Alcohol, Tobacco and Firearms.

George Scott Mason v. Paul Summers, et al., United States District Court, Eastern District of Tennessee case no. 3:07-CV-00043; Dismissed as to me after Motion for Summary Judgment granted 9/29/08. Mr. Mason was a defendant 1 prosecuted. 1 attended his parole revocation hearing. I was sued simply for attending that hearing.

- 1. State's written denial of pre-trial diversion. My decision was upheld by the Trial Judge and affirmed by the Court of Criminal Appeals.
- 2. Motion to Quash Notice of Taking of Depositions and Subpoena <u>Duces Tecum</u>. The background of this case involves a young woman, Shelley Mook, who has been missing since February, 2011. She had a small child who became the subject of a custody battle between her mother and her ex-husband. The ex-husband is considered a suspect in her disappearance. The ex-husband wanted to depose two of the detectives involved in the investigation and examine their files in order to find out what evidence we had against him. I filed a motion to bar that from happening in order to preserve the integrity of the investigation. The motion was granted by the Trial Court. No appeal of that decision was ever taken.

For the last fourteen years, I have proudly served the citizens of Bedford, Lincoln, Marshall and Moore Counties. I have truly tried to make a difference, to make our district safer, to make

victims feel like when they left the courthouse, they got justice. As a prosecutor I have a duty not simply to win a case or get a conviction, but instead to seek justice. That duty, to seek justice, has guided every decision I have made as a prosecutor.

If you think about it, the role of the Judge is not much different. The Judge also wants to see that justice is done in every case. The Judge achieves this by being fair and impartial and by making rulings that are based on the facts and the law. I believe for me the transition from prosecutor to Judge would be an easy one simply because I already have the mindset that the objective in every case is to seek justice.

36. State any achievements or activities in which you have been involved which demonstrate your commitment to equal justice under the law; include here a discussion of your probono service throughout your time as a licensed attorney. (150 words or less)

While I was in private practice, I did take <u>pro bono</u> cases from the Legal Aid Society of Middle Tennessee. I litigated several of these cases, including a denial of unemployment benefits and a Social Security disability claim. Additionally, the firm I worked for in Chattanooga provided free legal advice to inmates in the Hamilton County jail. Since I had extensive criminal defense experience, the firm assigned me to that task. Since I am no longer in private practice, I am precluded from taking <u>pro bono</u> cases.

37. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

Judge Robert Crigler presides over Circuit Court, Part I, for the Seventeenth Judicial District, which is comprised Bedford, Lincoln, Marshall and Moore Counties. For over twenty years, the Judge who has presided over Circuit Court, Part I, has heard exclusively criminal cases, and the overwhelming majority of those cases are felony level offenses.

To be an effective Judge for Circuit Court, Part I, it is necessary to have an extensive background in criminal law. For the last eighteen years my career has been devoted exclusively to eriminal law. For all of those eighteen years, I have been assigned to Circuit Court, Part I. I have been a defense attorney and a prosecutor, so I would be able to bring both perspectives to the bench. As a prosecutor I strive for justice. As a Judge I would do the same.

Beyond that, a judge has to maintain an even temperament while treating everyone with respect. I have dealt with the public for years, so I believe I possess the skills necessary to uphold the dignity of the bench in a manner that is respectful of all who come before it.

I am very active in the Lewisburg Lions Club which participates in several community events

Additionally, I am in Leadership Marshall, which has the purpose of encouraging people from all walks of life to become leaders in their community, which hopefully has the effect of improving our community. I will continue to be a part of that, and certainly will strive to make my community a better place.

My family and I routinely attend civic events here in Marshall County and in the surrounding communities. We have attended law enforcement remembrance ceremonies and September 11<sup>th</sup> services. We have also given our time and money to events that promote cancer awareness and child abuse prevention. We will continue to support events like that. We also enjoy supporting our local high school by attending football and basketball games. Lastly, our children are on community league sports teams. Because of this, we are frequently on the sidelines of a local ball field.

My exposure to the courtroom began at an early age. My dad was a court reporter, and on occasion I would go with him to work. He worked in a rural judicial district very similar to the Seventeenth Judicial District. In Court, I used to marvel at how the lawyers would conduct themselves or how the Judge always knew the right thing to say. My dad also instilled in me the belief that the Judge was the person of the highest integrity and deserving of the utmost respect. That is a belief I carried into my adult and professional life. Opinions vary widely about the judicial system, but I believe it is our obligation to maintain the integrity of the Court in an effort to increase respectability. I will work tirelessly in that regard.
