6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My practice involves primarily domestic relations cases. I would delineate the percentages as follows: Divorce (60%), Post-Divorce Modifications (20%), Paternity (10%), Dependency and Neglect Cases (2%), Termination/Adoptions (5%), Child Support (2%), Other (1%).

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I began my legal career at Reed & Associates. Like many new lawyers, I took judicial appointments from the criminal dockets, juvenile dockets, and probate dockets before I found my niche. During this time, I served criminal defendants in the Juvenile, General Sessions and Circuit Courts. I also served as a parent-attorney in cases involving dependency and neglect, and termination cases. I also enjoyed serving as guardian ad litem in conservatorships. Early in my career, I also assisted a seasoned attorney in workplace discrimination cases. As my practice became more established, I began to focus on Divorce, Post-Divorce Modifications, Enforcements, Child Support, and Juvenile Cases. I have represented litigants in the Tennessee Court of Appeals, including representing an indigent person in a termination of parental rights case. I have tried many bench trials in the following Tennessee counties; Bedford, Cannon, Coffee, Davidson, Lewis, Lincoln, Rutherford, Marshall, Maury, Moore, Sumner, Warren, and Williamson. I have served as a substitute teacher for Judge Don R. Ash at the Nashville School of Law, teaching Civil Procedure. I have also been an adjunct professor at Middle Tennessee State University, teaching Family Law for the Political Science Department. I currently serve as a legal advisor to Tennessee Representative Bryan Terry which has also allowed me the

opportunity to draft and contribute to legislation.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

Prior to the <u>Obergefell v. Hodges</u> opinion, I represented a woman who was involved in a same sex relationship. The woman was the only person to adopt a child under law and her partner sued her for custody/parentage over the child. I represented the biological mother from the trial court level through the Tennessee Court of Appeals. In that case, the Court held the biological Mother was the only parent and her partner was not entitled to visitation with the minor child. In re: Hayden C. G-J, M2012-02701-COA-R3-CV.

Since Obergefell, the case law is evolving and unclear. I was also involved in litigation regarding a father's rights in a parentage action where two spouses agreed to undergo artificial insemination using a friend as a donor. However, the birthing spouse also was intimately involved with the donor without her spouse's knowledge. The question became who was the legal parent to the minor child. After years of litigation, the parties were able to settle the case outside the court system. In re: B.D.A. (d/o/b 09/04/2009) Rutherford County Chancery #5CV-1351.

In 2016, I filed an ouster suit against our local sheriff. We were successful in his temporary removal and upon his plea of guilty in the Federal Courts, the case became moot before the final trial. James Robert Gann, III et al. v. Robert F. Arnold, Rutherford County Chancery #16CV-1500.

I am involved in interesting conservatorship case where the ward has married and had children after the conservatorship was in place, but is still not competent to handle his own affairs and the conservators are wishing to be removed. The case was to be a possible removal of the conservatorship but now has me investigating other legal issues that have presented as to the validity of the marriage, the status of the children, etc.

I am also admitted to the United States District Court for the Middle District of Tennessee (April 2009), and the United States Supreme Court (January 2011).

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

I have served as a Rule 31 mediator to numerous domestic cases since receiving my certification in February 2014. While each one was noteworthy and significant to the parties, none were of specific legal significance. Most of the cases involved identification and division of assets, development of parenting plans, setting child support, and alimony.

I have also had the pleasure to serve on the board for Help for Nicaragua, a 501C3 organization that serves the indigent and poor in the rural mountains of Nicaragua. In that role, I have had the privilege of getting to know the legal system in Nicaragua and assisting the board with legal issues here in the United States. This experience has given me an even greater respect for our system of justice in the United States. I also enjoyed teaching at Middle Tennessee State University, and on rare occasion at Nashville School of Law.

This is my second application to serve in any public office. In 2017, I applied for the opening of the Circuit Court Judgeship left vacant by the passing of Judge Keith Siskin, but was not selected.

I have been required to respond to one complaint with the Tennessee Board of Professional Responsibility. A complaint was made by an opposing pro-se litigant in a child custody matter. The pro-se litigant complained because I had represented her current boyfriend in his divorce years prior, and she believed I had a conflict of interest representing both her prior boyfriend and

father of her child. The Board dismissed the complaint without merit.

(2005) John C. Kersey, Sr. v. John W. Bratcher, et. al, Rutherford County Chancery Court #05-1491MI. John Kersey, a disbarred attorney, came to the Rutherford County Clerk and Master's office seeking a file for review. The clerk explained the file was in the office of Judge J. Mark Rogers for review and recusal. The Plaintiff insisted on seeing the file and I agreed to allow him to come to the Judge's office to review the file. Upon his entry with two deputies, I handed him the file and directed him that he could sit on the office couch to review the file. Instead he insisted in standing over me in my personal space. I again explained he could sit on the couch to review the file wherein he became belligerent and loud. The Judge was on the bench at that time and the Plaintiff's belligerence could be heard in the courtroom. The deputies escorted him out of the office. He filed a complaint stating the Clerk's office and I had violated the public records act. His complaint was dismissed by Summary Judgment. The Petitioner appealed to the Court of Appeals and the judgement of the trial court was affirmed. (M2006-01319-COA-R3-CV September 2007)

(1996) Corporate Catering, Inc. v. Corporate Catering, Etc. Davidson County Circuit Court #96C-903. The owner of a company named Corporate Catering, Inc. filed a common law copyright case against my company Corporate Catering, Etc., LLC. My company had purchased many assets of the previous company through a bankruptcy auction, including the telephone number. The petitioner claimed that he had a common law copyright on sandwiches we

produced and the name we used. After a jury trial, the trial judge, acting as the 13<sup>th</sup> juror, dismissed the complaint stating Tennessee did not recognize common law copyright and that his complaint stated claims upon which he could not find relief. The Plaintiff filed an appeal with the Tennessee Court of Appeals M1997-00230-COA-R3-CV, wherein the Court of Appeals affirmed the judgement of the trial court.

I have never had the privilege to serve in any public office nor have I previously been a candidate for any public office. I was an applicant for the Circuit Court Judge position vacated by the death of Judge Keith Siskin and appeared before this committee

### ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

I am seeking this position because I have a desire for public service and a strong sense of justice. I believe my personality, temperament, legal experience and life experiences make me best equipped to be a judge at this time in my life. I was taught about how to be a jurist by some of the best on the bench. They taught me about jury trials, how to be an effective public servant, to show grace and mercy while being able to administer justice. My legal career has expounded on those lessons and has allowed me to utilize the skills of so many who invested in me. I have experience in several areas of the law and have significant experience in domestic and family law matters. I also have the life experiences of being divorced, being part of a blended family, and learning to thrive in the roles of step-parent, parent, and wife. I, along with my sister, have now assumed the role of caretaker of my Mother. Most of all I am blessed to be a woman in a profession I love which lends me a perspective different than my male colleagues. All my experiences have prepared me for this important and meaningful opportunity by allowing me to understand a litigant's perspective. I wish to have a legacy to leave to my children and

grandchildren of which they can be proud and demonstrate to them the value of public service.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

As our laws and society progress, there seem to be fewer jury trials in our county. A majority of the cases being heard in Rutherford County are domestic cases. Due to our rapidly growing population, Rutherford County currently has five trial judge positions adding this as a sixth position. As I understand it, this position will be a civil position with an emphasis on the domestic docket. Although each jurist has his own way of approaching his docket, the perspective of a female jurist brings more diversity to the bench, offers a unique perspective, and serves as a role model to young citizens. I believe Rutherford and Cannon Counties need a female perspective to properly reflect the demographics of our judicial district and to add balance to our current bench.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

It is crucial a judge uphold the law despite his/her personal feelings. The rule of law gives people expectations and allows them to trust the independent judiciary. I sometimes hear my clients complain a judge was not fair to them. However, I explain to them that often it has nothing to do with the judge and everything to do with the law. Laws are not fair to all people all the time. I can think of numerous incidences where the law was not fair to someone, but it was crucial it be followed. I was involved in a parenting plan modification case wherein the parties were never married, and their first parenting plan was entered by the Rutherford County juvenile court. The Mother moved to Williamson County and the Father continued to live in Rutherford County. Because the Father continued lived here, Rutherford County maintained jurisdiction in the modification petition. Father went through several attorneys, continually delaying the trial. A month before the final hearing was scheduled, Father moved to Williamson County. One week before the trial was set to commence, his counsel filed a Motion to Transfer the case to Williamson County, which would again delay the trial. The case had been set by agreement of the Father, but his deliberate move to Williamson County required the Court to transfer the case and delayed trial. I was furious, but I had to acknowledge that despite the child needing permanence, I could not argue that the law disfavored his position. It was not fair to the child, nor to my client who needed closure, and she was devastated. However, instead of getting angry at the situation I got to work and drafted an amendment to that statute and worked with my local legislator to get the statute changed.

Similarly, I had a case involving a same-sex relationship wherein my client, during the relationship, adopted a child. My client's significant other helped raise the child, and upon splitting, the significant other sued her for custody/visitation of the child. I had researched the law extensively and assured my client that the law was in her favor. Her significant other did not

have a legal relationship to the child and therefore was not entitled to visitation or custody of the child. I immediately filed a Motion to Dismiss for failure to state a claim for which relief could be granted. It was denied. I filed a Motion for Summary Judgment. It was denied. I filed an interlocutory appeal. It was denied. I began to doubt myself a bit. However, I knew I was right. My client spent thousands of dollars for me to advocate for her position all the way through a trial. After two days of trial, the judge ruled that the significant other did not have a legal relationship to the child, and therefore was not entitled to visitation or custody. My client was very frustrated the judge did not grant her motion in the first place. Although I felt the system I believe in let this person down, I explained to my client that novel legal situations deserve research and inspection, and the trial judge in this case needed time to come to the correct legal conclusion. I felt badly for her significant other as I know she loved this child. However, the right outcome according to the law was achieved.
