Report on the Tennessee Supreme Court's Business Litigation Pilot Project

JUNE 1, 2016

HISTORY

The Tennessee Supreme Court, by order entered in March, 2015, established the Business Court Pilot Project. The Supreme Court initiated this docket to handle the complex litigation needs of existing and future businesses in Tennessee by providing expedited resolution of business cases by an experienced judge with expertise in handling complex commercial cases. Chancellor Ellen Hobbs Lyle of Davidson County Chancery Court, Part III, presides over the Business Docket. The specialized pilot docket began accepting cases on May 1, 2015.

BENEFITS OF THE BUSINESS PILOT PROJECT

The Business Court Pilot Project provides a well-organized, predictable process for the litigants. The goal is the efficient administration of justice — saving time and money for litigants.

Some of the key features of the project:

- Proactive case management by the court
- Pre-hearing judicial review of pleadings, briefs, and the law for efficient use of parties' time in court
- Appointed times for hearings so parties do not wait for other cases to be concluded
- Hearings conducted by telephone when appropriate
- Rulings within 30 days of hearings
- Consolidation of motion hearings
- Ruling on the papers when appropriate
- Employment of robust case litigation plan
- Use of alternative dispute resolution
- Use of technology including electronic filing
- Respect for litigants' time and resources

CASES

The Pilot Project includes a wide range of cases with contractual and corporate disputes being the most prevalent conflicts. Many litigants seek immediate action in the form of expedited discovery, injunctive relief, and accountings. Requested monetary relief in cases has ranged from \$100,000 to more than \$15 million.



PROCESS

To participate in the Pilot Project, a party files a request for designation, and all cases must receive approval by the Chief Justice of the Tennessee Supreme Court for transfer.

Litigants have the opportunity to evaluate the processes and share their experience with the Business Pilot



Project after resolution of the case by completing a 31-question survey designed to elicit feedback that will be used to enhance the experience for future litigants. The survey addresses discovery processes, cost effectiveness, timely resolutions, case management practices, and seeks general improvement suggestions.

ADVISORY COMMISSION

Key to the implementation of the pilot was the establishment of a Business Court Rules Advisory Commission composed of eight attorneys – including in-house corporate counsel as well as recognized private attorneys with combined business litigation experience of over 150 years. The Commission is chaired by Tennessee Court of Appeals Judge Neal McBrayer and is tasked with studying the activities of the Pilot Project, creating a data repository, and reviewing monthly updates from the Chancellor.

To date, the Commission has developed a survey to gage the experience of each litigant and attorney taking part in the pilot, evaluated survey responses, reported to the Chief Justice concerning attorney experience, and made recommendations on procedures and case criteria. The Commission is currently considering next steps for the pilot.


