Currently I serve as the full time Juvenile Court Magistrate for Rutherford County, Tennessee. I hear cases including: the IV-D child support docket, dependency and neglect, termination of parental rights, delinquent and unruly, temporary and final hearings on child custody and visitation cases, and surrender of parental rights. I am on-call for after hour determinations regarding detention of juveniles and removal of children by the Department of Children's Services. Additionally, I assist the Juvenile Court Judge with various administrative duties including, but not limited to: scheduling and maintaining dockets, liaison with various law enforcement departments to assist with issues involving juveniles, liaison with various county departments to address budgetary and other necessary administrative issues involving Juvenile Court and revising the local rules of practice for Juvenile Court.

In my practice I appeared regularly in all courts to include: General Sessions-civil and criminal, Probate Court, Juvenile Court, Circuit Court-civil and criminal, and Chancery Court. I represented clients in areas of criminal defense practice, general civil litigation primarily involving business and real estate matters, and domestic litigation. I appeared before the Probate Court as Attorney for the Estate, Guardian for incompetent beneficiaries or the proposed ward, and as Court-appointed Administrator. #### ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

I seek this position to fully utilize my professional, educational, and personal experiences to be of service to the people of the Sixteenth Judicial District. It has been my privilege to serve the people of Rutherford County as Juvenile Court Magistrate. I feel that the experience gained in my current position along with my other professional experience will provide me with a unique opportunity to be fully prepared to take the Circuit Court bench and be of service from day one. The Circuit Court position will provide me an opportunity to engage in subject matter across multiple areas of the law in which I have experience while still being able to utilize my knowledge and experience gained as Juvenile Court Magistrate.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

This position is a new appointment to the Circuit Court bench for the Sixteenth Judicial District. The district covers all of Rutherford and Cannon Counties. The district currently has four Circuit Court Judges and the Chancellor. This position will be the fifth Circuit Court Judgeship. Being a Court of general jurisdiction, the Circuit Court presides over criminal court, domestic litigation, and general civil litigation of all types. I am not aware if the Presiding Judge has assigned a specific docket or area of law to this new position, but I am fully prepared to preside over all manner of cases under the Court's jurisdiction. I believe my experience on the Juvenile Court bench and diverse legal background will allow the Presiding Judge to utilize me immediately to assist the Court in expediting the hearing of dockets in a timely manner.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute

or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

As Juvenile Court Magistrate I regularly hear parentage cases as part of a child support action or as part of a request for parenting time. The initial question in these cases involving children born out of wedlock is to determine the child's father. Often times, there has been a voluntary acknowledgment of paternity (VAP) pursuant to T.C.A. § 24-7-113. The statutory provisions contained therein state that the acknowledgment is conclusive as to the issue of parentage unless a party brings an action to set aside the VAP. The burden is on the petitioner to prove fraud, material mistake of fact, or duress. After five years, the only ground for setting aside the VAP is fraud by the mother in the inducement of the signature by the purported father. Under the statute, these findings are required before a court can order DNA testing. This statutory mechanism leads to results that are often not reflective of a child's actual biological father being determined to be the legal father thus placing the determination of who is a child's legal father on the VAP and not in the science of DNA testing. Despite my misgivings about the soundness of reasoning behind the statute, I have, on many occasions and will continue to, enforce these statutory provisions as dictated by the legislature.
