6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My current practice focuses on insurance defense litigation and workers' compensation. In June, 2018, roughly 60% of my hours were in the areas of insurance defense and premises liability. Workers' compensation accounted for the remaining 40%. Those percentages fluctuate by month.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

My entire career has been in litigation. I started my career primarily working in the areas of medical malpractice defense and the defense of long-term care facilities. After roughly four years, I began to also defend products liability and commercial litigation matters. I additionally handled insurance defense claims during that time. After changing firms in 2012, my focus has been primarily in the insurance defense and workers' compensation fields.

I am licensed to practice in Tennessee and Kentucky. I have been admitted to practice before the Middle, Eastern, and Western Districts of Tennessee, and the 6<sup>th</sup> Circuit Court of Appeals.

I have tried cases, handled multiple appeals, and generally defended lawsuits all across Tennessee and in other state and federal jurisdictions. As part of this, I have drafted hundreds of motions and attended hundreds of depositions. I am very familiar with the litigation process.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

I have represented a Tennessee nursing home industry group as amicus curiae before the Tennessee Supreme Court. I have been counsel on multiple appeals to the Tennessee Court of Appeals, and I currently have a premises liability case on appeal to the 6<sup>th</sup> Circuit. I have represented individuals and companies in state and federal courts across Tennessee and in other jurisdictions.

I have a broad range of litigation experience and have at least a basic understanding of the laws

applicable to many types of claims likely to be before me as a judge. Additionally, because I have defended claims in multiple jurisdictions, I have experience with researching and teaching myself laws and procedures about which I was not previously aware. I am additionally a trained Rule 31 mediator. I believe I know how to be a good judge, because I have experience with both excellent judges and judges that fell short of that standard.

#### ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

I enjoy the academic challenges of the law, but the adversarial nature of litigation practice is undesirable. I have been described by one colleague as "too reasonable," and I seek to avoid the contentious — and frequently unnecessary — disputes that arise in litigation, whenever possible. Additionally, I went to law school to be in court, but as the years pass, it seems I am in court less and less. Ultimately, I believe I am well suited to being a judge. I have a very even, respectful temperament, I have years of experience in many areas of civil litigation, and I understand the importance of fairness and impartiality.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking a position as a Circuit Court Judge in the 21<sup>st</sup> Judicial District. I live in Franklin, but I am comfortable travelling to Hickman, Lewis, and Perry Counties, as well. I believe my selection would give the court a hard-working, respectful, and impartial judge that would assist in making the other divisions' dockets more manageable.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Absolutely. I fully believe in impartially enforcing the law as written. While I respect the significant majority of judges I have been before, I have, at times, had situations where my clients were treated unfairly by biased judges. I believe that when those situations occur, it damages the credibility of the legal system as a whole.

As an attorney, I have had multiple cases where I believed my client was in the wrong. Nonetheless, I provided them the best legal defense I could within the scope of the Rules of Professional Conduct. For instance, in one medical malpractice case, multiple experts indicated to me that my client negligently caused a patient's death. Nonetheless, I continued to vehemently defend the claim until a settlement could be reached. There have been several other instances in which I defended clients that I questioned or did not respect. Despite my concerns, they were entitled to competent representation.

Whether attorney or judge, the legal obligations imposed by the law should be followed, regardless of one's personal feelings.
