6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I operate a general legal practice, representing individuals and small businesses, with emphasis on Tax Resolution (20%), Probate and Estates (20%), some Employment matters (5%), Bankruptcy Litigation (5%), Real Estate Matters (20%), Business Law (20%), as well as Environmental law (10%), mostly concentrated in the field of solid waste. The areas of concentration have, naturally, evolved over time. I practice appellate law as the need arises. My cases span the state, and I routinely have active cases in each of the three grand divisions of Tennessee, both in state and federal courts. My practice also frequently finds me in front of a county planning board or zoning commission, both in formal and informal appearances, as well as state administrative bodies. While almost all of my work is in civil law at present, I have regularly practiced criminal law at the General Sessions, Circuit, and even federal level, during the last eighteen years. I do not particularly enjoy criminal law, but am competent in such discipline, having consistently done quite well in such cases. My tax work of several years, is before the IRS and state Departments of Revenue. I regularly negotiate tax settlements on issues of tax liability and collection.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I returned from Jackson, Mississippi, to my hometown of Clarksville, Tennessee, for good, in May, 2003, having been notified of my passage of the Tennessee Bar Exam. Turning down a few other opportunities in favor of home, I opened a small office away from downtown, and began a practice. I immediately began taking whatever cases came in the door and with which I felt comfortable. These were mostly divorces, criminal cases, and wills and power of attorney matters. However, it was suggested I practice Bankruptcy law, which I did, filing almost 1,000 cases in my first 12 years. My practice continued as a general practice, but I found I was best at business and contractual matters, real estate disputes, and issues dealing with debtor / creditor relationships. Others got into Bankruptcy so I slowed down in that area, doing mostly litigation in such venue. As set out in my response to Paragraph numbered 6, above, probate and environmental law made a strong appearance in my practice, and I found that I increasingly was representing small businesses with both the business matters and the owners' personal legal concerns. I have also handled many estate recovery cases from inception to close, on behalf of TennCare, across the state.

Throughout my years of practice, I have always tried to be different from other attorneys. The danger I knew I faced and had to overcome by setting up shop in my hometown, was not to become complacent. Therefore, I have always taken interesting and "exotic" cases from out of town, and participated in the Tennessee Bar activities when possible or expedient. I operate outside of my comfort zone, broadening my speaking ability by making presentations at seminars, and speaking to small groups from time to time. This need for self-development was also the reason I pursued my recent stint with the Army at Fort Campbell. I always felt military service was missing on my resume, and this was the closest I could get at age 47. Indeed, that 7-month experience familiarized me with the simplest areas of the law again, but most importantly, the individual emotions of people which accompany them. The foregoing 18 years have made me capable and ready to be Circuit Court Judge in the 19th Judicial District.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

The case of <u>Venture Holdings, LLC v. Metro. Gov't of Nashville & Davidson Cnty.</u>, 585 S.W.3d 409 (Tenn. Ct. App. 2019) is a reported case, embodying this lawyer's work from a board of zoning appeals all the way through denial of certiorari in the TN Supreme Court.

Two other cases I am particularly proud of come to mind.

First, I represented a member of a closely-held corporation, who had signed as guarantor with several others, to secure a large loan for the business. When the note came due, the other guarantors filed bankruptcies, as did the business, which left my client solely liable for the debt. The creditor came after my client. I was able to use the Uniform Trade Secrets Act to file a counterclaim against the creditor, for conduct during the liquidation sale, where certain of my

client's intellectual property had been misappropriated. This leverage allowed a \$1.6 Million debt to be settled for \$220,000.00. This was life-changing for my client.

Next, in the course of a Chapter 13 case, my Debtor clients paid their Plan payments religiously for years. However, a particular mortgage creditor did not follow the rules for filing its claim and other procedures. There had been perceived misconduct on this creditor's part during the life of the loan. Consequently, I was able to void the lien of this creditor, and wipe away the mortgage debt on the elderly couple's residence at the conclusion of the Chapter 13 case. This helped the clients immensely in their later years.

I have responded to nine (9) formal complaints filed with the TN Board of Professional Responsibility, throughout my 18-year practice.

All complaints except one (1) were dismissed by the Board, such being related to the <u>Brandt</u> case, as listed below in Paragraph numbered 22. I was censured by the Board for not maintaining proper boundaries among the competing client interests in the midst of which I found myself. I had practiced for about 18 months when the case came about, was careless, and "fell victim to fraud." The entire experience made me a better attorney.

I was dismissed from the lawsuit, and the Plaintiff was made whole through judgments taken against the other Defendants. The real estate agent went to federal prison.

Aleo v. Weyant, No. M2013-00355-COA-R3-CV (Tenn. Ct. App. Dec. 12, 2013); a former divorce client suggested I had mishandled her divorce. The suit was dismissed by the TN Court of Appeals, on the basis of the statute of limitations, and where it was apparent that the client's

subsequent attorney was the obvious cause of Plaintiff's damages.

28. What are your reasons for seeking this position? (150 words or less)

Montgomery and Robertson Counties constitute my home. I say that about both Counties, because, truly, my most memorable social and professional endeavors have taken place in these communities. Of the two County seats, I certainly practice more in Clarksville. However, I have consistently filed cases and had a presence in Springfield, during each year of my practice. My favorite restaurants are in these towns, long-time college acquaintances reside therein, and most of my closest friends live in the 19th Judicial District. This is where I have built my life. To serve as Judge in this locality would give me a great sense of pride, as I would be providing a public service to my own community and those I care the most about, to include my three sons. As previously mentioned, I made the decision to stay here after law school, and I want to give my very best to the people that know me as a professional, and a vested part of this District. Moreover, I am amply prepared, personally and professionally, to advance to this level of service.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

Robertson and Montgomery Counties are on the verge of tremendous growth. Each wants to be a big city so desperately, and are visibly bursting at the seams. However, this has been at the expense of infrastructure, traffic patterns, and available amenities, that have flatly not kept up. Our legal system in the 19th Judicial District is just as burdened. We have only five Circuit Judges and one Chancellor, for just under 300,000 citizens. Thus, I would come to work on Day One ready to work. I am energetic, creative, decisive, and engaged. I will stay as late as necessary to get the docket done. I also am interested in establishing a Business Court here, as Davidson County has. Chiefly, however, I would be a judge who is visible in the community, and this on a daily basis. In my view, judges tend to isolate themselves after taking the Bench, and people notice and comment on their scarcity. As a judge, you would see me in the local restaurants, stores, and about our two cities, just as now. I grew up seeing such judges here.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

The case of <u>Venture Holdings, LLC v. Metro. Gov't of Nashville & Davidson Cnty.</u>, 585 S.W.3d 409 (Tenn. Ct. App. 2019), is a case I strongly disagree with. Granted, it remains a leading reported case on the issue of substantial and material evidence in the context of reviewing an administrative decision of a zoning board. However, in this instance, the fears, concerns, and conjecture of neighbors were allowed to stand as material evidence. To me, that concession seems against the extensive precedent on the issue, which I have heretofore researched. I was personally involved in this case, being both counsel of record, as well as the single member of the LLC Plaintiff, in a matter I took from the Board of Zoning Appeals, all the way to the Tennessee Supreme Court. It took up nearly two years of my life, and a lot of my savings. However, my strong personal interpretation of what I think should be the law is not germane when overseeing a case as judge. A trial judge shall apply the law, not seek to change it. I would have no difficulty applying the Venture Holdings case to a set of facts as judge. I fully respect the law and its finality on this particular subject.
