1. State your present employment. I am currently in the private practice of law as the Owner of Griffin Law Group, PLLC. 2. I was licensed to practice law in TN on October 20<sup>th</sup>, 2013. My BPR number is 032138. 3. Indicate the date of licensure and whether the license is currently active. If not active, explain. I have only been admitted to practice law in the State of Tennessee. I am admitted to federal practice in the Middle District of Tennessee and was admitted on December 1st of 2014. 4. I began private practice as a solo practitioner in October of 2013. I entered into a space sharing agreement with attorney Michael Rocco in January of 2014. We became law partners and founded Rocco & Griffin PLLC, in January of 2015. We continued to run a small law firm together until July of 2017 when Michael Rocco decided to sell his portion of the firm to attorney Tyler Davis. In July of 2020 Tyler Davis and I decided to part ways thus splitting the firm into two new entities. Mr. Davis took the Kingston office and I received the Sparta office. The firm was renamed as Griffin Law Group, PLLC which I still own and operate to this day. I

currently have three associate attorneys working for me along with 4 staff members.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My current practice includes most of the areas of law that arise in a small-town including estate planning, probate, criminal defense, juvenile, real estate, civil litigation, collections, contracts, bankruptcy, and family law. My associate attorneys handle the bulk of the family law cases and the civil litigation. I personally handle the real estate closings, estate planning, probate administration, civil collections, and a large number of criminal defense cases. My current practice including those cases held by associates working for me is approximately fifteen percent (15%) real estate, thirty percent (30%) criminal defense, five percent (5%) collections, fifteen percent (15%) juvenile law, fifteen percent (15%) family law, two percent (2%) bankruptcy, three percent (3%) contract drafting, five percent (5%) estate planning, five percent (5%) probate administration, and five percent (5%) civil litigation.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have had the pleasure to handle a wide variety of cases. I have conducted multiple criminal jury trials to verdict and numerous bench trials on Civil, Family, and Juvenile cases. I have handled several class A felonies including cases that involved wire taps and extensive discovery. I have also been blessed to have a large enough client base that I have been able to practice law in every county in the 13<sup>th</sup> Judicial District along with the 31<sup>st</sup> Judicial District. I have appealed cases to the Court of Appeals. I have also handled administrative issues such as who was qualified to run as a Board Member of a local Utility Cooperative. Lastly, I have had the pleasure of helping some of our local veterans plan their estates. I believe in giving back to our community by serving our veterans and first responders by planning their estates, free of charge.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

In 2015 I appealed a termination of parental rights case for the Putnam County Juvenile Court to the Court of Appeals. The Case is *IN RE William B.*, 2015 WL 3647928. This was a difficult case, and I am proud of the quality of the legal writing I did on behalf of the client in this matter despite the matter ultimately being affirmed.

I was a student attorney the last semester of my 3L year at Cecil C. Humphrey's School of Law in the Elder Law Clinic.

I have not submitted any prior applications for a judicial position. The only other time I have sought judicial office was when I ran for the office of General Sessions Judge of White and Van Buren Counties in 2022 ultimately coming in second place in a five candidate race for the Republican Primary.

Humphreys School of law from August of 2010 until May of 2013. I received my Juris Doctor Degree from Cecil C. Humphreys School of Law on May 12<sup>th</sup>, 2013. I was in the top quarter of my class and during my time at Cecil C. Humphreys I received CALI awards in two classes. Those two classes were Decedent's Estates and Admiralty Law.

In full disclosure I did receive a letter once several years ago from the Consumer Assistance Program with the Board of Professional Responsibility for an individual who alleged I did not inform him that he could post-convict his counsel for his third violation of probation case in which he was found in violation and revoked to serve his sentence. I responded to the letter and sent the individual the case law in Tennessee clearly stating that defendants do not have the right to post-convict violation of probation counsel. I never heard anything else back from either the defendant client or the CAP program after my response letter.

It is my desire to put the legal expertise and skill I have gained in my extensive career as an attorney operating a firm to work assisting the citizens of 13<sup>th</sup> Judicial District. I have handled numerous criminal cases and I know that I have a deep understanding of the Criminal Law and Constitution of our great State of Tennessee and the United States of America. I strive to be an asset for my community and a defender of the Constitution. I hope that citizens from all walks of life will feel confident that those appearing before my Court if I am fortunate enough to be appointed will be treated professionally because they know that I will uphold the laws by making sure those who are convicted of crimes are sentenced appropriately.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking the position of Criminal Court Judge in the 13<sup>th</sup> Judicial District which contains seven counties, Putnam, Cumberland, White, Overton, Dekalb, Clay, and Pickett, all of which are rural areas. The Judge's main duties would be to impanel jurors, decide motion hearings, decide probation violation hearings, arraign defendants, appoint counsel to indigent defendants, preside over criminal jury trials, and accept plea agreements. There are two other Criminal Court Judges, two Circuit Judges, and one Chancellor in the district. I would be able to help add court dates to the smaller counties who have a limited number of days due to how stretched our two current Judges are despite their diligent efforts. Having practiced in every single county in this district I am familiar with the needs of each county and will get to work immediately to improve access to our court system.

Yes, I assisted a pair of clients in ejecting an elderly man from a home and property that they had bought at a foreclosure sale. I felt empathy for the elderly man, but I had been hired by my clients to get this individual off of their property so that they could proceed with repairs on the home and ultimately put it up for sale. My clients were legally in the right and had lawfully purchased the property. I moved forward with the case professionally and was as civil with the elderly man as the situation would allow. I was ultimately successful in ejecting the man from



the property. While I had done everything ethically, correctly, and successfully for my clients I did not enjoy the victory. In regard to a Criminal Court Judge position, I would uphold the Constitution above all else. I would suppress any evidence that was gathered in violation of the Constitutional rights of our citizens. I would do this even though I detest the idea of a criminal getting to walk free when they are otherwise clearly guilty. Benjamin Franklin once stated "The law holds that it is better that 10 guilty persons escape, than that one innocent suffer" and this quote has always been foundational for myself during the practice of law.
