PROFESSIONAL BACKGROUND AND WORK EXPERIENCE

1. State your present employment.

I am presently a partner at Beal, Nations, & Crutcher.

2. State the year you were licensed to practice law in Tennessee and give your Tennessee Board of Professional Responsibility number.

I was licensed to practice law in Tennessee in 2009 and was assigned Board of Professional Responsibility number 026930.

Upon completion of my legal education, I was still employed by the Williamson County Circuit Court Judges' Office, where I had worked throughout law school as a law clerk to now Chief Justice Jeffrey Bivins, now Court of Criminal Appeals Judge Timothy L. Easter, now Senior Judge R.E. Lee Davies, and Judge Robbie Beal.

After passing the bar examination, I accepted an *of counsel* position with the firm of Sidwell and Barrett, P.C. in Franklin, Tennessee. I remained in that position from 2010 until 2014, when Judge Robbie Beal left his position as Williamson County Circuit Court judge. Judge Beal and retired United States Attorney and Williamson County General Sessions Judge Ernie Williams invited me to open a new law firm with them. I accepted and the firm at which I am presently employed was formed in September of 2014 as Williams, Beal, & Nations. I have been employed continuously as a partner at that firm since then.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

While I began as a general practitioner, my practice has evolved over the years into primarily a family law focused practice. Divorce and child custody constitutes approximately 70% of my present practice. I also practice in the areas of criminal defense (approximately 10%), estate planning and probate (10%), and general civil litigation (10%).

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have been a trial attorney since I was licensed in 2009. My courtroom experience, however, began in 2007 when I was hired as a law clerk to the Williamson County Circuit Court judges. I was in the courtroom each day with the judge to whom I was assigned. The years I spent in that position shaped my legal career. I learned from highly experienced and respected judges and lawyers during those years and that experience gave me the confidence and skills necessary to successfully practice law.

In addition to my experience as a trial attorney, I have been asked on many occasions to sit as Special Magistrate in the Juvenile Court for Williamson County, Tennessee. On those occasions, I heard and ruled upon cases on the docket, which were primarily child support matters. I interacted with litigants, attorneys, courtroom and clerk's office personnel and the Juvenile Court Judge in order to successfully complete each docket.

In 2010, I was appointed by Judge James G. Martin, III of the Williamson County Chancery Court to serve as special master in a highly contentious divorce matter. This experience provided me with additional judicial experience in a Chancery Court capacity.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

While I do not believe that any of my appellate cases necessarily deserve special note, I have been involved in multiple appellate cases, including the drafting of briefs and appearances at oral arguments in both the Court of Appeals and the Court of Criminal Appeals.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

While my election to the Williamson County Commission does not necessarily require a legal education, my experience as an attorney has certainly proven useful in my capacity as a legislator in that body. My knowledge of the law has been an invaluable resource on many occasions during my tenure as a commissioner. I have served on the Law Enforcement and Education Committees, and this fiscal year I was selected by the County Mayor to serve on the Budget Committee.

Additionally, while not exactly my own legal experience, I believe it is important to know that I am married to a Williamson County Sheriff's Deputy who has been a law enforcement officer in our county for twenty years. Through this marriage, I have gained insight into the challenges and issues faced by our law enforcement community each day.

This is my first application for any judicial position.

I was employed full-time throughout my college career as a server, in addition to completing an internship in a local law office and working as a paralegal in a Nashville law firm.

Yes. I was the plaintiff in a divorce matter in Davidson County Circuit Court in 2008, wherein I was granted an agreed irreconcilable differences divorce.

I have also been the plaintiff in collections actions against clients who have failed to comply with their contractual financial obligations. Those cases have all been filed in the General Sessions Court of Williamson County. I have provided the docket numbers and dispositions of each case below, but have utilized each defendant's initials rather than their full names in an effort to protect their privacy:

Erin Nations v. R.P.A., filed on 2/11/2013 under docket number 2013-CV-407: the client promptly paid the balance and the case was dismissed.

Erin Nations v. J.R.Y., filed on 3/31/2014 under docket number 2014-CV-738: an agreed judgement was entered.

Erin Nations v. A.S., filed on 7/8/2022 under docket number 2022-CV-1587: a judgment was granted against defendant.

Erin Nations v. J.T., filed on 7/8/2022 under docket number 2022-CV-1588: service was never obtained on the defendant.

I have been the elected County Commissioner for the 6th District of Williamson County since 2018. I was first elected to a four-year term in August of 2018 and then re-elected in August of 2022 for another four-year term.

In 2014, I was a candidate for the position of State Executive Committeewoman for the Republican Party of Tennessee.

ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

I firmly believe that the citizens of Williamson County are entitled to continued access to equal justice under the law. I further believe that the future of that prospect is entirely dependent upon the willingness of competent, capable, and dedicated lawyers to serve their community in a judicial capacity. I have a deeply rooted commitment both to justice and to the community where I have lived my entire life and am now raising my own children. I am highly motivated to serve that community. I have served for five years as a County Commissioner and I now believe that I can most effectively serve my community in a judicial capacity.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

The 21st Judicial District is now comprised solely of Williamson County. There are four judges elected to serve the 21st Judicial District. All four judges serve as both Circuit judges and Chancellors, hearing both criminal and civil matters. As Circuit judges, they hear all Circuit Criminal matters as well as civil matters. Jury trials are relatively common on the Circuit side. The judges also sit as Chancellors, in which capacity they hear matters of equity. These matters include divorces, adoptions, conservatorships, guardianships, and probate matters. Williamson County recently approved a new position for a Probate Special Master, which relieved the Clerk and Master of the duties she was performing in that capacity, which I understand was very helpful to the judiciary.

My selection to the court would have an historic impact in that, for the first time in history, the 21st Judicial District would be comprised of more female judges than male.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I will absolutely uphold and enforce the laws of the State of Tennessee, whether my personal opinions or feelings agree with the substance of that law or not. I wholeheartedly believe that my personal feelings on any subject are entirely irrelevant to my duty to apply the law equally and without prejudice.

An example of my ability to put my personal feelings and inclinations aside in furtherance of the law occurred early in my legal career. I was appointed to represent criminal defendants on more than one occasion who were charged with crimes that were reprehensible to me as a person. However, as a lawyer, my job was to uphold the law and ensure that the laws and rules of court were followed and that my client was afforded the protections to which he/she was entitled under the laws of this state. I accepted that obligation entirely and without hesitation.

Another example comes from my family law practice, wherein I often must deal with matters relating to the welfare of children. I often feel that the best interest of the child should be the prevailing authority and should dictate the outcome of the matter. However, a best interest analysis often occurs secondarily to and in conjunction with other applicable statutes and case law. It is my job in representing a client to argue the law that is most beneficial to my client, regardless of any personal feelings.
