**RE:** Administrative Fee for Appointed Counsel

In 1997 the Tennessee General Assembly enacted Public Chapter 547 (T.C.A. 37-1-126 and 40-14-103) providing for the assessment of an administrative fee on all indigent criminal and juvenile delinquent defendants who are provided court appointed counsel. Court appointed counsel includes public defenders and private attorneys. The public chapter authorized an administrative fee between \$50 and \$200 per defendant. A separate law, Public Chapter 857 also requires the collection of additional data in cases in which a guardian ad litem is appointed in a juvenile dependency or neglect case.

The law specifically requires court clerks to submit monthly reports to the Administrative Office of the Courts. These reports contain the following information: the number of defendants appointed counsel and/or guardian ad litem, the number of cases in which a fee was assessed, the number of cases in which the fee was waived, and the dollar amount collected by the clerk's office and submitted to the Department of Revenue.

The attached summary information and detailed statistical reports contain information received from county court clerks outlining the administrative fees collected for 2024. The total Amount Collected by the state for 2024 was \$1,513,411.11 (Amount Retained/Clerk Fee: \$84,082.80 plus the Amount deposited to the Department of Revenue: \$1,429,328.31). There was a slight reduction of 3% from the amount collected in 2023, \$1,559,292.00, most likely explained by a 4% increase in guardian fee waivers of the Defendants (see page 8). Note that the total number of defendants appointed guardians or counsel increased by 3% between 2023 and 2024, whereas the number ordered to pay declined slightly which corresponds with the 3% reduction in fee collected.











## Total Amount of Fees Deposited to Department of Revenue
