
RE: Administrative Fee for Appointed Counsel

In 1997 the Tennessee General Assembly enacted Public Chapter 547 (T.C.A. 37-1-126 and 40-14-103) providing for the assessment of an administrative fee on all indigent criminal and juvenile delinquent defendants who are provided court appointed counsel. Court appointed counsel includes public defenders and private attorneys. The public chapter authorized an administrative fee between \$50 and \$200 per defendant. A separate law, Public Chapter 857 also requires the collection of additional data in cases in which a guardian ad litem is appointed in a juvenile dependency or neglect case.

The law specifically requires court clerks to submit monthly reports to the Administrative Office of the Courts. These reports contain the following information: the number of defendants appointed counsel and/or guardian ad litem, the number of cases in which a fee was assessed, the number of cases in which the fee was waived, and the dollar amount collected by the clerk's office and submitted to the Department of Revenue.

The attached summary of data and detailed statistical reports contain information received from county court clerks outlining the administrative fees collected for 2025. The total Amount Collected by the state for 2025 was \$1,590,787 (Amount Retained/Clerk Fee: \$86,804 plus the Amount deposited to the Department of Revenue: \$1,503,983). There was a 5% increase from the amount collected in 2024, \$1,513,411, most likely explained by a 16% decrease in guardian fee waivers of the Defendants (see page 5). Note that the total number of defendants appointed guardians or counsel increased by 1.5% between 2024 and 2025, and the number ordered to pay increased considerably: 67% which corresponds with the 5% rise in fees collected.

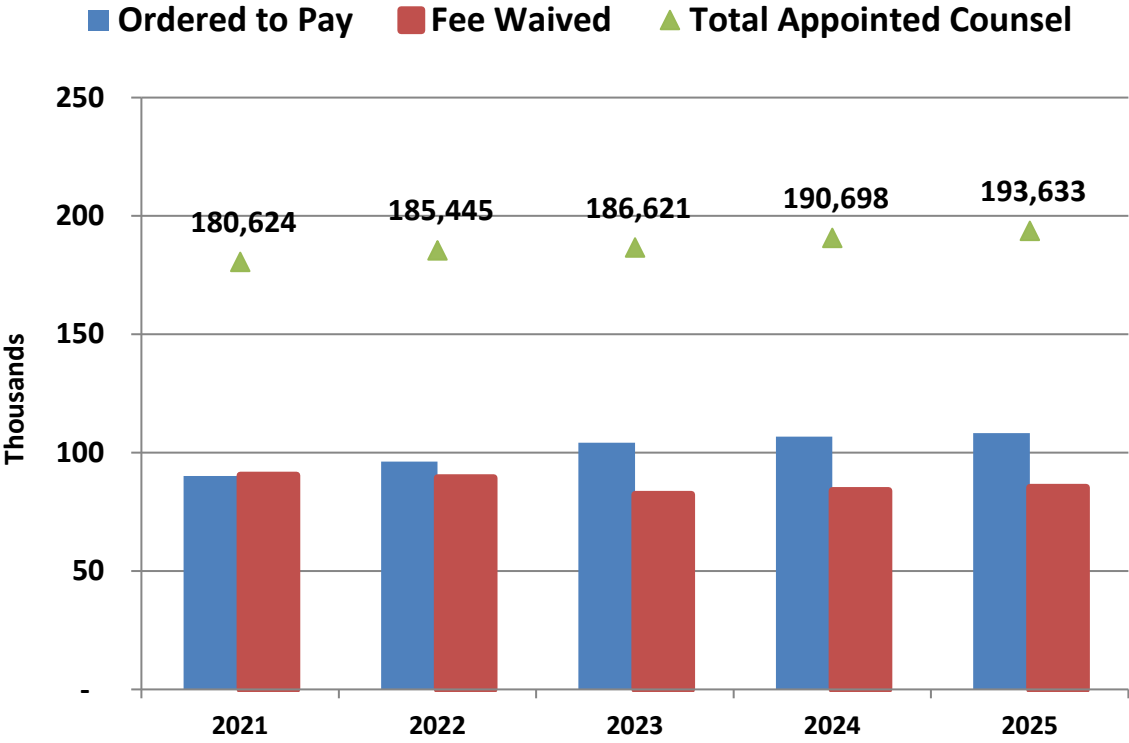

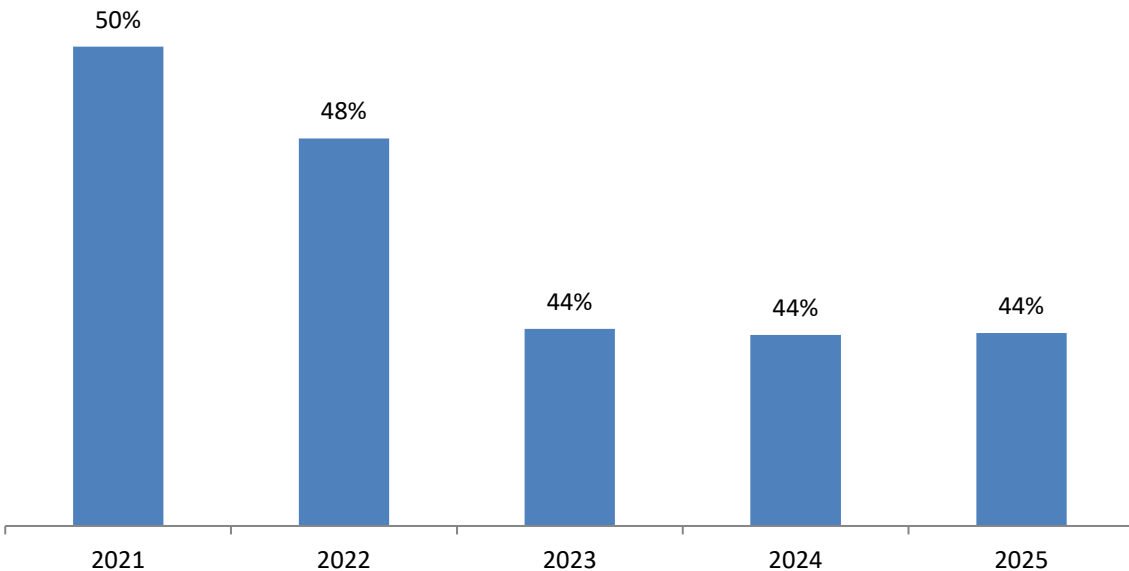

Total Number of Appointed Counsel Ordered to Pay Statewide

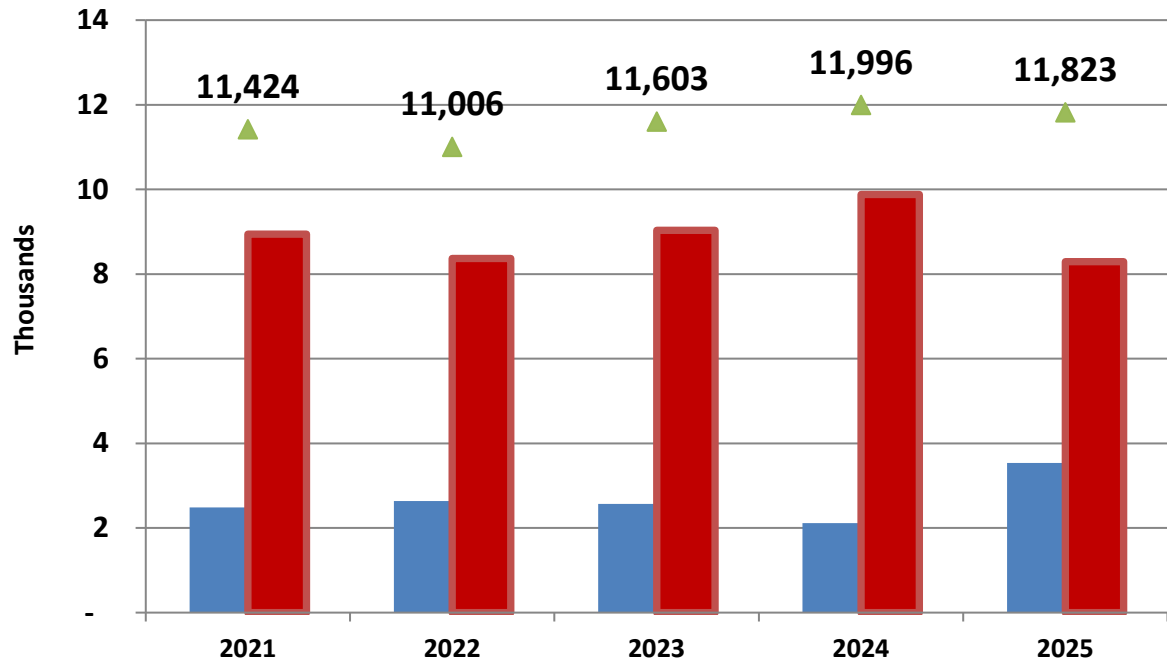


Percentage of Cases Where Admin Fee was Waived

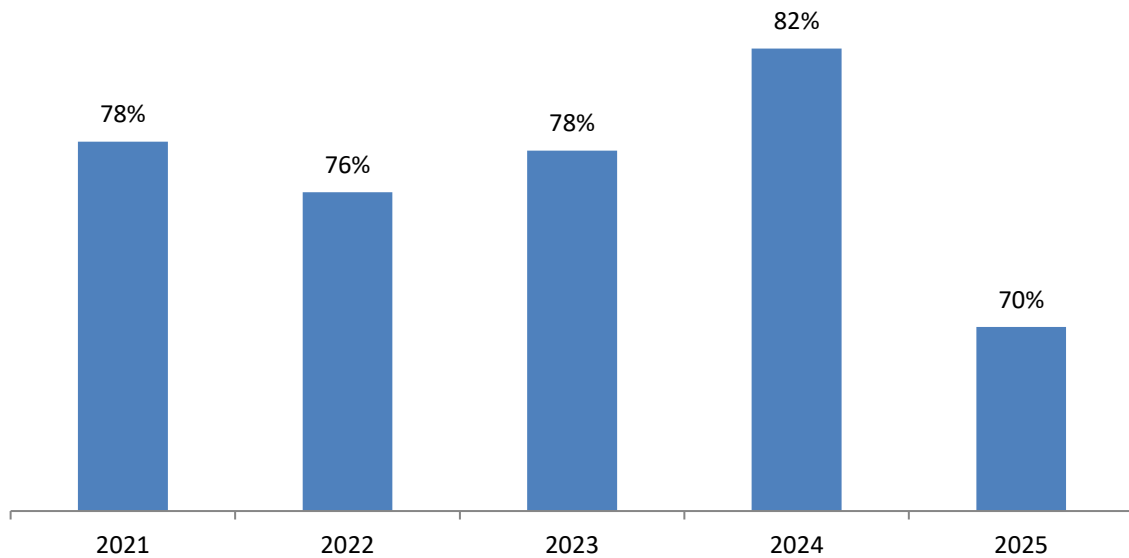


Number of Defendants Appointed a Guardian

■ Ordered to Pay ■ Fee Waived ▲ Total Appointed Guardian

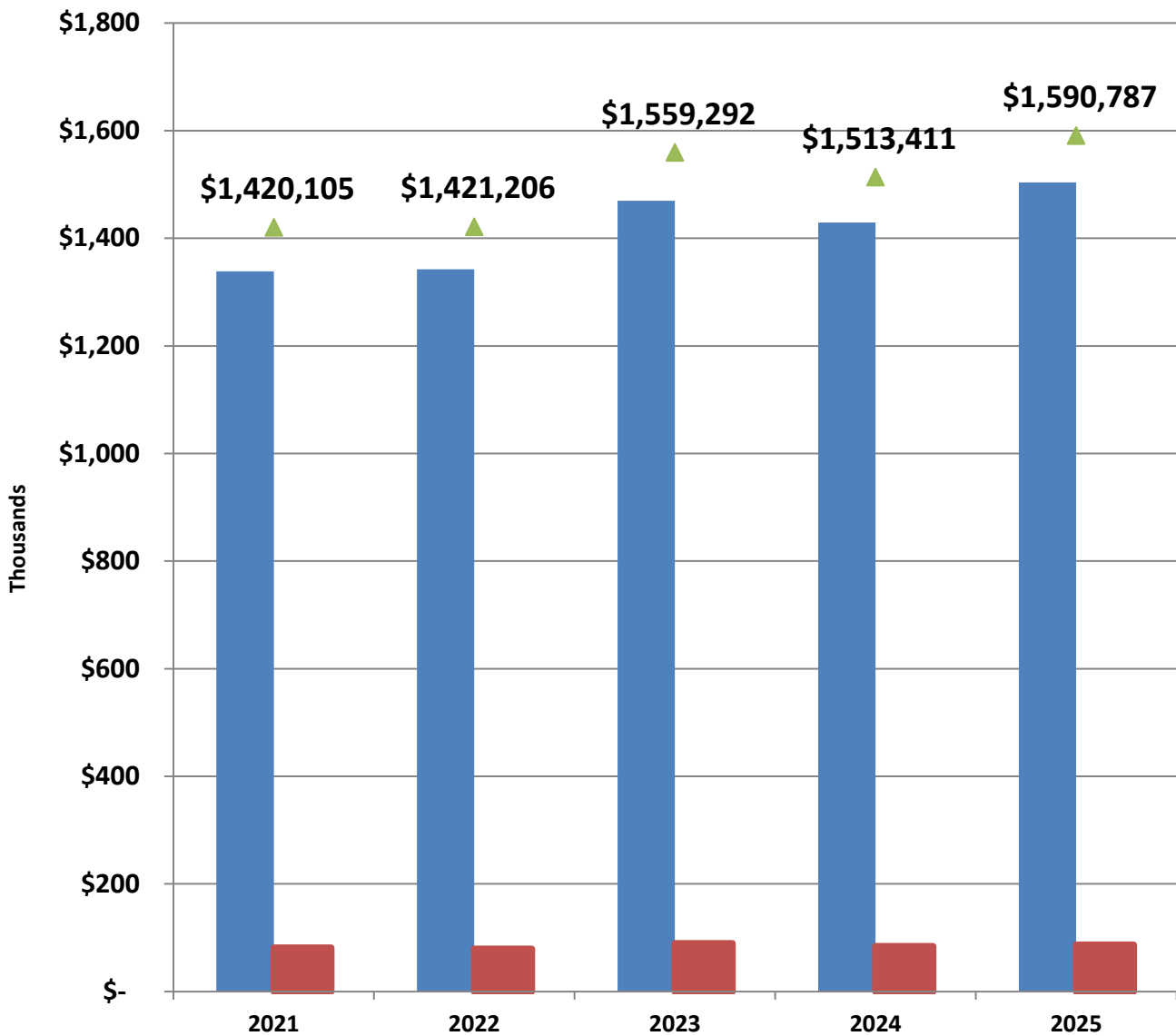


Percentage of Defendants whose Guardian Fee was Waived
